16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. AMENDATORY 43A O.S. 2021, Section 10-111.1,
18	is amended to read as follows:
19	Section 10-111.1 A. On or before January 1, 2019 <u>2024</u> , the
20	Office of the Attorney General shall promulgate <u>establish</u> and
21	maintain the Vulnerable Adult Abuse, Neglect and Exploitation Report
22	Registry, accessible to the public on the Internet in an electronic
23	format that is easily and readily searchable <u>updated quarterly</u> , to

1. A procedure for recording individuals on the registry who

have been found guilty by a court of law or entered a plea of guilty

or nolo contendere to a charge of abuse, neglect or exploitation of

a vulnerable adult; and

- 2. Disclosure requirements for information that is accessible on the registry.
- B. The Vulnerable Adult Abuse, Neglect and Exploitation Registry shall include but not be limited to:
 - 1. The full name of the individual;

- 2. Information necessary to identify the individual;
- 3. The disposition and other identifying case information regarding convictions or confessions of abuse, neglect or exploitation in a court of law; and
 - 4. The date the individual was convicted or pled guilty or nolo contendere.
 - B. The report created in subsection A of this section shall be maintained by the Office of the Attorney General and shall include a list of defendants who have been prosecuted by the Office of the Attorney General and have been found guilty by a court of law for abuse, exploitation or neglect of elderly or vulnerable adults in the preceding twelve (12) months. The report shall be provided to the Governor, the Speaker of the House of Representatives and the President Pro Tempore of the Senate on an annual basis beginning January 31, 2019. The report shall include, but not be limited to:
