11 COMMITTEE SUBSTITUTE

12 An Act relating to the Office of Management and
13 Enterprise Services; providing for reappropriation
14 and redesignation of certain funds in certain amount
15 for a certain purpose; authorizing certain
16 expenditures of certain funds; providing amounts;
17 providing purposes; and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. REAPPROPRIATION AND REDESIGNATION The amount
20 of Two Million Six Hundred Thousand Dollars (\$2,600,000.00) of the
21 original appropriation of Five Million Six Hundred Thousand Dollars
22 (\$5,600,000.00), appropriated to the Office of Management and
23 Enterprise Services by Section 132, Chapter 146, O.S.L. 2018, from
24 any monies not otherwise appropriated from the Special Cash Fund of

1 the State Treasury to reconcile costs associated with the funding of
2 state pension systems, is hereby reappropriated and redesignated to
3 the Office of Management and Enterprise Services to perform duties
4 imposed upon the Office by law. If, on the date this act is
5 approved, any of the amount originally appropriated, as adjusted by
6 expenditures, encumbrances and transfers, results in an unencumbered
7 balance less than the reappropriated and redesignated amount, that
8 reappropriated and redesignated amount is reduced to the
9 unencumbered amount.

10 SECTION 2. Notwithstanding any other provision of law, the
11 Office of Management and Enterprise Services is hereby authorized to
12 expend during the fiscal year ending June 30, 2019, from the Postal
13 Service Revolving Fund (Fund 231), the sum of One Hundred Fifty
14 Thousand Dollars (\$150,000.00) or so much thereof as may be
15 necessary to perform the duties imposed upon the Office of
16 Management and Enterprise Services by law.

17 SECTION 3. Notwithstanding any other provision of law, the
18 Office of Management and Enterprise Services is hereby authorized to
19 expend during the fiscal year ending June 30, 2019, from the
20 Registration of State Vendors Revolving Fund (Fund 270), the sum of
21 Fifty Thousand Dollars (\$50,000.00) or so much thereof as may be
22 necessary to perform the duties imposed upon the Office of
23 Management and Enterprise Services by law.

1 SECTION 4. Notwithstanding any other provision of law, the
2 Office of Management and Enterprise Services is hereby authorized to
3 expend during the fiscal year ending June 30, 2019, from the Vendor
4 Fees and Rebates Revolving Fund (Fund 271), the sum of One Million
5 Two Hundred Fifty Thousand Dollars (\$1,250,000.00) or so much
6 thereof as may be necessary to perform the duties imposed upon the
7 Office of Management and Enterprise Services by law.

8 SECTION 5. It being immediately necessary for the preservation
9 of the public peace, health or safety, an emergency is hereby
10 declared to exist, by reason whereof this act shall take effect and
11 be in full force from and after its passage and approval.
