AMENDATORY 74 O.S. 2021, Section 314, is 17 amended to read as follows: 18 Section 314. The State Fire Marshal and or the chief of the 19 fire department of every city, town or village district in which a 20 fire department is established, and or the mayor of every 21 incorporated village city or town in which no fire department 22 exists, and or the sheriff of the county shall investigate the 23 cause, origin and circumstances of every fire occurring in such 24 city, village, town district or county by which property has been

1	destroyed or damaged, and shall especially make investigation as to
2	whether <u>the cause of</u> such fire was <del>the result of carelessness or</del>
3	design accidental or intentional. Said investigation shall begin
4	within <del>two (2) days, not including Sundays,</del> <u>forty-eight (48) hours</u>
5	of the occurrence of such fire, and the said Fire Marshal shall have
6	the right to supervise and direct such investigation whenever he
7	deems it necessary or expedient. The officer making the
8	investigation of fires, shall forthwith notify said Fire Marshal and
9	shall within a week of the occurrence of the fire furnish to the
0	said Fire Marshal a written statement of all facts relating to the
.1	cause and origin of the fire, and such other information as may be
.2	called for by blanks provided by said Marshal. The State Fire
.3	Marshal shall keep in his office a record of all fires occurring in
4	the state, together with all facts, statistics and circumstances
.5	including the origin of the fires, which may be determined by the
6	investigation provided by this act; such records shall at all times
_7	be open to the public inspection, and such portions of it as the
8	insurance commissioner may deem necessary shall be transcribed and
9	forwarded to him within fifteen (15) days from the 1st day of
20	January of each year. The officer making the investigation of fires
21	shall within a week of the occurrence of the fire complete a written
22	statement of all acts relating to the cause and origin of the fire
23	and shall within forty-eight (48) hours of the occurrence of such

1	fire report to the State Fire Marshal all civilian and firefighter
2	injuries and fatalities resulting from the occurrence of such fire.
3	SECTION 2. This act shall become effective November 1, 2023.
