14 Services, the Oklahoma Department of Agriculture,
15 Food, and Forestry, the Oklahoma Department of
16 Commerce, the Rural Economic Action Plan Fund, the
17 Oklahoma Conservation Commission, the Corporation
18 Commission, the Department of Environmental Quality,
19 the Oklahoma Historical Society, the J.M. Davis
20 Memorial Commission, the Department of Labor, the
21 Department of Mines, the Oklahoma Tourism and
22 Recreation Department, the Oklahoma Water Resources
23 Board, the Alcoholic Beverage Laws Enforcement
24 Commission, the Department of Corrections, the
Oklahoma State Bureau of Investigation, the Council
on Law Enforcement Education and Training, the Board
of Medicolegal Investigations, the Oklahoma State
Bureau of Narcotics and Dangerous Drugs Control, the
Department of Public Safety, the Office of the
Attorney General, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System, the Pardon and Parole Board, the
Oklahoma Quick Action Closing Fund, The State
Emergency Fund, the Rate Preservation Fund, the
Maintenance of State Buildings Revolving Fund, the
Digital Transformation Program Revolving Fund, and
the Multiple Injury Trust Fund; stating amounts of
the appropriations; stating purposes and
restrictions; authorizing transfers and deposits; and
providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 EDUCATION

2 SECTION 1. There is hereby appropriated to the State Board of
3 Education from any monies not otherwise appropriated from the
4 General Revenue Fund of the State Treasury for the fiscal year
5 ending June 30, 2020, the sum of One Billion Four Hundred Seventy-
6 eight Million One Hundred Five Thousand Seven Hundred Dollars
7 (\$1,478,105,700.00) or so much thereof as may be necessary for the
8 financial support of public schools. Of those funds appropriated,
9 the State Board of Education shall designate Fifty-eight Million
10 Eight Hundred Fifty-eight Thousand Five Hundred Three Dollars
11 (\$58,858,503.00) for increased compensation for certified personnel
12 as defined by Section 26-103 of Title 70 of the Oklahoma Statutes.

13 SECTION 2. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Education Reform Revolving Fund created in Section 34.89 of Title 62
16 of the Oklahoma Statutes, the sum of Eight Hundred Fifty-four
17 Million Three Hundred Thousand Five Hundred Twenty-five Dollars
18 (\$854,300,525.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 3. The State Board of Education is hereby authorized to
21 expend during the fiscal year ending June 30, 2020, from the Common
22 Education Technology Revolving Fund of the State Treasury, the sum
23 of Forty-seven Million One Hundred Eleven Thousand Four Hundred
24

1 Twelve Dollars (\$47,111,412.00) or so much thereof as may be
2 necessary for the financial support of public schools.

3 SECTION 4. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2020, the sum of Three Million Eight Hundred
7 Thousand Dollars (\$3,800,000.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 5. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Mineral Leasing Fund of the State Treasury for the fiscal year
12 ending June 30, 2018, the sum of One Hundred Thirty-one Dollars
13 (\$131.00) or so much thereof as may be necessary for the financial
14 support of public schools.

15 SECTION 6. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2020, the sum of Twenty-one Million
19 Three Hundred Seventy-five Thousand Dollars (\$21,375,000.00) or so
20 much thereof as may be necessary for the financial support of public
21 schools.

22 SECTION 7. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2018, the sum of Seven Million Seventy-
2 eight Thousand Two Hundred Eighty-nine Dollars (\$7,078,289.00) or so
3 much thereof as may be necessary for the financial support of public
4 schools.

5 SECTION 8. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2020, the sum of One Hundred Million Nine Hundred
9 Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much
10 thereof as may be necessary for the support of public schools
11 activities.

12 SECTION 9. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 General Revenue Fund of the State Treasury for the fiscal year
15 ending June 30, 2020, the sum of Thirty-three Million Dollars
16 (\$33,000,000.00) or so much thereof as may be necessary for the
17 purchase of textbooks and instructional materials.

18 SECTION 10. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2020, the sum of Three Hundred Twenty-two Million
22 Four Hundred Fourteen Thousand One Hundred Ninety-nine Dollars
23 (\$322,414,199.00) or so much thereof as may be necessary for the
24 Certified Employee Health Benefit Allowance.

1 SECTION 11. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2020, the sum of One Hundred Eighty Million Two
5 Hundred Seventy-seven Thousand Seven Hundred Twenty-one Dollars
6 (\$180,277,721.00) or so much thereof as may be necessary for the
7 Support Personnel Health Benefit Allowance.

8 SECTION 12. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2020, the sum of Sixteen Million Two Hundred Forty-
12 six Thousand Ninety-seven Dollars (\$16,246,097.00) or so much
13 thereof as may be necessary for administrative and support functions
14 of the State Department of Education.

15 SECTION 13. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2020, the sum of Two Million Three
19 Hundred Seventy-five Thousand Dollars (\$2,375,000.00) or so much
20 thereof as may be necessary for transfer to the School Consolidation
21 Assistance Fund.

22 SECTION 14. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2018, the sum of Seven Hundred Eighty-
2 six Thousand Four Hundred Seventy-seven Dollars (\$786,477.00) or so
3 much thereof as may be necessary for transfer to the School
4 Consolidation Assistance Fund.

5 SECTION 15. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2020, the sum of Two Million Three
9 Hundred Seventy-five Thousand Dollars (\$2,375,000.00) or so much
10 thereof as may be necessary for transfer to the Teachers' Retirement
11 System Dedicated Revenue Revolving Fund.

12 SECTION 16. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2018, the sum of Seven Hundred Eighty-
16 six Thousand Four Hundred Seventy-seven Dollars (\$786,477.00) or so
17 much thereof as may be necessary for transfer to the Teachers'
18 Retirement System Dedicated Revenue Revolving Fund.

19 SECTION 17. There is hereby appropriated to the Oklahoma Arts
20 Council from any monies not otherwise appropriated from the General
21 Revenue Fund of the State Treasury for the fiscal year ending June
22 30, 2020, the sum of Two Million Nine Hundred Twelve Thousand Five
23 Hundred Thirty-one Dollars (\$2,912,531.00) or so much thereof as may
24

1 be necessary to perform the duties imposed upon the Oklahoma Arts
2 Council by law.

3 SECTION 18. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2020, the sum of One Hundred Thirty-
7 nine Million Four Hundred Seventy-nine Thousand One Hundred Eighty-
8 five Dollars (\$139,479,185.00) or so much thereof as may be
9 necessary to perform the duties imposed upon the State Board of
10 Career and Technology Education by law.

11 SECTION 19. There is hereby appropriated to the State Board of
12 Career and Technology Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2020, the sum of
15 Two Million Six Hundred Twelve Thousand Five Hundred Dollars
16 (\$2,612,500.00) pursuant to paragraph 2 of subsection F of Section
17 713 of Title 3A of the Oklahoma Statutes for allocation by the State
18 Board of Career and Technology Education for the education and
19 general operating budgets of the institutions and for other
20 programs, construction, renovations or repairs administered by the
21 State Board of Career and Technology Education.

22 SECTION 20. There is hereby appropriated to the State Board of
23 Career and Technology Education from any monies not otherwise
24 appropriated from the Oklahoma Education Lottery Trust Fund of the

1 State Treasury for the fiscal year ending June 30, 2018, the sum of
2 Eight Hundred Sixty-five Thousand One Hundred Twenty-four Dollars
3 (\$865,124.00) pursuant to paragraph 2 of subsection F of Section 713
4 of Title 3A of the Oklahoma Statutes for allocation by the State
5 Board of Career and Technology Education for the education and
6 general operating budgets of the institutions and for other
7 programs, construction, renovations or repairs administered by the
8 State Board of Career and Technology Education.

9 SECTION 21. There is hereby appropriated to the Office of
10 Educational Quality and Accountability from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2020, the sum of One Million One
13 Hundred Thirty-two Thousand Five Hundred Nine Dollars
14 (\$1,132,509.00) or so much thereof as may be necessary to perform
15 the duties imposed upon the Office of Educational Quality and
16 Accountability by law. Of those funds appropriated the sum of Sixty
17 Thousand Dollars (\$60,000.00) shall be deposited in the Teacher
18 Certification Scholarship Revolving Fund created pursuant to Section
19 6-187C of Title 70 of the Oklahoma Statutes. Of those funds
20 appropriated the sum of One Hundred Eighty Thousand Dollars
21 (\$180,000.00) shall be deposited in the Education Leadership
22 Oklahoma Revolving Fund created pursuant to Section 6-204.3 of Title
23 70 of the Oklahoma Statutes.

1 SECTION 22. There is hereby appropriated to the Office of
2 Educational Quality and Accountability from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury the
4 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
5 thereof as may be necessary to perform the duties imposed upon the
6 Office of Educational Quality and Accountability by law.

7 SECTION 23. There is hereby appropriated to the Oklahoma
8 Educational Television Authority from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2020, the sum of Two Million Eight
11 Hundred Forty-two Thousand Seven Hundred Thirteen Dollars
12 (\$2,842,713.00) or so much thereof as may be necessary to perform
13 the duties imposed upon the Oklahoma Educational Television
14 Authority by law.

15 SECTION 24. There is hereby appropriated to the Oklahoma State
16 Regents for Higher Education from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2020, the sum of Six Hundred Sixty-
19 six Million Nine Hundred Nine Thousand Three Hundred Sixty-seven
20 Dollars (\$666,909,367.00) or so much thereof as may be necessary for
21 allocation by the Oklahoma State Regents for Higher Education
22 pursuant to the provisions of Article XIII-A of the Oklahoma
23 Constitution for the education and general operating budgets of the
24 institutions and for other programs, construction, renovations or

1 repairs administered by the Oklahoma State Regents for Higher
2 Education. Of those funds appropriated, the sum of Three Million
3 One Hundred Twenty-three Thousand Four Hundred Ten Dollars
4 (\$3,123,410.00) shall be transferred to the Oklahoma Tuition
5 Equalization Grant Trust Fund to implement the provisions of the
6 Oklahoma Tuition Equalization Grant Act.

7 SECTION 25. The Oklahoma State Regents for Higher Education are
8 hereby authorized to expend during the fiscal year ending June 30,
9 2020, the sum of Forty-seven Million One Hundred Eleven Thousand
10 Four Hundred Twelve Dollars (\$47,111,412.00) from the Higher
11 Education Capital Revolving Fund of the State Treasury for
12 allocation by the Oklahoma State Regents for Higher Education
13 pursuant to the provisions of Article XIII-A of the Oklahoma
14 Constitution for the education and general operating budgets of the
15 institutions and for other programs, construction, renovations or
16 repairs administered by the Oklahoma State Regents for Higher
17 Education.

18 SECTION 26. The Oklahoma State Regents for Higher Education are
19 hereby authorized to expend during the fiscal year ending June 30,
20 2020, the sum of Forty-seven Million One Hundred Eleven Thousand
21 Four Hundred Twelve Dollars (\$47,111,412.00) from the Oklahoma
22 Student Aid Revolving Fund of the State Treasury for allocation by
23 the Oklahoma State Regents for Higher Education pursuant to the
24 provisions of Article XIII-A of the Oklahoma Constitution for the

1 education and general operating budgets of the institutions and for
2 other programs, construction, renovations or repairs administered by
3 the Oklahoma State Regents for Higher Education.

4 SECTION 27. There is hereby appropriated to the Oklahoma State
5 Regents for Higher Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2020, the sum of Eleven Million
8 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars
9 (\$11,764,823.00) or so much thereof as may be necessary for
10 expenditures for concurrent enrollment pursuant to Section 628.13 of
11 Title 70 of the Oklahoma Statutes.

12 SECTION 28. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the Oklahoma Education Lottery Trust Fund of the
15 State Treasury for the fiscal year ending June 30, 2020, the sum of
16 Eighteen Million Seven Hundred Sixty-two Thousand Five Hundred
17 Dollars (\$18,762,500.00) pursuant to paragraph 2 of subsection F of
18 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
19 the Oklahoma State Regents for Higher Education pursuant to the
20 provisions of Article XIII-A of the Oklahoma Constitution for
21 construction, renovations or repairs administered by the Oklahoma
22 State Regents for Higher Education or for any other purpose
23 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
24 of the Oklahoma Statutes.

1 SECTION 29. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2018, the sum of
5 Six Million Two Hundred Thirteen Thousand One Hundred Sixty-five
6 Dollars (\$6,213,165.00) pursuant to paragraph 2 of subsection F of
7 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
8 the Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-A of the Oklahoma Constitution for
10 construction, renovations or repairs administered by the Oklahoma
11 State Regents for Higher Education or for any other purpose
12 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
13 of the Oklahoma Statutes.

14 SECTION 30. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2020, the sum of Four Million One
18 Hundred Ninety-seven Thousand Three Hundred Seventy-nine Dollars
19 (\$4,197,379.00) or so much thereof as may be necessary for the
20 general operating budget of the Administrative Offices of the
21 Oklahoma State Regents for Higher Education.

22 SECTION 31. There is hereby appropriated to the Commissioners
23 of the Land Office from any monies not otherwise appropriated from
24 the Commissioners of the Land Office Fund of the State Treasury for

1 the fiscal year ending June 30, 2020, the sum of Eight Million Seven
2 Hundred Twenty-eight Thousand Four Hundred Thirteen Dollars
3 (\$8,728,413.00) or so much thereof as may be necessary to perform
4 the duties imposed upon the Commissioners of the Land Office by law.

5 SECTION 32. There is hereby appropriated to the Oklahoma
6 Department of Libraries from any monies not otherwise appropriated
7 from the General Revenue Fund of the State Treasury for the fiscal
8 year ending June 30, 2020, the sum of Four Million Five Hundred
9 Twenty-seven Thousand Four Hundred Eleven Dollars (\$4,527,411.00) or
10 so much thereof as may be necessary to perform the duties imposed
11 upon the Oklahoma Department of Libraries by law.

12 SECTION 33. There is hereby appropriated to the Physician
13 Manpower Training Commission from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2020, the sum of Six Million Eight
16 Hundred Thirty-six Thousand Three Hundred Thirty Dollars
17 (\$6,836,330.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Physician Manpower Training Commission
19 by law.

20 SECTION 34. There is hereby appropriated to the Physician
21 Manpower Training Commission from any monies not otherwise
22 appropriated from the Special Cash Fund of the State Treasury the
23 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
24

1 thereof as may be necessary to perform the duties imposed upon the
2 Physician Manpower Training Commission by law.

3 SECTION 35. There is hereby appropriated to the Board of
4 Trustees of the Oklahoma School of Science and Mathematics from any
5 monies not otherwise appropriated from the General Revenue Fund of
6 the State Treasury for the fiscal year ending June 30, 2020, the sum
7 of Six Million Two Hundred Eighty-four Thousand Seven Hundred Sixty-
8 four Dollars (\$6,284,764.00) or so much thereof as may be necessary
9 to perform the duties imposed upon the Board of Trustees of the
10 Oklahoma School of Science and Mathematics by law.

11 SECTION 36. There is hereby appropriated to the Oklahoma Center
12 for the Advancement of Science and Technology from any monies not
13 otherwise appropriated from the General Revenue Fund of the State
14 Treasury for the fiscal year ending June 30, 2020, the sum of
15 Fourteen Million Three Hundred Seventy-one Thousand Three Hundred
16 Ninety-eight Dollars (\$14,371,398.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Oklahoma Center for
18 the Advancement of Science and Technology by law. Of those funds
19 appropriated, the sum of Five Million Three Hundred Thirty-three
20 Thousand Five Hundred Forty-two Dollars (\$5,333,542.00) shall be
21 deposited in the Research Support Revolving Fund, created pursuant
22 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
23 funds appropriated, the sum of Two Million Nine Hundred Thirty-three
24 Thousand Four Hundred Forty-eight Dollars (\$2,933,448.00) shall be

1 deposited in the Seed-Capital Revolving Fund, created pursuant to
2 Section 5060.21 of Title 74 of the Oklahoma Statutes.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 37. There is hereby appropriated to the Office of the
5 State Auditor and Inspector from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2020, the sum of Four Million Two
8 Hundred Fifty-six Thousand Two Hundred Sixty-seven Dollars
9 (\$4,256,267.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Office of the State Auditor and
11 Inspector by law.

12 SECTION 38. There is hereby appropriated to the Office of the
13 State Auditor and Inspector from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2020, the sum of Two Hundred Twenty-
16 three Thousand Two Hundred Twenty-eight Dollars (\$223,228.00) or so
17 much thereof as may be necessary to perform the duties imposed upon
18 the Commission on County Government Personnel Education and
19 Training. The appropriation made in this section shall be expended
20 exclusively for the purpose so stated and shall not be transferable.

21 SECTION 39. There is hereby appropriated to the State Election
22 Board from any monies not otherwise appropriated from the General
23 Revenue Fund of the State Treasury for the fiscal year ending June
24 30, 2020, the sum of Eight Million Six Hundred One Thousand Thirty-

1 five Dollars (\$8,601,035.00) or so much thereof as may be necessary
2 to perform the duties imposed upon the State Election Board by law.

3 SECTION 40. There is hereby appropriated to the Oklahoma
4 Department of Emergency Management from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2020, the sum of Five Hundred Five
7 Thousand Eight Hundred Fifty-nine Dollars (\$505,859.00) or so much
8 thereof as may be necessary to perform the duties imposed upon the

10 Economic Action Plan program except that the cumulative amounts
11 transferred shall not exceed the cumulative amounts of equal monthly
12 allotments of the appropriations made to Oklahoma Water Resources
13 Board.

14 PUBLIC SAFETY

15 SECTION 92. There is hereby appropriated to the Alcoholic
16 Beverage Laws Enforcement Commission from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2020, the sum of Three Million
19 Nineteen Thousand Three Hundred Sixty-four Dollars (\$3,019,364.00)
20 or so much thereof as may be necessary to perform the duties imposed
21 upon the Alcoholic Beverage Laws Enforcement Commission by law.

22 SECTION 93. There is hereby appropriated to the Department of
23 Corrections from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2020, the sum of Five Hundred Fifty-three Million
2 Four Hundred Eighteen Thousand Three Hundred Sixty Dollars
3 (\$553,418,360.00) or so much thereof as may be necessary to perform
4 the duties imposed upon the Department of Corrections by law.

5 SECTION 94. There is hereby appropriated to the Department of
6 Corrections from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2019, the sum of Two Million One Hundred Forty-one
9 Thousand Four Hundred Sixty-four Dollars (\$2,141,464.00) or so much
10 thereof as may be necessary to perform the duties imposed upon the
11 Department of Corrections by law.

12 SECTION 95. There is hereby appropriated to the Oklahoma State
13 Bureau of Investigation from any monies not otherwise appropriated
14 from the General Revenue Fund of the State Treasury for the fiscal
15 year ending June 30, 2020, the sum of Seventeen Million One Hundred
16 Eighty Thousand One Hundred Twenty-two Dollars (\$17,180,122.00) or
17 so much thereof as may be necessary to perform the duties imposed
18 upon the Oklahoma State Bureau of Investigation by law. Of the
19 funds appropriated herein, a maximum of One Hundred Thousand Dollars
20 (\$100,000.00) may be transferred to an agency special account for
21 the purpose of purchasing evidence items, paying fees to informers
22 or special employees, paying expenses incurred in the prosecution
23 and defense of civil actions, and paying other expenses as incurred

6 Enforcement Education and Training from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2020, the sum of Five Hundred
9 Ninety-seven Thousand Two Hundred Seventy Dollars (\$597,270.00) or
10 so much thereof as may be necessary to perform the duties imposed
11 upon the Council on Law Enforcement Education and Training by law.

12 SECTION 97. There is hereby appropriated to the Council on Law
13 Enforcement Education and Training from any monies not otherwise
14 appropriated from the C.L.E.E.T. Fund for the fiscal year ending
15 June 30, 2020, the sum of Two Million Nine Hundred Fourteen Thousand
16 Fourteen Dollars (\$2,914,014.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Council on Law
18 Enforcement Education and Training by law.

19 SECTION 98. There is hereby appropriated to the Board of
20 Medicolegal Investigations from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2020, the sum of Seventeen Million
23 Nine Hundred Ninety-one Thousand Three Hundred Fifty-seven Dollars
24 (\$17,991,357.00) or so much thereof as may be necessary to perform

1 the duties imposed upon the Board of Medicolegal Investigations by
2 law.

3 SECTION 99. There is hereby appropriated to the Oklahoma State
4 Bureau of Narcotics and Dangerous Drugs Control from any monies not
5 otherwise appropriated from the General Revenue Fund of the State
6 Treasury for the fiscal year ending June 30, 2020, the sum of Three
7 Million Two Hundred Seventy-six Thousand Three Hundred Eighty-five
8 Dollars (\$3,276,385.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the Oklahoma State Bureau of
10 Narcotics and Dangerous Drugs Control by law.

11 SECTION 100. There is hereby appropriated to the Department of
12 Public Safety from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2020, the sum of Seventy-seven Million One Hundred
15 Seventeen Thousand Seven Hundred Ninety Dollars (\$77,117,790.00) or
16 so much thereof as may be necessary to perform the duties imposed
17 upon the Department of Public Safety by law.

18 SECTION 101. There is hereby appropriated to the Department of
19 Public Safety from any monies not otherwise appropriated from the
20 State Public Safety Fund of the State Treasury for the fiscal year
21 ending June 30, 2020, the sum of Twenty-two Million Two Hundred
22 Sixty Thousand Six Hundred Ninety-six Dollars (\$22,260,696.00) or so
23 much thereof as may be necessary to perform the duties imposed upon
24 the Department of Public Safety by law.

1 SECTION 102. There is hereby appropriated to the Department of
2 Public Safety from any monies not otherwise appropriated from the
3 State Public Safety Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Four Million Nine Hundred Ninety-
5 eight Thousand Four Hundred Eighty-one Dollars (\$4,998,481.00) or so
6 much thereof as may be necessary to perform the duties imposed upon
7 the Department of Public Safety by law.

9 SECTION 103. There is hereby appropriated to the Office of the
10 Attorney General from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2020, the sum of Eight Million Nine Hundred Thirteen
13 Thousand Six Hundred Fifty-four Dollars (\$8,913,654.00) or so much
14 thereof as may be necessary to perform the duties imposed upon the
15 Office of the Attorney General by law.

16 SECTION 104. There is hereby appropriated to the Office of the
17 Attorney General from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2020, the sum of Nine Hundred Ninety-nine Thousand
20 Three Hundred Fifty-two Dollars (\$999,352.00) to transfer to the
21 Legal Services Revolving Fund, created pursuant to subsection G of
22 Section 921.1 of Title 12 of the Oklahoma Statutes.

23 SECTION 105. For the fiscal year ending June 30, 2020, the
24 Office of the Attorney General is authorized to transfer an amount

1 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty
2 Dollars (\$320,430.00) from the Office of the Attorney General's
3 Evidence Fund (700 Fund), created by Section 19 of Title 74 of the
4 Oklahoma Statutes, to the Office of the Attorney General's Revolving
5 Fund (200 Fund), created by Section 20 of Title 74 of the Oklahoma

7 SECTION 106. There is hereby appropriated to the Court of
8 Criminal Appeals from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2020, the sum of Three Million Nine Hundred Seventy-
11 seven Thousand Sixty-seven Dollars (\$3,977,067.00) or so much
12 thereof as may be necessary to perform the duties imposed upon the
13 Court of Criminal Appeals by law.

14 SECTION 107. There is hereby appropriated to the District
15 Attorneys Council from any monies not otherwise appropriated from
16 the General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2020, the sum of Fifty-eight Million Seven Hundred
18 Seventy-nine Thousand Seven Hundred Eighty-two Dollars
19 (\$58,779,782.00) or so much thereof as may be necessary to perform

6 the fiscal year ending June 30, 2020, the sum of Two Million Dollars
7 (\$2,000,000.00) or so much thereof as may be necessary to complete
8 repairs and maintenance of the Governor's Mansion.

9 SECTION 131. There is hereby appropriated to the Maintenance of
10 State Buildings Revolving Fund (Fund 283) from any monies not
11 otherwise appropriated from the General Revenue Fund of the State
12 Treasury for the fiscal year ending June 30, 2020, the sum of Six
13 Million One Hundred Thousand Dollars (\$6,100,000.00) or so much
14 thereof as may be necessary to implement the provisions set forth in
15 Section 908 of Title 62 of the Oklahoma Statutes.

16 SECTION 132. There is hereby appropriated to the Multiple
17 Injury Trust Fund from any monies not otherwise appropriated from
18 the General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2020, the sum of Five Million Dollars
20 (\$5,000,000.00) or so much thereof as may be necessary to pay
21 obligations of the Fund.

22 SECTION 133. Sections 122 through 124 of this act shall become
23 effective June 15, 2019.

24

1 SECTION 134. Sections 1 through 115 and 125 through 132 of this
2 act shall become effective July 1, 2019.
