5 (k) "Bonds" means any bonds, notes, interim certificates,
6 debentures, or other obligations issued by an authority pursuant to
7 this act.

8 (1) "Real property" includes all lands, including improvements 9 and fixtures thereon, and property of any nature appurtenant 10 thereto, or used in connection therewith, and every estate, interest 11 and right, legal or equitable, therein including terms for years.

(m) "Obligee of an authority" or "obligee" includes any bondholder, agent or trustee for any bondholder, or lessor demising to the authority property used in connection with a project, or any assignee or assignees of such lessor's interest or any part thereof, and the federal government when it is a party to any contract with the authority.

(n) "Persons engaged in national defense activities" means
persons in the Armed Forces of the United States; employees of the
Department of Defense; and workers engaged or to be engaged in
activities connected with national defense. The term also includes
the families of the persons, employees, and workers who reside with
