## An Act

ENROLLED HOUSE BILL NO. 2869

An Act relating to courts; amending 20 O.S. 2011, Sections 3.1, 30.2A and 31.2, as amended by Sections 1, 2 and 3, Chapter 399, O.S.L. 2015 (20 O.S. Supp. 2020, Sections 3.1, 30.2A and 31.2) and 20 O.S. 2011, Section 92.1A, which relate to judicial salaries; clarifying applicability; providing exceptions based on certain future actions; modifying salary references; and declaring an emergency.

SUBJECT: Courts

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 20 O.S. 2011, Section 3.1, as amended by Section 1, Chapter 399, O.S.L. 2015 (20 O.S. Supp. 2020, Section 3.1), is amended to read as follows:

Section 3.1 A. Except For fiscal year 2021 and each fiscal year thereafter, except as otherwise provided by the Board on Judicial Compensation after the effective date of this act, the following judicial officers shall receive compensation for their services, payable monthly as follows:

1. The Chief Justice of the Supreme Court shall receive an annual salary of <del>One Hundred Fifty-five Thousand Eight Hundred</del> <del>Twenty Dollars (\$155,820.00)</del> <u>One Hundred Seventy-two Thousand Forty-</u> nine Dollars (\$172,049.00); and

2. An Associate Justice of the Supreme Court shall receive an annual salary of <del>One Hundred Forty-five Thousand Nine Hundred</del>

Fourteen Dollars (\$145,914.00) One Hundred Sixty-one Thousand One Hundred Twelve Dollars (\$161,112.00).

B. Any increase in salary provided for in subsection A of this section must be paid from existing available funds.

SECTION 2. AMENDATORY 20 O.S. 2011, Section 30.2A, as amended by Section 2, Chapter 399, O.S.L. 2015 (20 O.S. Supp. 2020, Section 30.2A), is amended to read as follows:

Section 30.2A A. Except For fiscal year 2021 and each fiscal year thereafter, except as otherwise provided by the Board on Judicial Compensation after the effective date of this act, the following judicial officers shall receive compensation for their services, payable monthly as follows:

1. The Presiding Judge of the Court of Civil Appeals shall receive an annual salary of <del>One Hundred Forty Thousand Seven Hundred</del> <del>Ninety-five Dollars (\$140,795.00)</del> <u>One Hundred Fifty-five Thousand</u> Four Hundred Fifty-nine Dollars (\$155,459.00); and

2. A Judge of the Court of Civil Appeals shall receive an annual salary of <del>One Hundred Thirty-eight Thousand Two Hundred Thirty-five Dollars (\$138,235.00)</del> <u>One Hundred Fifty-two Thousand Six</u> Hundred Thirty-two Dollars (\$152,632.00).

B. Any increase in salary provided for in subsection A of this section must be paid from existing available funds.

SECTION 3. AMENDATORY 20 O.S. 2011, Section 31.2, as amended by Section 3, Chapter 399, O.S.L. 2015 (20 O.S. Supp. 2020, Section 31.2), is amended to read as follows:

Section 31.2 A. Except For fiscal year 2021 and each fiscal year thereafter, except as otherwise provided by the Board on Judicial Compensation after the effective date of this act, the following judicial officers shall receive compensation for their services, payable monthly as follows:

1. The Presiding Judge of the Court of Criminal Appeals shall receive an annual salary of <del>One Hundred Fifty-one Thousand Thirtyfour Dollars (\$151,034.00)</del> <u>One Hundred Sixty-six Thousand Seven</u> Hundred Sixty-five Dollars (\$166,765.00); and 2. A Judge of the Court of Criminal Appeals shall receive an annual salary of <del>One Hundred Forty-five Thousand Nine Hundred Fourteen Dollars (\$145,914.00)</del> <u>One Hundred Sixty-one Thousand One</u> Hundred Twelve Dollars (\$161,112.00).

B. Any increase in salary provided for in subsection A of this section must be paid from existing available funds.

SECTION 4. AMENDATORY 20 O.S. 2011, Section 92.1A, is amended to read as follows:

Section 92.1A Except For fiscal year 2021 and each fiscal year thereafter, except as otherwise provided by the Board on Judicial Compensation after the effective date of this act, the following judicial officers shall receive compensation for their services, payable monthly as follows:

1. A judge of the district court shall receive an annual salary of <del>One Hundred Two Thousand Five Hundred Twenty-nine Dollars</del> (\$102,529.00) <u>One Hundred Forty-five Thousand Five Hundred Sixty-</u> seven Dollars (\$145,567.00);

2. An associate district judge shall receive an annual salary of Ninety-four Thousand Eight Hundred Thirty-nine Dollars (\$94,839.00) One Hundred Thirty-four Thousand Two Hundred Sixty-one Dollars (\$134,261.00); and

3. A special judge shall receive an annual salary of <del>Eighty-</del> seven Thousand One Hundred Fifty Dollars (\$87,150.00) <u>One Hundred</u> Twenty-two Thousand Nine Hundred Fifty-four Dollars (\$122,954.00).

SECTION 5. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
