11                                   COMMITTEE SUBSTITUTE

12                   An Act relating to the Office of Management and  
13                   Enterprise Services; making appropriations;  
14                   identifying source; establishing amount; providing  
                  purpose; providing for noncodification; and declaring  
                  an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19                   SECTION 1.           NEW LAW           A new section of law not to be  
20                   codified in the Oklahoma Statutes reads as follows:

21                   There is hereby appropriated to the Office of Management and  
22                   Enterprise Services from monies not otherwise appropriated from the  
23                   Statewide Recovery Fund of the State Treasury created in Enrolled  
24                   House Bill No. 3349 of the 2nd Session of the 58th Oklahoma

1 Legislature, the sum of Four Million Seven Hundred Thousand Dollars  
2 (\$4,700,000.00) or so much thereof as may be necessary to pay for  
3 expenses arising from implementing programs and expenditures in  
4 accordance with actions taken by the Joint Committee on Pandemic  
5 Relief Funding. Such funds shall be utilized in a manner consistent  
6 with the recommendations adopted by the Joint Committee on Pandemic  
7 Relief Funding on May 11, 2023.

8 SECTION 2. NEW LAW A new section of law not to be  
9 codified in the Oklahoma Statutes reads as follows:

10 There is hereby appropriated to the ARPA Administrative Costs  
11 Fund created in Enrolled House Bill No. 2940 of the 1st Session of  
12 the 59th Oklahoma Legislature from monies not otherwise appropriated  
13 from the Statewide Recovery Fund of the State Treasury created in  
14 Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma  
15 Legislature, the sum of Five Million Eight Hundred Four Thousand  
16 Dollars (\$5,804,000.00) or so much thereof as may be necessary to  
17 pay for future administrative expenses approved by the Joint  
18 Committee on Pandemic Relief Funding in association with  
19 implementing, administering, or overseeing programs funded by the  
20 Statewide Recovery Fund created in Enrolled House Bill No. 3349 of  
21 the 2nd Session of the 58th Oklahoma Legislature.

22 SECTION 3. It being immediately necessary for the preservation  
23 of the public peace, health or safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
