AMENDATORY 12 amended to read as follows: 13 Section 481. A State Board of Medical Licensure and Supervision 14 hereinafter referred to as the "Board", is hereby re-created, to 15 continue until July 1, <del>2024</del> 2025, in accordance with the provisions 16 of the Oklahoma Sunset Law. The Board shall be composed of seven 17 (7) allopathic physicians licensed to practice medicine in this 18 state and represent the public and four (4) lay members. 19 physician members of the Board shall be graduates of legally 20 chartered medical schools recognized by the Oklahoma State Regents 21 for Higher Education or the Liaison Council on Medical Education. 22 The physician members shall have actively practiced as licensed 23 physicians continuously in this state for the three (3) years

immediately preceding their appointment to the Board. All members
