8 2011, Section 604.1, as last amended by Section 1,
9 Chapter 461, O.S.L. 2019 (3A O.S. Supp. 2020, Section
10 604.1), which relates to the Oklahoma State Athletic
11 Commission; amending 10 O.S. 2011, Section 640.1, as
12 last amended by Section 1, Chapter 296, O.S.L. 2017
13 (10 O.S. Supp. 2020, Section 640.1), which relates to
14 the Oklahoma Partnership for School Readiness Board;
15 amending 52 O.S. 2011, Section 288.3, as last amended
16 by Section 1, Chapter 295, O.S.L. 2017 (52 O.S. Supp.
17 2020, Section 288.3), which relates to the Oklahoma
18 Energy Resources Board; amending 59 O.S. 2011,
19 Section 137, as last amended by Section 1, Chapter

1607), which relates to the Board of Examiners for
Speech-Language Pathology and Audiology; amending 59
O.S. 2011, Section 2053, as last amended by Section
1, Chapter 466, O.S.L. 2019 (59 O.S. Supp. 2020,
Section 2053), which relates to the State Board of
Examiners of Perfusionists; amending 59 O.S. 2011,
Section 2305, as last amended by Section 1, Chapter
464, O.S.L. 2019 (59 O.S. Supp. 2020, Section 2305),
which relates to the Advisory Committee on
Pedorthics; amending 59 O.S. 2011, Section 3005, as

1 last amended by Section 1, Chapter 465, O.S.L. 2019
2 (59 O.S. Supp. 2020, Section 3005), which relates to
3 the Advisory Committee on Orthotics and Prosthetics;
4 amending 74 O.S. 2011, Section 4102, as last amended
5 by Section 1, Chapter 193, O.S.L. 2019 (74 O.S. Supp.
6 2020, Section 4102), which relates to the State
7 Capitol Preservation Commission; extending sunset
8 date; providing an effective date; and declaring an
9 emergency.

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 3A O.S. 2011, Section 604.1, as
12 last amended by Section 1, Chapter 461, O.S.L. 2019 (3A O.S. Supp.
13 2020, Section 604.1), is amended to read as follows:

14 Section 604.1 A. There is hereby re-created, until July 1,
15 ~~2021~~ 2024, in accordance with the Oklahoma Sunset Law, the Oklahoma
16 State Athletic Commission, which shall be composed of nine (9)
17 members appointed by the Governor with the advice and consent of the
18 Senate. The member of the Commission initially appointed pursuant
19 to this act shall serve a term of three (3) years that shall expire
20 on June 30, 2006. Members appointed to the Commission shall serve
21 for terms of three (3) years. Terms of office shall expire on June
22 30. All vacancies and unexpired terms shall be filled in the same
23 manner as the original appointment and within sixty (60) days from
24 the date of the vacancy. Members may be removed by the Governor for
incompetence, willful neglect of duty, corruption in office, or
malfeasance in office.

1 B. Members appointed to the Commission shall reside in this
2 state and shall have the following qualifications:

3 1. Two members shall have experience as a professional
4 combative sports practitioner, other than as a professional wrestler
5 or in professional combative sports promotions;

6 2. One member shall have experience as a professional wrestler
7 or in professional wrestling promotions;

8 3. One member shall have experience in sports medicine;

9 4. One member shall have experience in the cable television
10 business; and

11 5. Four members shall represent the public at large as lay
12 members.

13 C. No member of the Commission or any person related to a
14 member within the third degree by consanguinity or affinity shall
15 promote, sponsor, or have any financial interest in the promotion or
16 sponsorship of any professional combative sports event or amateur
17 mixed martial arts event while a member of the Commission.

18 D. The members of the Commission shall elect from their
19 membership a chair and vice-chair to serve for one-year terms. A
20 majority of the members shall constitute a quorum for the purpose of
21 conducting the business of the Commission. The Commission shall
22 meet at least quarterly, and special meetings may be called by the
23 chair.

1 E. The Commission shall comply with the provisions of the
2 Oklahoma Open Meeting Act, the Oklahoma Open Records Act, and the
3 Administrative Procedures Act.

4 F. All members of the Commission and such employees as
5 determined by the Commission shall be bonded as required by Sections
6 ~~85.26~~ 85.58Q through ~~85.31~~ 85.58V of Title 74 of the Oklahoma
7 Statutes.

8 G. Members of the Commission shall serve without compensation
9 but shall be reimbursed for expenses incurred in the performance of
10 their duties as provided in the State Travel Reimbursement Act.

11 SECTION 2. AMENDATORY 10 O.S. 2011, Section 640.1, as
12 last amended by Section 1, Chapter 296, O.S.L. 2017 (10 O.S. Supp.
13 2020, Section 640.1), is amended to read as follows:

14 Section 640.1 A. There is hereby re-created until July 1, ~~2021~~
15 2024, in accordance with the Oklahoma Sunset Law, the Oklahoma
16 Partnership for School Readiness Board. The Board shall promote
17 school readiness supporting community-based efforts to increase the
18 number of children who are ready to succeed by the time they enter
19 school. The Board shall additionally serve as the state's Early
20 Childhood Advisory Council and fulfill the responsibilities
21 described in the Head Start Act of 2007 (PL 110-134, Section 642B).
22 The Board shall consist of representatives from the private and
23 public sectors as follows:
24

1 1. Fifteen private sector representatives appointed by the
2 Governor from a list submitted by an existing private-sector school
3 readiness initiative that includes in its focus community
4 mobilization and public engagement activities to include:

5 a. two parents of children eight (8) years of age or
6 younger, and

7 b. one representative of licensed child care providers;

8 2. One representative of the licensed child care industry
9 appointed by the Governor from a list submitted by an association
10 representing the licensed child care industry in this state;

11 3. One representative of a state association of federally
12 funded early childhood programs appointed by the Governor; and

13 4. To ensure that existing resources are being utilized
14 effectively, fifteen public sector representatives or their
15 designees as follows:

16 a. State Superintendent of Public Instruction,

17 b. State Commissioner of Health,

18 c. Commissioner of the Department of Mental Health and
19 Substance Abuse Services,

20 d. Director of the Oklahoma Department of Commerce,

21 e. Director of the Oklahoma Department of Libraries,

22 f. Director of the Department of Human Services,

23 g. Administrator of the Oklahoma Health Care Authority,

- 1 h. Director of the Oklahoma Commission on Children and
- 2 Youth,
- 3 i. Director of the State Department of Rehabilitation
- 4 Services,
- 5 j. Executive Director of the Oklahoma Educational
- 6 Television Authority,
- 7 k. Director of the Oklahoma Department of Career and
- 8 Technology Education,
- 9 l. Chancellor of the Oklahoma State Regents for Higher
- 10 Education,
- 11 m. Cabinet Secretary with responsibility for education
- 12 agencies,
- 13 n. Dean of the College of Human Environmental Sciences,
- 14 Oklahoma State University, and
- 15 o. State Director of Head Start Collaboration.

16 B. Members appointed by the Governor shall serve terms of four
17 (4) years; provided, of those members initially appointed to the
18 Board, eight members shall be appointed for two-year terms,
19 beginning September 1, 2003, and seven members shall be appointed
20 for four-year terms, beginning September 1, 2003, as designated by
21 the Governor. The member appointed pursuant to paragraph 2 of
22 subsection A of this section shall be appointed for an initial term
23 to end on August 31, 2007. The member appointed pursuant to
24 paragraph 3 of subsection A of this section shall be appointed for

1 an initial term to end on August 31, 2009. Appointed members shall
2 continue in office until a successor is appointed by the Governor.
3 The Governor shall fill all vacancies in the same manner as the
4 original appointment was made.

5 C. The Director of the Department of Human Services shall
6 convene an organizational meeting of the Oklahoma Partnership for
7 School Readiness Board prior to November 1, 2003, at which time
8 members of the Board shall elect a chair, a vice-chair, and other
9 officers as needed. A majority of the members of the Board shall
10 constitute a quorum for the transaction of business.

11 D. Members of the Board shall receive no compensation for
12 serving on the Board but shall receive travel reimbursement as
13 follows:

14 1. State agency officers and employees who are members of the
15 Board shall be reimbursed for travel expenses incurred in the
16 performance of their duties by their respective agencies in
17 accordance with the State Travel Reimbursement Act; and

18 2. Remaining members shall be reimbursed by the Board from any
19 funds received by the Board for travel expenses incurred in the
20 performance of their duties in accordance with the State Travel
21 Reimbursement Act.

22 E. Members of the Board shall be exempt from the dual-office-
23 holding provisions of Section 6 of Title 51 of the Oklahoma
24 Statutes.

1 SECTION 3. AMENDATORY 52 O.S. 2011, Section 288.3, as
2 last amended by Section 1, Chapter 295, O.S.L. 2017 (52 O.S. Supp.
3 2020, Section 288.3), is amended to read as follows:

4 Section 288.3 There is hereby re-created until July 1, ~~2021~~
5 2024, the Oklahoma Energy Resources Board which shall be subject to
6 the provisions of the Oklahoma Sunset Law. The purpose of the Board
7 is to coordinate a program designed to demonstrate to the general
8 public the importance of the Oklahoma oil and natural gas
9 exploration and production industry, to encourage the wise and
10 efficient use of energy, to promote environmentally sound production
11 methods and technologies, to develop existing supplies of Oklahoma's
12 oil and natural gas resources, to support research and educational
13 activities concerning the oil and natural gas exploration and
14 production industry and to cause remediation of historical oilfield
15 environmental problems.

16 SECTION 4. AMENDATORY 59 O.S. 2011, Section 137, as last
17 amended by Section 1, Chapter 469, O.S.L. 2019 (59 O.S. Supp. 2020,
18 Section 137), is amended to read as follows:

19 Section 137. A. A Board of Podiatric Medical Examiners is
20 hereby re-created, to continue until July 1, ~~2021~~ 2024, in
21 accordance with the provisions of the Oklahoma Sunset Law. Said
22 Board shall regulate the practice of podiatric medicine in this
23 state in accordance with the provisions of the Podiatric Medicine
24 Practice Act. The Board, appointed by the Governor, shall be

1 composed of five podiatric physicians licensed to practice podiatric
2 medicine in this state and one lay member representing the public.

3 B. Each podiatric physician member of the Board shall:

4 1. Be a legal resident of this state;

5 2. Have practiced podiatric medicine continuously in this state
6 during the three (3) years immediately preceding ~~his~~ appointment to
7 the Board;

8 3. Be free of pending disciplinary action or active
9 investigation by the Board; and

10 4. Be a member in good standing of the American Podiatric
11 Medical Association and of the Oklahoma Podiatric Medical
12 Association.

13 C. The lay member of the Board shall:

14 1. Be a legal resident of this state;

15 2. Not be a registered or licensed practitioner of any of the
16 healing arts or be related, within the third degree of consanguinity
17 or affinity, to any such person; and

18 3. Participate in Board proceedings only for the purposes of:

19 a. reviewing, investigating and disposing of written
20 complaints regarding the conduct of podiatric
21 physicians, and

22 b. formulating, adopting and promulgating rules pursuant
23 to Article I of the Administrative Procedures Act.
24

1 D. Except as provided in subsection E of this section, the term
2 of office of each podiatric physician member of the Board shall be
3 five (5) years, with one such member being appointed to the Board
4 each year. The lay member of the Board shall serve a term
5 coterminous with that of the Governor. Each member shall hold
6 office until the expiration of the term for which appointed or until
7 a qualified successor has been duly appointed. An appointment shall
8 be made by the Governor within ninety (90) days after the expiration
9 of the term of any member, or the occurrence of a vacancy on the
10 Board due to resignation, death, or any other cause resulting in an
11 unexpired term. The appointment of the podiatric physician members
12 shall be made from a list of not less than five persons submitted
13 annually to the Governor by the Oklahoma Podiatric Medical
14 Association.

15 E. Each of the three podiatric physician members of the Board,
16 serving on the effective date of this act, shall complete the term
17 of office for which he or she was appointed, and the successor to
18 each such member shall be appointed for a term of five (5) years.
19 Within sixty (60) days after the effective date of this act, the
20 Governor shall appoint two new podiatric physician members to the
21 Board, one for a term expiring July 1, 1997, and one for a term
22 expiring on July 1, 1998. The successor to each such new member
23 shall be appointed for a term of five (5) years.

24

1 F. Before assuming ~~his~~ duties on the Board, each member shall
2 take and subscribe to the oath or affirmation provided in Article XV
3 of the Oklahoma Constitution, which oath or affirmation shall be
4 administered and filed as provided in said article.

5 G. A member may be removed from the Board by the Governor for
6 cause which shall include, but not be limited to:

7 1. Ceasing to be qualified;

8 2. Being found guilty by a court of competent jurisdiction of a
9 felony or of any offense involving moral turpitude;

10 3. Being found guilty, through due process, of malfeasance,
11 misfeasance or nonfeasance in relation to ~~his~~ Board duties;

12 4. Being found mentally incompetent by a court of competent
13 jurisdiction;

14 5. Being found in violation of any provision of the Podiatric
15 Medicine Practice Act; or

16 6. Failing to attend three consecutive meetings of the Board
17 without just cause, as determined by the Board.

18 SECTION 5. AMENDATORY 59 O.S. 2011, Section 199.2, as
19 last amended by Section 1, Chapter 294, O.S.L. 2017 (59 O.S. Supp.
20 2020, Section 199.2), is amended to read as follows:

21 Section 199.2 A. 1. There is hereby re-created, to continue
22 until July 1, ~~2021~~ 2024, in accordance with the provisions of the
23 Oklahoma Sunset Law, a State Board of Cosmetology and Barbering
24

1 which shall be composed of eleven (11) members to be appointed by
2 the Governor and to serve at the pleasure of the Governor.

3 2. One member shall be appointed from each congressional
4 district and the additional members shall be appointed at-large.

5 However, when congressional districts are redrawn, each member
6 appointed prior to July 1 of the year in which such modification
7 becomes effective shall complete the current term of office and
8 appointments made after July 1 of the year in which such

9 modification becomes effective shall be based on the redrawn
10 districts. Appointments made after July 1 of the year in which such
11 modification becomes effective shall be from any redrawn districts
12 which are not represented by a board member until such time as each
13 of the modified congressional districts are represented by a board
14 member. One member shall be a barber appointed at-large.

15 3. At the time of appointment, the members shall be citizens of
16 this state, at least twenty-five (25) years of age, and shall be
17 high school graduates. Six members shall, at the time of
18 appointment, have had at least five (5) years' continuous practical
19 experience in the practice of cosmetology in this state; one member
20 shall be appointed at large and, at the time of the appointment,
21 have had at least five (5) years' continuous practical experience in
22 the practice of barbering in this state; one member shall be a lay
23 person; one member shall be an administrator of a licensed private
24 cosmetology school; one member shall be an administrator of a

1 licensed barber school; and one member shall be an administrator of
2 a public school licensed to teach cosmetology or barbering.

3 4. No two members shall be graduates of the same cosmetology
4 school, nor shall they be organizers of or promote the organization
5 of any cosmetic, beauty, or hairdressers' association. Each of the
6 eight cosmetology appointees shall continue to be actively engaged
7 in the profession of cosmetology while serving. No two members
8 engaged in the profession of barbering shall be organizers of or
9 promote the organization of any barbering association. Each of the
10 two barbering appointees shall continue to be actively engaged in
11 the profession of barbering while serving.

12 5. If any member retires or ceases to practice his or her
13 profession during the term of membership on the Board, such terms
14 shall automatically cease and the Governor shall appoint a like-
15 qualified person to fulfill the remainder of the term.

16 B. The terms of office for Board members shall be four (4)
17 years ending June 30.

18 C. Each member shall serve until a successor is appointed and
19 qualified.

20 D. Six members of the Board shall constitute a quorum for the
21 transaction of business.

22 E. The Governor may remove any member of the Board at any time
23 at the Governor's discretion. Vacancies shall be filled by
24 appointment by the Governor for the unexpired portion of the term.

1 F. The Board shall organize by electing from its membership a
2 chair and vice-chair, each to serve for a period of one (1) year.
3 The presiding officer shall not be entitled to vote upon any
4 question except in the case of a tie vote.

5 Members shall be reimbursed for their actual and necessary
6 traveling expenses as provided by the State Travel Reimbursement
7 Act.

8 G. Within thirty (30) days after the end of each fiscal year,
9 the Board shall make a full report to the Governor of all its
10 receipts and expenditures, and also a full statement of its work
11 during the year, together with such recommendations as the Board
12 deems expedient.

13 H. The Board may expend funds for suitable office space for the
14 transaction of its business. The Board shall adopt a common seal
15 for the use of the executive director in authenticating Board
16 documents.

17 I. The Board shall meet at its office for the transaction of
18 such business as may come before it on the second Monday in January,
19 March, May, July, September, and November and at such other times as
20 it may deem advisable.

21 SECTION 6. AMENDATORY 59 O.S. 2011, Section 858-201, as
22 last amended by Section 1, Chapter 297, O.S.L. 2017 (59 O.S. Supp.
23 2020, Section 858-201), is amended to read as follows:

24

1 Section 858-201. A. There is hereby re-created, to continue
2 until July 1, ~~2021~~ 2024, in accordance with the provisions of the
3 Oklahoma Sunset Law, the Oklahoma Real Estate Commission, which
4 shall consist of seven (7) members. The Commission shall be the
5 sole governmental entity, state, county or municipal, which shall
6 have the authority to regulate and issue real estate licenses in the
7 State of Oklahoma.

8 B. All members of the Commission shall be citizens of the
9 United States and shall have been residents of the State of Oklahoma
10 for at least three (3) years prior to their appointment.

11 C. Five members shall be licensed real estate brokers and shall
12 have had at least five (5) years' active experience as real estate
13 brokers prior to their appointment and be engaged full time in the
14 real estate brokerage business. One member shall be a lay person
15 not in the real estate business, and one member shall be an active
16 representative of a school of real estate located within the State
17 of Oklahoma and approved by the Oklahoma Real Estate Commission.

18 D. No more than two members shall be appointed from the same
19 congressional district according to the latest congressional
20 redistricting act. However, when congressional districts are
21 redrawn, each member appointed prior to July 1 of the year in which
22 such modification becomes effective shall complete the current term
23 of office and appointments made after July 1 of the year in which
24 such modification becomes effective shall be based on the redrawn

1 districts. No appointments may be made after July 1 of the year in
2 which such modification becomes effective if such appointment would
3 result in more than two members serving from the same modified
4 district.

5 SECTION 7. AMENDATORY 59 O.S. 2011, Section 1607, as
6 last amended by Section 1, Chapter 463, O.S.L. 2019 (59 O.S. Supp.
7 2020, Section 1607), is amended to read as follows:

8 Section 1607. A. There is hereby re-created, to continue until
9 July 1, ~~2021~~ 2024, in accordance with the provisions of the Oklahoma
10 Sunset Law, the Board of Examiners for Speech-Language Pathology and
11 Audiology whose duty it is to administer the provisions of the
12 Speech-Language Pathology and Audiology Licensing Act. The members
13 of the Board shall be residents of this state and shall be appointed
14 by the Governor with the advice and consent of the Senate. The
15 Board shall be composed of five (5) members consisting of three
16 licensed speech-language pathologists or audiologists, provided that
17 at least one of the three shall be a licensed speech-language
18 pathologist and at least one a licensed audiologist; one
19 otolaryngologist who is certified by the American Board of
20 Otolaryngology and one lay member.

21 B. The members of the original Board shall serve the following
22 terms: one member for one (1) year, two members for two (2) years,
23 and two members for three (3) years. Thereafter, at the expiration
24 of the term, or termination of the member's service for any reason,

1 the Governor shall appoint each successor for a term of three (3)
2 years, or for the remainder of an unexpired term. The successor for
3 any of the three speech-language pathologists or audiologists will
4 be selected from a list of five licensed speech-language
5 pathologists or audiologists, furnished by the Oklahoma Speech-
6 Language-Hearing Association. The re-creation of the Board shall
7 not affect the staggered terms of office for Board members
8 established with the original Board.

9 C. Before entering upon the duties of the member's office, each
10 member of the Board shall take the Constitutional oath of office and
11 file it with the Secretary of State.

12 D. Board members may be reappointed to serve one additional
13 three-year term. Three (3) years after the termination of a
14 previous appointment to the Board, a member may be reappointed for
15 one additional three-year term.

16 E. Board members shall be reimbursed for travel expenses
17 incurred in the performance of their duties as provided in the State
18 Travel Reimbursement Act.

19 SECTION 8. AMENDATORY 59 O.S. 2011, Section 2053, as
20 last amended by Section 1, Chapter 466, O.S.L. 2019 (59 O.S. Supp.
21 2020, Section 2053), is amended to read as follows:

22 Section 2053. A. There is hereby re-created until July 1, ~~2021~~
23 2024, in accordance with the provisions of the Oklahoma Sunset Law,
24 the State Board of Examiners of Perfusionists. The Board shall

1 administer the provisions of the Oklahoma Licensed Perfusionists
2 Act. The Board shall consist of nine (9) members, appointed by the
3 State Board of Medical Licensure and Supervision.

4 B. The initial appointments for each member shall be for
5 progressive terms of one (1) through three (3) years so that only
6 one term expires each calendar year; subsequent appointments shall
7 be for five-year terms. Members of the Board shall serve at the
8 pleasure of and may be removed from office by the appointing
9 authority. No member shall serve more than three consecutive terms.
10 Members shall continue to serve until their successors are
11 appointed. Any vacancy shall be filled in the same manner as the
12 original appointments. Five members shall constitute a quorum.

13 C. The Board shall be composed as follows:

14 1. Three members shall be members of the general public;

15 2. Four members shall be licensed perfusionists appointed from
16 a list of not less than ten licensed perfusionists submitted by a
17 statewide organization representing licensed perfusionists; and

18 3. Two members shall be physicians licensed pursuant to the
19 Oklahoma Allopathic Medical and Surgical Licensure and Supervision
20 Act and who are also board certified in cardiovascular surgery.

21 D. The licensed perfusionist members shall have been engaged in
22 rendering perfusion services to the public, teaching perfusion care,
23 or research in perfusion care, for at least five (5) years
24 immediately preceding their appointments. These members shall at

1 all times be holders of valid licenses for the practice of perfusion
2 in this state, except for the members first appointed to the Board.
3 These initial members shall, at the time of appointment, be
4 credentialed as a Certified Clinical Perfusionist (CCP) conferred by
5 the American Board of Cardiovascular Perfusion (ABCP) or its
6 successor organization, and all shall fulfill the requirements for
7 licensure pursuant to the Oklahoma Licensed Perfusionists Act. All
8 members of the Board shall be residents of this state.

9 E. Upon expiration or vacancy of the term of a member, the
10 respective nominating authority may, as appropriate, submit to the
11 appointing authority a list of not less than three persons qualified
12 to serve on the Board to fill the expired term of their respective
13 member. Appointments may be made from these lists by the appointing
14 authority and additional lists may be provided by the respective
15 organizations if requested by the appointing authority.

16 F. It shall be a ground for removal from the Board if a member:

17 1. Does not have at the time of appointment the qualifications
18 required for appointment to the Board;

19 2. Does not maintain during service on the Board the
20 qualifications required for appointment to the Board;

21 3. Violates a prohibition established pursuant to the Oklahoma
22 Licensed Perfusionists Act;

23

24

1 4. Cannot discharge the member's term for a substantial part of
2 the term for which the member is appointed because of illness or
3 disability; or

4 5. Is absent from more than half of the regularly scheduled
5 board meetings that the member is eligible to attend during a
6 calendar year unless the absence is excused by a majority vote of
7 the Board.

8 SECTION 9. AMENDATORY 59 O.S. 2011, Section 2305, as
9 last amended by Section 1, Chapter 464, O.S.L. 2019 (59 O.S. Supp.

11 Section 2305. A. There is hereby re-created, to continue until
12 July 1, ~~2021~~ 2024, in accordance with the provisions of the Oklahoma
13 Sunset Law, an Advisory Committee on Pedorthics, which shall consist
14 of five (5) voting members to be appointed by the State Board of
15 Medical Licensure and Supervision to three-year terms ending
16 December 31; provided, initial appointments shall be staggered such
17 that two members are appointed for one (1) year, two members are

8 SECTION 10. AMENDATORY 59 O.S. 2011, Section 3005, as
9 last amended by Section 1, Chapter 465, O.S.L. 2019 (59 O.S. Supp.
10 2020, Section 3005), is amended to read as follows:

11 Section 3005. A. There is hereby re-created, to continue until
12 July 1, ~~2021~~ 2024, in accordance with the provisions of the Oklahoma
13 Sunset Law, an Advisory Committee on Orthotics and Prosthetics,
14 which shall consist of seven (7) voting members to be appointed by
15 the State Board of Medical Licensure and Supervision to three-year
16 terms ending December 31; provided, initial appointments shall be
17 staggered such that two members are appointed for one (1) year, two
18 members are appointed for two (2) years, and three members are
19 appointed for three (3) years.

20 B. One member shall be a licensed physician who is a member of
21 the State Board of Medical Licensure and Supervision. Two members
22 shall be lay persons who are consumers of orthotic or prosthetic
23 services. Two members shall be licensed orthotists, not more than
24 one of whom may also be a licensed prosthetist. Two members shall

3 Prosthetics Practice Act not being possible until the act is

15 SECTION 11. AMENDATORY 74 O.S. 2011, Section 4102, as
16 last amended by Section 1, Chapter 193, O.S.L. 2019 (74 O.S. Supp.
17 2020, Section 4102), is amended to read as follows:

18 Section 4102. There is hereby re-created, to continue until
19 July 1, ~~2020~~ 2024, in accordance with the provisions of the Oklahoma
20 Sunset Law, the State Capitol Preservation Commission which shall be
21 responsible for planning and supervising the preservation and
22 restoration of the interior and exterior of the State Capitol
23 Building, hereinafter referred to as the Capitol, and the Governor's
24

1 Mansion. The Commission shall control the display of art objects in
2 public areas of the Capitol and the Governor's Mansion.

3 SECTION 12. This act shall become effective July 1, 2021.

4 SECTION 13. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
