20 follows:

21 "G. The provisions of this section shall not apply to a non-  
22 appropriated agency that has authority to refund from its revolving  
23 fund a portion of collected fees, fines or assessments on a pro rata  
24 basis."

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified

15

in the Oklahoma Statutes as Section 154 of Title 62, unless there is

16

created a duplication in numbering, reads as follows:

A. By the first Monday in August of each year, the Office of

18

Management and Enterprise Services shall reconcile all state agency

19

revolving funds pursuant to reconciliation criteria developed by the

20

Director of the Office of Management and Enterprise Services for

21

each individual state agency revolving fund, which may include but

22

is not limited to no action, cash transfer or requisite fee or fine

23

reduction. Such criteria shall be adopted by rule and subject to

24

the Administrative Procedures Act, Section 250 et seq. of Title 75

1 of the Oklahoma Statutes, and codified in the administrative code of  
2 the Office of Management and Enterprise Services.

3 B. The Office of Management and Enterprise Services shall  
4 separate appropriated agencies from nonappropriated agencies and  
5 shall make a report regarding the revolving funds of each agency  
6 type for purposes of this section.

7 C. With respect to the revolving fund balances of an  
8 appropriated agency, such balances shall be transferred to the  
9 Special Cash Fund.

10 D. With respect to the revolving fund balances of  
11 nonappropriated agencies, the recommendations of the Office of  
12 Management and Enterprise Services shall be communicated in writing  
13 to the Speaker of the Oklahoma House of Representatives, to the  
14 President Pro Tempore of the Oklahoma State Senate and to the  
15 chairperson of the standing committee responsible for the analysis  
16 of administrative rules for both the Oklahoma House of  
17 Representatives and the Oklahoma State Senate.

18 E. Proceeds realized through the reconciliation shall be  
19 deposited in the Special Cash Fund for certification by the State  
20 Board of Equalization at the December meeting for expenditure  
21 authority in the following fiscal year.

22 F. By the second Friday in August of each year, state agency  
23 directors may file reconciliation protests with the Legislative  
24 Oversight Committee on State Budget Performance. If a protest is
