14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 63 O.S. 2021, Section 683.4, is
16	amended to read as follows:
17	Section 683.4 A. There is hereby created the Oklahoma
18	Department of Emergency Management (OEM). The Governor shall
19	appoint a Director of the Department, with the advice and consent of
20	the Senate, who shall be the head of the Department. The Governor
21	shall fix the salary of the Director, in cooperation with standards
22	promulgated by the Office of Management and Enterprise Services.
23	B. The Director may employ personnel and fix their compensation
24	in cooperation with standards promulgated by the Office of

Management and Enterprise Services, and may make such expenditures within the appropriation therefor, or from such other available funds as may be necessary to carry out the purposes of the Oklahoma Emergency Management Act of 2003 and other programs specified by law.

C. The Director and other personnel of the Department shall be
provided with appropriate office space, furniture, equipment,
supplies, stationery, and printing in the same manner as provided
for personnel of other state agencies.

D. The Director, subject to the direction and control of the Governor, shall be the executive head of the Department and shall serve as the chief advisor to the Governor on emergency management and shall:

Be responsible to the Governor for carrying out the programs
 as required by law;

16 2. Coordinate the activities of all organizations for emergency 17 management within the state;

18 3. Maintain liaison with and cooperate with the emergency 19 management agencies and organizations of other states and of the 20 federal government;

21 4. Develop and maintain a comprehensive all-hazards mitigation
22 plan for this state;

23 5. Implement the Oklahoma Hazard Mitigation Program;24

Have such additional authority, duties, and responsibilities
 authorized by the Oklahoma Emergency Management Act of 2003 and as
 may be prescribed by the Governor;

4 7. Supervise the Office of Volunteerism in accordance with5 Section 683.26 of this title; and

8. Report quarterly to the Governor, the Speaker of the House of
Representatives and the President Pro Tempore of the Senate the
balance and outstanding obligations of the State Emergency Fund.

9 E. The Director shall supervise the formulation, execution, 10 review and revisions of the state Emergency Operations Plan as 11 provided for by Section 683.2 of this title. The plan shall be 12 reviewed annually and revised as necessary.

13SECTION 2.AMENDATORY63 O.S. 2021, Section 683.9, is14amended to read as follows:

15 Section 683.9 The provisions of this section shall be operative 16 only during the existence of a natural or man-made emergency. The 17 existence of such emergency may be proclaimed by the Governor or by 18 concurrent resolution of the Legislature if the Governor in such 19 proclamation, or the Legislature in such resolution, finds that an 20 emergency or disaster has occurred or is anticipated in the 21 immediate future. Any such emergency, whether proclaimed by the 22 Governor or by the Legislature, shall terminate upon the 23 proclamation of the termination thereof by the Governor \overline{r} or by 24 automatically after thirty (30) days unless renewed by concurrent

resolution of the Legislature, whichever occurs first. Any such
emergency proclaimed by the Legislature shall terminate upon passage
by the Legislature of a concurrent resolution terminating such
emergency. During such period as such state of emergency exists or
continues, the Governor shall have and may exercise the following
additional emergency powers:

7 To activate the Emergency Operations Plan, and to assume 1. regulatory control over all essential resources of this state, 8 9 directly or through the boards, agencies, offices and officers 10 established by the Emergency Operations Plan, to determine 11 priorities of such resources and allocate such resources as the 12 Governor may deem necessary in cooperation with the political 13 subdivisions of this state, the federal government, or other states. "Resources" shall mean all economic resources within this state 14 15 including but not limited to food, manpower, health, water, 16 transportation, economic stabilization, electric power, petroleum, 17 gas, and solid fuel, industrial production, construction and 18 housing.

To enforce all laws, rules and regulations relating to
 emergency management and to assume direct operational control of any
 or all emergency management forces and helpers in this state.

3. To provide for the evacuation of all or part of the population from any stricken or threatened area or areas within this

state and to take such steps as are necessary for the receipt and
 care of such evacuees.

Subject to the provisions of the State Constitution, to 3 4. 4 remove from office any public officer having administrative 5 responsibilities under this act for willful failure to obey any 6 order, rule or regulation adopted pursuant to this act. Such 7 removal shall be upon charges after service upon such person of a copy of such charges and after giving such person an opportunity to 8 9 be heard in the defense of such person. Pending the preparation and 10 disposition of charges, the Governor may suspend such person for a 11 period not exceeding thirty (30) days. A vacancy resulting from 12 removal or suspension pursuant to this section shall be filled by the Governor until it is filled as otherwise provided by law. 13

14 5. To perform and exercise such other functions, powers, and 15 duties as are necessary to promote and secure the safety and 16 protection of the civilian population and to carry out the 17 provisions of the Emergency Operations Plan in a national or state 18 emergency.

19 SECTION 3. This act shall become effective November 1, 2024.
