13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 40 O.S. 2011, Section 141.9, is
15	amended to read as follows:
16	Section 141.9 A. 1. Certificates of competency designating
17	special inspectors of boilers and pressure vessels shall be issued
18	by the Commissioner upon request of any authorized inspection
19	agency, which has been licensed or registered by the appropriate
20	authority of this state. All such authorized inspection agencies
21	shall provide boiler and pressure vessel insurance coverage and be
22	actively engaged in writing this type coverage in this state \div .
23	2. Before receiving a certificate of competency, each inspector
24	shall receive a passing grade on the examination provided for by

- Section 10 141.10 of this act title, or shall hold a commission or certificate of competency as an inspector of boilers or pressure vessels from a state that has a standard of examination equal to that of this state, or a commission as an inspector of boilers and pressure vessels issued by the National Board of Boiler and Pressure Vessel Inspectors.
 - 3. Special inspectors shall not receive any salary or expenses from this state, and a certificate of competency shall be valid only as long as such special inspectors are in full-time employment of an authorized inspection agency.
 - 4. Special inspectors may inspect all boilers and pressure vessels insured by their respective authorized inspection agency and.
- 5. The inspections required pursuant to the Boiler and Pressure 14 15 Vessel Safety Act that are conducted incidental to the issuance or 16 renewal of boiler and machinery insurance shall not subject an insurer, whether domestic or foreign, its agents or its employees to 17 liability for damages for any act or omission in the course of 18 performing inspections as provided by this section. This section 19 shall not apply if the gross negligence of the insurer, its agent or 20 its employee created the condition that was the proximate cause of 21 the injury, death or loss. 22
 - $\underline{6.}$ The insurance company shall apply on or before January 31 of each year for renewal of certificates of competency for each special

- 3 1. Certificates of competency designating owner-user В. inspectors of boilers or pressure vessels or both shall be issued by the Commissioner upon request of any company operating boilers or 5 pressure vessels or both in this state. The owner-user shall 6 7 maintain a regularly established inspection department which is under the supervision of one or more technically competent 9 individuals whose qualifications and whose organization and 10 inspection procedures are in accordance with paragraph 4 of subsection A of Section $\frac{3}{2}$ 141.3 of this $\frac{1}{2}$ title and acceptable to 11 12 the Commissioner of Labor. Boilers and pressure vessels shall be inspected regularly and in accordance with applicable provisions of 13 the rules and regulations adopted by the Commissioner pursuant to 14 15 this act+.
 - 2. Before receiving a certificate of competency, each inspector shall attain a passing grade on the examination provided for by Section 10 141.10 of this act title, or shall hold a certificate of competency as an inspector from a state that has a standard of examination equal to that of this state, or who holds a valid commission issued in accordance with the constitution and bylaws of the National Board of Boiler and Pressure Vessel Inspectors.
 - 3. A certificate of competency as an owner-user inspector shall be issued only if, in addition to meeting the requirements in

- paragraph 2 of this subsection, the inspector is continuously
 employed by the company and is responsible for making inspection of
 boilers and pressure vessels used by such company.
 - 4. Owner-user inspectors shall not receive any salary or expenses from this state and a certificate of competency shall be valid only as long as such owner-user inspector is employed full time by a qualified owner-user inspection agency, in accordance with the applicable provisions of the rules and regulations adopted pursuant to this act.
 - 5. The owner-user inspection agency will apply on or before January 31 of each year for renewal of competency for each owner-user inspector employed in this state. The fee must accompany application; and.
 - 6. Such owner-user inspectors may inspect all pressure vessels operated by their respective companies and, when so inspected, the owners and users of such pressure vessels shall be exempt from the payment to the state of the inspection fees provided for in Section 16 141.16 of this act title.
- SECTION 2. This act shall become effective November 1, 2018.
