HOUSE BILL 3286

AS INTRODUCED

An Act relating to Service Oklahoma; amending 47 O.S. 2021, Section 6-101, as last amended by Section 5, Chapter 47, 1st Extraordinary Session, O.S.L. 2023 (47 O.S. Supp. 2023, Section 6-101), which relates to driver licenses; allowing certain entity to issue commercial learner permits; requiring Service Oklahoma promulgate certain rules; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2021, Section 6-101, as last amended by Section 5, Chapter 47, 1st Extraordinary Session, O.S.L. 2023 (47 O.S. Supp. 2023, Section 6-101), is amended to read as follows:

Section 6-101. A. No person, except those hereinafter expressly exempted in Sections 6-102 and 6-102.1 of this title, shall operate any motor vehicle upon a highway in this state unless the person has a valid Oklahoma driver license for the class of vehicle being operated under the provisions of this title. No person shall be permitted to possess more than one valid license at

1 any time, except as provided in paragraph 4 of subsection F of this
2 section.

3 B. 1. No person shall operate a Class A commercial motor
4 vehicle unless the person is eighteen (18) years of age or older and
5 holds a valid Class A commercial license, except as provided in
6 paragraph 5 of this subsection and subsection F of this section.
7 Any person holding a valid Class A commercial license shall be
8 permitted to operate motor vehicles in Classes A, B, C and D, except
9 as provided for in paragraph 4 of this subsection.

10 2. No person shall operate a Class B commercial motor vehicle
11 unless the person is eighteen (18) years of age or older and holds a
12 valid Class B commercial license, except as provided in paragraph 5
13 of subsection F of this section. Any person holding a valid Class B
14 commercial license shall be permitted to operate motor vehicles in
15 Classes B, C and D, except as provided for in paragraph 4 of this
16 subsection.

17 3. No person shall operate a Class C commercial motor vehicle
18 unless the person is eighteen (18) years of age or older and holds a
19 valid Class C commercial license, except as provided in subsection F
20 of this section. Any person holding a valid Class C commercial
21 license shall be permitted to operate motor vehicles in Classes C
22 and D, except as provided for in paragraph 4 of this subsection.

23 4. No person under twenty-one (21) years of age shall be
24 licensed to operate any motor vehicle which is required to be
..

1 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
2 subpart F, except as provided in subsection F of this section;
3 provided, a person eighteen (18) years of age or older may be
4 licensed to operate a farm vehicle which is required to be placarded
5 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
6 except as provided in subsection F of this section.

7 5. A person at least seventeen (17) years of age who
8 successfully completes all examinations required by law may be
9 issued by Service Oklahoma:

- 10 a. a restricted Class A commercial license which shall
11 grant to the licensee the privilege to operate a Class
12 A or Class B commercial motor vehicle for harvest
13 purposes or a Class D motor vehicle, or
- 14 b. a restricted Class B commercial license which shall
15 grant to the licensee the privilege to operate a Class
16 B commercial motor vehicle for harvest purposes or a
17 Class D motor vehicle.

18 6. No person shall operate a Class D motor vehicle unless the
19 person is sixteen (16) years of age or older and holds a valid Class
20 D license, except as provided for in Section 6-102 or 6-105 of this
21 title. Any person holding a valid Class D license shall be
22 permitted to operate motor vehicles in Class D only.

1 C. Any person issued a driver license pursuant to this section
2 may exercise the privilege thereby granted upon all streets and
3 highways in this state.

4 D. No person shall operate a motorcycle or motor-driven cycle
5 without having a valid Class A, B, C or D license with a motorcycle
6 endorsement. Except as otherwise provided by law, any new applicant
7 for an original driver license shall be required to successfully
8 complete a written examination, vision examination and driving
9 examination for a motorcycle as prescribed by the Department of
10 Public Safety, in conjunction with Service Oklahoma, and a certified
11 state-approved motorcycle basic rider course approved by the
12 Department, in conjunction with Service Oklahoma, if the applicant
13 is seventeen (17) years of age or younger to be eligible for a
14 motorcycle endorsement thereon. The written examination and driving
15 examination for a motorcycle shall be waived by Service Oklahoma
16 upon verification that the person has successfully completed a
17 certified Motorcycle Safety Foundation rider course approved by the
18 Department, in conjunction with Service Oklahoma.

19 E. Except as otherwise provided by law, any person who lawfully
20 possesses a valid Oklahoma driver license which is eligible for
21 renewal shall be required to successfully complete a written
22 examination, vision examination and driving examination for a
23 motorcycle as prescribed by the Department, in conjunction with
24 Service Oklahoma, and a certified state-approved motorcycle basic
--

1 rider course approved by the Department, in conjunction with Service
2 Oklahoma, if the person is seventeen (17) years of age or younger to
3 be eligible for a motorcycle endorsement. The written examination
4 and driving examination for a motorcycle shall be waived by Service
5 Oklahoma upon verification that the person has successfully
6 completed a certified Motorcycle Safety Foundation rider course
7 approved by the Department, in conjunction with Service Oklahoma.

8 F. 1. Any person eighteen (18) years of age or older may apply
9 for a restricted Class A, B or C commercial learner permit. Service
10 Oklahoma or an Oklahoma Department of Career and Technology
11 Education location contracted with Service Oklahoma, after the
12 applicant has passed all parts of the examination for a Class D
13 license and has successfully passed all parts of the examination for
14 a Class A, B or C commercial license other than the driving
15 examination, may issue to the applicant a commercial learner permit
16 which shall entitle the person having immediate lawful possession of
17 the commercial learner permit and a valid Oklahoma driver license or
18 provisional driver license pursuant to Section 6-212 of this title
19 to operate a Class A, B or C commercial motor vehicle upon the
20 public highways solely for the purpose of behind-the-wheel training
21 in accordance with rules promulgated by the Department.

22 2. This commercial learner permit shall be issued for a period
23 as provided in Section 6-115 of this title of one hundred eighty
24 (180) days, which may be renewed one time for an additional one
--

1 hundred eighty (180) days; provided, such commercial learner permit
2 may be suspended, revoked, canceled, denied or disqualified at the
3 discretion of the Department, with notice to Service Oklahoma, for
4 violation of the restrictions, for failing to give the required or
5 correct information on the application or for violation of any
6 traffic laws of this state pertaining to the operation of a motor
7 vehicle. Except as otherwise provided, the lawful possessor of a
8 commercial learner permit who has been issued a commercial learner
9 permit for a minimum of fourteen (14) days may have the restriction
10 requiring an accompanying driver removed by satisfactorily
11 completing a driver's examination; provided, the removal of a
12 restriction shall not authorize the operation of a Class A, B or C
13 commercial motor vehicle if such operation is otherwise prohibited
14 by law.

15 3. No person shall apply for and Service Oklahoma shall not
16 issue an original Class A, B or C driver license until the person
17 has been issued a commercial learner permit and held the permit for
18 at least fourteen (14) days. Any person who currently holds a Class
19 B or C license and who wishes to apply for another class of
20 commercial driver license shall be required to apply for a
21 commercial learner permit and to hold the permit for at least
22 fourteen (14) days before applying for the Class A or B license, as
23 applicable. Any person who currently holds a Class A, B or C
24 license and who wishes to add an endorsement or remove a restriction
--

1 for which a skills examination is required shall be required to
2 apply for a commercial learner permit and to hold the permit for at
3 least fourteen (14) days before applying for the endorsement.

4 4. A commercial learner permit shall be issued by Service
5 Oklahoma or an Oklahoma Department of Career and Technology
6 Education location contracted with Service Oklahoma as a separate
7 and unique document which shall be valid only in conjunction with a
8 valid Oklahoma driver license or provisional driver license pursuant
9 to Section 6-212 of this title, both of which shall be in the
10 possession of the person to whom they have been issued whenever that
11 person is operating a commercial motor vehicle as provided in this
12 subsection.

13 5. After one renewal of a commercial learner permit, as
14 provided in paragraph 2 of this subsection, a commercial permit
15 shall not be renewed again. Any person who has held a commercial
16 learner permit for the initial issuance period and one renewal
17 period shall not be eligible for and Service Oklahoma shall not
18 issue another renewal of the permit; provided, the person may
19 reapply for a new commercial learner permit, as provided for in this
20 subsection.

21 6. Service Oklahoma shall promulgate rules to allow Oklahoma
22 Department of Career and Technology Education locations contracted
23 with Service Oklahoma to provide commercial driver training the
24
--

1 ability to issue commercial learner permits in its training
2 facilities.

3 G. 1. For purposes of this title:

4 a. "REAL ID Compliant Driver License" or "Identification
5 Card" means a driver license or identification card
6 issued by this state that has been certified by the
7 United States Department of Homeland Security (USDHS)
8 as compliant with the requirements of the REAL ID Act
9 of 2005, Public Law No. 109-13. A REAL ID Compliant
10 Driver License or Identification Card and the process
11 through which it is issued incorporate a variety of
12 security measures designed to protect the integrity
13 and trustworthiness of the license or card. A REAL ID
14 Compliant Driver License or Identification Card will
15 be clearly marked on the face indicating that it is a
16 compliant document, and

17 b. "REAL ID Noncompliant Driver License" or
18 "Identification Card" means a driver license or
19 identification card issued by this state that has not
20 been certified by the United States Department of
21 Homeland Security (USDHS) as being compliant with the
22 requirements of the REAL ID Act of 2005. A REAL ID
23 Noncompliant Driver License or Identification Card
24 will be clearly marked on the face indicating that it
--

1 is not compliant with the federal REAL ID Act of 2005
2 and is not acceptable for official federal purposes.
3 The driver license or identification card will have a
4 unique design or color indicator that clearly
5 distinguishes it from a compliant license or card.

6 2. Original Driver License and Identification Card Issuance:

- 7 a. Application for an original REAL ID Compliant or REAL
8 ID Noncompliant Driver License or Identification Card
9 shall be made to Service Oklahoma.
- 10 b. Service Oklahoma employees shall perform all document
11 recognition and other requirements needed for approval
12 of an original REAL ID Compliant or REAL ID
13 Noncompliant Driver License or Identification Card
14 application.
- 15 c. Upon approval of an original REAL ID Compliant or REAL
16 ID Noncompliant Driver License or Identification Card
17 application, the applicant may take the approved
18 application document to a licensed operator to receive
19 a temporary driver license or identification card.
- 20 d. The licensed operator shall process the approved REAL
21 ID Compliant or REAL ID Noncompliant Driver License or
22 Identification Card application and upon payment shall
23 provide the applicant a temporary driver license or
24 identification card. A temporary driver license or
--

1 identification card shall afford the holder the
2 privileges otherwise granted by the specific class of
3 driver license or identification card for the period
4 of time listed on the temporary driver license or
5 identification card or the period of time prior to the
6 applicant receiving a REAL ID Compliant or REAL ID
7 Noncompliant Driver License or Identification Card,
8 whichever time period is shorter.

9 3. REAL ID Compliant Driver License and Identification Card

10 Renewal and Replacement:

- 11 a. Application for renewal or replacement of a REAL ID
12 Compliant Driver License or Identification Card may be
13 made to Service Oklahoma or to a licensed operator;
14 provided, such licensed operator is authorized to
15 process application for REAL ID Compliant Driver
16 Licenses and Identification Cards. A licensed
17 operator may process the voluntary downgrade of a REAL
18 ID Compliant Commercial Driver License to any lower
19 class license upon request of the licensee; provided,
20 no additional endorsements or restrictions are placed
21 on the license.
- 22 b. Service Oklahoma employees or authorized licensed
23 operators shall perform all document recognition and
24 other requirements needed for approval of a renewal or
--

1 replacement REAL ID Compliant Driver License or
2 Identification Card application.

3 c. Upon approval of a renewal or replacement REAL ID
4 Compliant Driver License or Identification Card
5 application, the applicant may receive a temporary
6 driver license or identification card from Service
7 Oklahoma or an authorized licensed operator.

8 d. A temporary driver license or identification card
9 acquired under the provisions of this paragraph shall
10 afford the holder the privileges otherwise granted by
11 the specific class of driver license or identification
12 card being renewed or replaced for the period of time
13 listed on the temporary driver license or
14 identification card or the period of time prior to the
15 applicant receiving a REAL ID Compliant Driver License
16 or Identification Card, whichever time period is
17 shorter.

18 e. For purposes of this title, an application for a REAL
19 ID Compliant Driver License or Identification Card by
20 an individual with a valid Oklahoma-issued driver
21 license or identification card shall be considered a
22 renewal of a REAL ID Compliant Driver License or
23 Identification Card.

24
--

1 4. REAL ID Noncompliant Driver License and Identification Card

2 Renewal and Replacement:

- 3 a. Application for renewal or replacement of a REAL ID
4 Noncompliant Driver License or Identification Card may
5 be made to Service Oklahoma or to a licensed operator.
6 A licensed operator may process the voluntary
7 downgrade of a REAL ID Noncompliant Commercial Driver
8 License to any lower class license upon request of the
9 licensee; provided, no additional endorsements or
10 restrictions are added to the license.
- 11 b. Service Oklahoma employees or licensed operators shall
12 perform all document recognition and other
13 requirements needed for approval of a renewal or
14 replacement REAL ID Noncompliant Driver License or
15 Identification Card application.
- 16 c. Upon approval of a renewal or replacement REAL ID
17 Noncompliant Driver License or Identification Card
18 application, the applicant may receive a temporary
19 driver license or identification card from Service
20 Oklahoma or a licensed operator.
- 21 d. A temporary driver license or identification card
22 acquired under the provisions of this paragraph shall
23 afford the holder the privileges otherwise granted by
24 the specific class of driver license or identification
--

1 card being renewed or replaced for the period of time
2 listed on the temporary driver license or
3 identification card or the period of time prior to the
4 applicant receiving a REAL ID Noncompliant Driver
5 License or Identification Card, whichever time period
6 is shorter.

7 H. 1. The fee charged for an approved application for an
8 original Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver
9 License or an approved application for the addition of an
10 endorsement to a current valid Oklahoma REAL ID Compliant or REAL ID
11 Noncompliant Driver License shall be assessed in accordance with the
12 following schedule:

1 2. Notwithstanding the provisions of Section 1104 of this
2 title, all monies collected from the fees charged for Class A, B and
3 C commercial licenses pursuant to the provisions of this subsection
4 shall be deposited in the General Revenue Fund of this state.

5 I. The fee charged for any failed examination shall be Four
6 Dollars (\$4.00) for any license classification. Notwithstanding the
7 provisions of Section 1104 of this title, all monies collected from
8 such examination fees pursuant to the provisions of this subsection
9 shall be deposited in the General Revenue Fund of this state.

10 J. In addition to any fee charged pursuant to the provisions of
11 subsection H of this section, the fee charged for the issuance or
12 renewal of a REAL ID Noncompliant Driver License shall be in
13 accordance with the following schedule; provided, that any applicant
14 who has a CDL Learner Permit shall be charged only the replacement
15 fee for the issuance of the license:

3 K. In addition to any fee charged pursuant to the provisions of
4 subsection H of this section, the fee charged for the issuance or
5 renewal of a REAL ID Compliant Driver License shall be in accordance
6 with the following schedule; provided, that any applicant who has a
7 CDL Learner Permit shall be charged only the replacement fee for the
8 issuance of the license:

1 L. A commercial learner permit may be renewed one time for a
2 period of one hundred eighty (180) days. The cost for the renewed
3 permit shall be the same as for the original permit.

4 M. Notwithstanding the provisions of Section 1104 of this
5 title, of each fee charged pursuant to the provisions of subsections
6 J, K and L of this section:

7 1. Five Dollars and fifty cents (\$5.50) of a 4-year license or
8 Eleven Dollars (\$11.00) of an 8-year license shall be deposited to
9 the Trauma Care Assistance Revolving Fund created in Section 1-
10 2530.9 of Title 63 of the Oklahoma Statutes;

11 2. Six Dollars and seventy-five cents (\$6.75) of a 4-year
12 license or Thirteen Dollars and fifty cents (\$13.50) of an 8-year
13 license shall be deposited to the Department of Public Safety
14 Computer Imaging System Revolving Fund to be used solely for the
15 purpose of administration and maintenance of the computerized
16 imaging system of the Department through October 31, 2022.

17 Beginning November 1, 2022, Six Dollars and seventy-five cents
18 (\$6.75) of a 4-year license or Thirteen Dollars and fifty cents
19 (\$13.50) of an 8-year license shall be deposited to the Service
20 Oklahoma Computer Imaging System Revolving Fund to be used solely
21 for the purpose of administration and maintenance of the
22 computerized imaging system of Service Oklahoma;

23 3. Ten Dollars (\$10.00) of a 4-year license or Twenty Dollars
24 (\$20.00) of an 8-year license shall be deposited to the Department
--

1 of Public Safety Revolving Fund for all original or renewal
2 issuances of licenses through October 31, 2022. Beginning November
3 1, 2022, Ten Dollars (\$10.00) of a 4-year license or Twenty Dollars
4 (\$20.00) of an 8-year license shall be deposited to the Service
5 Oklahoma Revolving Fund for all original or renewal issuances of
6 licenses; and

7 4. Five Dollars (\$5.00) of a 4-year license or Six Dollars
8 (\$6.00) of an 8-year license shall be deposited to the State Public
9 Safety Fund created in Section 2-147 of this title.

10 N. All original and renewal driver licenses shall expire as
11 provided in Section 6-115 of this title.

12 O. 1. Through May 31, 2025, any person sixty-two (62) to
13 sixty-four (64) years of age during the calendar year of issuance or
14 renewal of a Class D license or motorcycle endorsement shall be
15 charged the following prorated fee:

20 2. Any person sixty-five (65) years of age or older during the
21 calendar year of issuance or renewal of a Class D license or
22 motorcycle endorsement shall not be charged a fee.

23 P. No person who has been honorably discharged from active
24 service in any branch of the Armed Forces of the United States or
--

1 Oklahoma National Guard and who has been certified by the United
2 States Department of Veterans Affairs, its successor or the Armed
3 Forces of the United States to be a disabled veteran in receipt of
4 compensation at the one-hundred-percent rate for a permanent
5 disability sustained through military action or accident resulting
6 from disease contracted while in such active service and registered
7 with the veterans registry created by the Oklahoma Department of
8 Veterans Affairs shall be charged a fee for the issuance,
9 replacement or renewal of an Oklahoma driver license; provided, that
10 if a veteran has been previously exempt from a fee pursuant to this
11 subsection, no registration with the veterans registry shall be
12 required.

13 Q. In accordance with the provisions of subsection G of this
14 section, Service Oklahoma is authorized to promulgate rules for the
15 issuance and renewal of driver licenses authorized pursuant to the
16 provisions of Sections 6-101 through 6-309 of this title; provided,
17 that no such rules applicable to the issuance or renewal of REAL ID
18 Noncompliant Driver Licenses shall create more stringent standards
19 than such rules applicable as of January 1, 2017, unless directly
20 related to a specific change in statutory law concerning standards
21 for REAL ID Noncompliant Driver Licenses. Applications, upon forms
22 approved by Service Oklahoma, for such licenses shall be handled, in
23 accordance with the provisions of subsection G of this section, by
24 the licensed operator; provided, Service Oklahoma is authorized to

1 assume these duties in any county of this state. Each licensed
2 operator accepting applications for driver licenses shall receive
3 Six Dollars (\$6.00) for a 4-year REAL ID Noncompliant Driver License
4 or Twelve Dollars (\$12.00) for an 8-year REAL ID Noncompliant Driver
5 License or Ten Dollars (\$10.00) for a 4-year REAL ID Compliant
6 Driver License or Twenty Dollars (\$20.00) for an 8-year REAL ID
7 Compliant Driver License to be deducted from the total collected for
8 each license or renewal application accepted through June 30, 2023.
9 Beginning July 1, 2022, and ending on June 30, 2023, each motor
10 license agent or licensed operator accepting applications for driver
11 licenses for individuals over the age of sixty-five (65) years or
12 for applications for drivers pursuant to subsection P of this
13 section shall receive Six Dollars (\$6.00) for a 4-year driver
14 license or Twelve Dollars (\$12.00) for an 8-year driver license to
15 be deducted daily by the motor license agent or licensed operator
16 receipts. Beginning July 1, 2023, these fees shall be retained by
17 the licensed operator pursuant to subsection E of Section 1141.1 of
18 this title. The fees received by the licensed operator, authorized
19 by this subsection, shall be used for operating expenses. The
20 amount retained pursuant to this subsection shall not be retained by
21 any state agency. The fees received by the licensed operator,
22 authorized by this subsection, shall be used for operating expenses.
23 For purposes of this subsection, "licensed operator" shall mean an
24 individual who obtains a license from the Service Oklahoma Operator
..

1 Board to operate a designated Service Oklahoma location and offers
2 third-party fulfillment of designated services to be rendered by
3 Service Oklahoma.

4 R. Notwithstanding the provisions of Section 1104 of this title
5 and subsection Q of this section and except as provided in
6 subsections H and M of this section, the first Sixty Thousand
7 Dollars (\$60,000.00) of all monies collected pursuant to this
8 section shall be paid by the Oklahoma Tax Commission to the State
9 Treasurer to be deposited in the General Revenue Fund of the State
10 Treasury.

11 The next Five Hundred Thousand Dollars (\$500,000.00) of monies
12 collected pursuant to this section shall be paid by the Tax
13 Commission to the State Treasurer to be deposited each fiscal year
14 under the provisions of this section to the credit of the Department
15 of Public Safety Restricted Revolving Fund for the purpose of the
16 Oklahoma Law Enforcement Telecommunications System. All other
17 monies collected in excess of Five Hundred Sixty Thousand Dollars
18 (\$560,000.00) each fiscal year shall be apportioned as provided in
19 Section 1104 of this title, except as otherwise provided in this
20 section.

21 S. Service Oklahoma shall retain the images displayed on
22 licenses and identification cards issued pursuant to the provisions
23 of Sections 6-101 through 6-309 of this title which may be used
24 only:
--

1 1. By a law enforcement agency for purposes of criminal
2 investigations, missing person investigations or any law enforcement
3 purpose which is deemed necessary by the Commissioner of Public
4 Safety;

5 2. By the driver licensing agency of another state for its
6 official purpose; and

7 3. As provided in Section 2-110 of this title.

8 All agencies approved by the Oklahoma Law Enforcement
9 Telecommunications System (OLETS) or the National Law Enforcement
10 Telecommunications System (NLETS) to receive photographs or
11 computerized images may obtain them through OLETS or through NLETS.
12 Photographs or computerized images may be obtained by law
13 enforcement one inquiry at a time.

14 The computer system and related equipment acquired for this
15 purpose must conform to industry standards for interoperability and
16 open architecture. The Department of Public Safety may promulgate
17 rules to implement the provisions of this subsection.

18 T. No person may hold more than one state-issued or territory-
19 issued REAL ID Compliant Driver License or REAL ID Compliant
20 Identification Card from Oklahoma or any other state or territory.
21 Service Oklahoma shall not issue a REAL ID Compliant Driver License
22 to a person who has been previously issued a REAL ID Compliant
23 Driver License or REAL ID Compliant Identification Card until such
24 license or identification card has been surrendered to Service

1 Oklahoma by the applicant. Service Oklahoma may promulgate rules
2 related to the issuance of replacement REAL ID Compliant Driver
3 Licenses in the event of loss or theft.

4 U. Beginning May 24, 2021, and ending on June 30, 2023, in
5 addition to the amounts provided in subsection Q of this section, a
6 licensed operator shall receive Five Dollars (\$5.00) for each
7 processed application for a REAL ID Compliant 4-year Driver License
8 and Ten Dollars (\$10.00) for each processed application for a REAL
9 ID Compliant 8-year Driver License. Any additional amounts provided
10 pursuant to this subsection shall not be retained by Service
11 Oklahoma.

12 SECTION 2. This act shall become effective November 1, 2024.
