HOUSE BILL 3455

AS INTRODUCED

An Act relating to the classification of felony offenses; creating the Oklahoma Crime Reclassification Act of 2024; requiring persons who commit criminal offenses to be classified in accordance with certain structure; affirming certain sentencing powers of the court; providing list of classes; directing the use of certain criminal provisions for first degree murder convictions; establishing a classification system for felony criminal offenses; stating classifications; providing list of crimes for each class; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 20A of Title 21, unless there is created a duplication in numbering, reads as follows:

A. This act shall be known and may be cited as the "Oklahoma Crime Reclassification Act of 2024".

B. There is hereby established a classification system for all felony criminal offenses provided for in the Oklahoma Statutes that places the offenses into classes on the basis of the severity of the offense and other factors of the commission of the crime. All

1 felonies provided for by the Oklahoma Statutes shall be classified
2 in the following manner:

3 1. "Class Y" is reserved for the crime of murder in the first
4 degree as defined by Section 701.7 of Title 21 of the Oklahoma
5 Statutes; and

6 2. "Class A1", "Class A2", "Class A3", "Class B1", "Class B2",
7 "Class B3", "Class B4", "Class B5", "Class B6", "Class C1", "Class
8 C2", "Class D1", "Class D2", and "Class D3" are reserved for all
9 other violent and nonviolent felony offenses.

10 SECTION 2. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 20B of Title 21, unless there is
12 created a duplication in numbering, reads as follows:

13 Upon the effective date of this act, Class Y shall include the
14 following criminal offenses:

15 1. Murder in the first degree as provided for in subsection A
16 of Section 701.7 of Title 21 of the Oklahoma Statutes;

17 2. Murder in the first degree during the commission of a crime,
18 as provided for in subsection B of Section 701.7 of Title 21 of the
19 Oklahoma Statutes;

20 3. Murder in the first degree when the death of a child results
21 from willful or malicious injuring, torturing, maiming, or using
22 unreasonable force, as provided for in subsection C of Section 701.7
23 of Title 21 of the Oklahoma Statutes;

1 4. Murder in the first degree when the person solicits another
2 to cause the death of another human being in furtherance of
3 unlawfully manufacturing, distributing, or dispensing a controlled
4 dangerous substance, as provided for in subsection D of Section
5 701.7 of Title 21 of the Oklahoma Statutes;

6 5. Murder in the first degree when the person intentionally
7 causes the death of a law enforcement officer or a corrections
8 officer or employee, as provided for in subsection E of Section
9 701.7 of Title 21 of the Oklahoma Statutes; and

10 6. Murder in the first degree when a person kills another
11 person or causes the death of another human being in the commission
12 of an act of terrorism, as provided for in subsection C of Section
13 1268.2 of Title 21 of the Oklahoma Statutes.

14 SECTION 3. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 20C of Title 21, unless there is
16 created a duplication in numbering, reads as follows:

17 Upon the effective date of this act, Class A1 shall include the
18 following criminal offenses:

19 1. Domestic abuse committed against a pregnant woman with
20 knowledge of the pregnancy and a miscarriage occurs or injury to the
21 unborn child, as provided for in subsection E of Section 644 of
22 Title 21 of the Oklahoma Statutes;

23 2. Administering poison with intent to kill, as provided for in
24 Section 651 of Title 21 of the Oklahoma Statutes;

1 3. Second degree murder, as provided for in paragraph 1 of
2 Section 701.8 of Title 21 of the Oklahoma Statutes;

3 4. Second degree murder by a person engaged in the commission
4 of a felony, as provided for in paragraph 2 of Section 701.8 of
5 Title 21 of the Oklahoma Statutes;

6 5. Kidnapping for the purpose of extorting money, as provided
7 for in subsection A of Section 745 of Title 21 of the Oklahoma
8 Statutes;

9 6. Sexual abuse of a child under twelve (12) years of age, as
10 provided for in subsection F of Section 843.5 of Title 21 of the
11 Oklahoma Statutes;

12 7. Sexual exploitation of a child under twelve (12) years of
13 age, as provided for in subsection I of Section 843.5 of Title 21 of
14 the Oklahoma Statutes;

15 8. Sexual abuse of a child under fourteen (14) years of age
16 subsequent to a previous conviction of sexual abuse of a child under
17 fourteen (14) years of age, as provided for in subsection K of
18 Section 843.5 of Title 21 of the Oklahoma Statutes;

19 9. Soliciting or aiding a minor child to perform an obscene
20 act, as provided for in paragraph 1 of subsection B of Section 1021
21 of Title 21 of the Oklahoma Statutes;

22 10. Showing, exhibiting, loaning, or distributing to a minor
23 child obscene material or child pornography for purposes of inducing
24 the minor to participate in an obscene act, as provided for in
..

1 paragraph 2 of subsection B of Section 1021 of Title 21 of the
2 Oklahoma Statutes;

3 11. Murder, maiming, robbery, rape, or arson committed in the
4 course of a riot, as provided for in paragraph 1 of Section 1312 of
5 Title 21 of the Oklahoma Statutes;

6 12. Burglary by the aid or use of any explosive, as provided
7 for in Section 1441 of Title 21 of the Oklahoma Statutes;

8 13. Place, manufacture, possess, display, or threaten to use
9 any explosive or incendiary device and personal injury results, as
10 provided for in Section 1767.1 of Title 21 of the Oklahoma Statutes;

11 14. Aggravated manufacturing a controlled dangerous substance,
12 as provided for in paragraph 3 of subsection G of Section 2-401 of
13 Title 63 of the Oklahoma Statutes; and

14 15. Using any explosive or blasting agent to kill, injure, or
15 intimidate any person or to damage any real or personal property and
16 personal injury results, as provided for in subsection B of Section
17 124.8 of Title 63 of the Oklahoma Statutes.

18 SECTION 4. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 20D of Title 21, unless there is
20 created a duplication in numbering, reads as follows:

21 Upon the effective date of this act, Class A2 shall include the
22 following criminal offenses:

23 1. Accessory to murder in the first degree, as provided for in
24 paragraph 5 of Section 175 of Title 21 of the Oklahoma Statutes;

1 2. Aggravated assault and battery upon a police officer,
2 sheriff, deputy sheriff, highway patrolman, corrections personnel,
3 or any state peace officer that results in maiming, as provided for
4 in subsection B of Section 650 of Title 21 of the Oklahoma Statutes;

5 3. Solicitation for murder in the first degree, as provided for
6 in Section 701.16 of Title 21 of the Oklahoma Statutes;

7 4. Manslaughter in the first degree, as provided for in Section
8 711 of Title 21 of the Oklahoma Statutes;

9 5. Administration of a poison, drug, or medicine by an
10 intoxicated physician to another person that causes the death of
11 such other person, as provided for in Section 712 of Title 21 of the
12 Oklahoma Statutes;

13 6. Aiding, assisting, or participating in the receipt,
14 possession, or exchange of money or thing of value from the
15 kidnapped person, as provided for in subsection B of Section 745 of
16 Title 21 of the Oklahoma Statutes;

17 7. Human trafficking for labor or commercial sex, as provided
18 for in subsection C of Section 748 of Title 21 of the Oklahoma
19 Statutes;

20 8. Female genital mutilation, as provided for in Section 760 of
21 Title 21 of the Oklahoma Statutes;

22 9. Robbery in the first degree, as provided for in Section 798
23 of Title 21 of the Oklahoma Statutes;

1 10. Conjoint robbery committed by two or more persons, as
2 provided for in Section 800 of Title 21 of the Oklahoma Statutes;

3 11. Robbery or attempted robbery with a dangerous weapon or
4 imitation firearm, as provided for in Section 801 of Title 21 of the
5 Oklahoma Statutes;

6 12. Wiring or equipping vehicles or structures with explosive
7 materials, things, or devices with intent to cause bodily injury or
8 death to another person, as provided for in Section 849 of Title 21
9 of the Oklahoma Statutes;

10 13. Aggravated possession of child pornography, as provided for
11 in Section 1040.12a of Title 21 of the Oklahoma Statutes;

12 14. Rape by instrumentation, as provided for in Section 1111.1
13 of Title 21 of the Oklahoma Statutes;

14 15. Rape in the first degree, as provided for in subsection A
15 of Section 1114 of Title 21 of the Oklahoma Statutes;

16 16. Compelling a woman to marry another person against her will
17 by force, menace, or duress, as provided for in Section 1117 of
18 Title 21 of the Oklahoma Statutes;

19 17. Maliciously, wantonly, or negligently removing, injuring,
20 or destroying any railroad or railroad equipment that results in the
21 death of another human being, as provided for in Section 1752 of
22 Title 21 of the Oklahoma Statutes;

1 18. Resisting or aiding in resisting the execution of process
2 during a state of riot or insurrection, as provided for in Section
3 107 of Title 22 of the Oklahoma Statutes;

4 19. Driving under the influence of alcohol or other
5 intoxicating substance after a previous conviction of murder in the
6 second degree or manslaughter in the first degree where a death was
7 caused as a result of driving under the influence of alcohol or
8 other intoxicating substance, as provided for in paragraph 5 of
9 subsection C of Section 11-902 of Title 47 of the Oklahoma Statutes;

10 20. Manufacturing or attempting to manufacture any controlled
11 dangerous substance or the possession of certain substances, as
12 provided for in paragraph 2 of subsection G of Section 2-401 of
13 Title 63 of the Oklahoma Statutes; and

14 21. Robbery or attempted robbery of controlled dangerous
15 substances from a practitioner, manufacturer, distributor, or agent
16 thereof, as provided for in subsection B of Section 2-403 of Title
17 63 of the Oklahoma Statutes.

18 SECTION 5. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 20E of Title 21, unless there is
20 created a duplication in numbering, reads as follows:

21 Upon the effective date of this act, Class A3 shall include the
22 following criminal offenses:

4 2. Second or subsequent conviction of domestic abuse against a

6 subsection E of Section 644 of Title 21 of the Oklahoma Statutes;

7 3. Aggravated assault and battery upon a police officer,
8 sheriff, deputy sheriff, highway patrolman, corrections personnel,
9 or any state peace officer, as provided for in subsection A of
10 Section 650 of Title 21 of the Oklahoma Statutes;

11 4. Shooting with intent to kill, as provided for in subsection
12 A of Section 652 of Title 21 of the Oklahoma Statutes;

13 5. Using a vehicle to facilitate the intentional discharge of a
14 firearm, crossbow, or other weapon, as provided for in subsection B
15 of Section 652 of Title 21 of the Oklahoma Statutes;

16 6. Assault and battery with a deadly weapon, as provided for in
17 subsection C of Section 652 of Title 21 of the Oklahoma Statutes;

18 7. Maiming, as provided for in Section 751 of Title 21 of the
19 Oklahoma Statutes;

20 8. Sexual abuse by a caretaker, as provided for in paragraph 2
21 of subsection B of Section 843.1 of Title 21 of the Oklahoma
22 Statutes;

23 9. Child abuse, as provided for in subsection A of Section
24 843.5 of Title 21 of the Oklahoma Statutes;

1 10. Enabling child abuse, as provided for in subsection B of
2 Section 843.5 of Title 21 of the Oklahoma Statutes;

3 11. Child sexual abuse, as provided for in subsection E of
4 Section 843.5 of Title 21 of the Oklahoma Statutes;

5 12. Enabling child sexual abuse, as provided for in subsection
6 G of Section 843.5 of Title 21 of the Oklahoma Statutes;

7 13. Child sexual exploitation, as provided for in subsection H
8 of Section 843.5 of Title 21 of the Oklahoma Statutes;

9 14. Enabling child sexual exploitation, as provided for in
10 subsection J of Section 843.5 of Title 21 of the Oklahoma Statutes;

11 15. Lewd or indecent proposals or acts to a child, as provided
12 for in subsection A of Section 1123 of Title 21 of the Oklahoma
13 Statutes;

14 16. Terrorism, as provided for in subsection B of Section
15 1268.2 of Title 21 of the Oklahoma Statutes;

16 17. Conspiracy to commit terrorism, as provided for in
17 subsection A of Section 1268.3 of Title 21 of the Oklahoma Statutes;

18 18. Any person above the age of eighteen (18) who, on campuses
19 or public school grounds, advocates revolution, sabotage, force and
20 violation, sedition, treason, or the overthrow of the United States
21 government, as provided for in subsection B of Section 1327 of Title
22 21 of the Oklahoma Statutes;

23 19. Arson in the first degree, as provided for in subsection A
24 of Section 1401 of Title 21 of the Oklahoma Statutes;

--

1 20. Arson while manufacturing, attempting to manufacture, or
2 endeavoring to manufacture a controlled dangerous substance, as
3 provided for in subsection B of Section 1401 of Title 21 of the
4 Oklahoma Statutes; and

5 21. Causing personal injury while committing an act of arson,
6 as provided for in Section 1405 of Title 21 of the Oklahoma
7 Statutes.

8 SECTION 6. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 20F of Title 21, unless there is
10 created a duplication in numbering, reads as follows:

11 Upon the effective date of this act, Class B1 shall include the
12 following criminal offenses:

13 1. Accessory to murder in the second degree, as provided for in
14 paragraph 5 of Section 175 of Title 21 of the Oklahoma Statutes;

15 2. Rescuing or attempting to rescue a prisoner charged or
16 convicted of a felony, as provided for in paragraph 1 of Section 521
17 of Title 21 of the Oklahoma Statutes;

18 3. Aiding suicide, as provided for in Section 813 of Title 21
19 of the Oklahoma Statutes;

20 4. Aiding suicide by furnishing the person with deadly weapons
21 or poisonous drugs, as provided for in Section 814 of Title 21 of
22 the Oklahoma Statutes;

23 5. Mingling poison, controlled dangerous substances, or sharp
24 objects harmful to human life with any food, drink, medicine, or
--

1 water, as provided for in Section 832 of Title 21 of the Oklahoma
2 Statutes;

3 6. Abuse, financial neglect, neglect, or exploitation by a
4 caretaker, as provided for in paragraph 1 of subsection B of Section
5 843.1 of Title 21 of the Oklahoma Statutes;

6 7. Exploitation of an elderly person or disabled adult, as
7 provided for in Section 843.4 of Title 21 of the Oklahoma Statutes;

8 8. Engaging in child neglect, as provided for in subsection C
9 of Section 843.5 of Title 21 of the Oklahoma Statutes;

10 9. Enabling child neglect, as provided for in subsection D of
11 Section 843.5 of Title 21 of the Oklahoma Statutes;

12 10. Forcible sodomy, as provided for in subsection A of Section
13 888 of Title 21 of the Oklahoma Statutes;

14 11. Sodomy by a person over eighteen (18) years of age upon a
15 person under sixteen (16) years of age, as provided for in paragraph
16 1 of subsection B of Section 888 of Title 21 of the Oklahoma
17 Statutes;

18 12. Sodomy upon a person incapable through mental illness or
19 unsoundness of mind to give legal consent, as provided for in
20 paragraph 2 of subsection B of Section 888 of Title 21 of the
21 Oklahoma Statutes;

22 13. Sodomy with any person by means of force, violence, or
23 threats of force or violence, as provided for in paragraph 3 of
24 subsection B of Section 888 of Title 21 of the Oklahoma Statutes;

1 14. Sodomy upon a person under the legal custody, supervision,
2 or authority of a state agency, county, municipality, or political
3 subdivision of the state, as provided for in paragraph 4 of
4 subsection B of Section 888 of Title 21 of the Oklahoma Statutes;

5 15. Sodomy upon a person at least sixteen (16) years of age but
6 less than twenty (20) years of age and who is a student of any
7 public or private secondary school, junior high, high school, or
8 public vocational school with a person eighteen (18) years of age or
9 older and who is employed by the same school system, as provided for
10 in paragraph 5 of subsection B of Section 888 of Title 21 of the
11 Oklahoma Statutes;

12 16. Sodomy upon a person who is unconscious, as provided for in
13 paragraph 7 of subsection B of Section 888 of Title 21 of the
14 Oklahoma Statutes;

15 17. Sodomy upon a person who is intoxicated by a narcotic or
16 anesthetic agent administered by or with the privity of the accused,
17 as provided for in paragraph 8 of subsection B of Section 888 of
18 Title 21 of the Oklahoma Statutes;

19 18. Procuring or causing the participation of a minor in child
20 pornography or possessing, procuring, manufacturing, selling, or
21 distributing child pornography, as provided for in Section 1021.2 of
22 Title 21 of the Oklahoma Statutes;

24 child pornography by a parent, guardian, or individual having

11 prostitution, as provided for in paragraph 3 of subsection A of
12 Section 1087 of Title 21 of the Oklahoma Statutes;

13 24. Permitting the prostitution of a child in any house,
14 building, room, other premises, or any conveyances under the control
15 of a person, as provided for in paragraph 2 of subsection B of
16 Section 1087 of Title 21 of the Oklahoma Statutes;

17 25. Causing, inducing, persuading, or encouraging a child by
18 promise, threats, violence, or any device or scheme to engage in
19 prostitution, as provided for in paragraph 1 of subsection A of
20 Section 1088 of Title 21 of the Oklahoma Statutes;

21 26. Keeping, holding, detaining, restraining, or compelling a
22 child to engage in prostitution, as provided for in paragraph 2 of
23 subsection A of Section 1088 of Title 21 of the Oklahoma Statutes;

1 27. Keeping, holding, detaining, restraining, or compelling a
2 child to engage in prostitution for purposes of compelling the child
3 to pay, liquidate, or cancel any debts, dues, or obligations
4 incurred by the child, as provided for in paragraph 3 of subsection
5 A of Section 1088 of Title 21 of the Oklahoma Statutes;

6 28. Permitting the keeping, holding, detaining, or restraining
7 of a child for prostitution in any house, building, room, other
8 premises, or any conveyances under the control of a person, as
9 provided for in paragraph 2 of subsection B of Section 1088 of Title
10 21 of the Oklahoma Statutes;

11 29. Advocating the revolution, sabotage, force and violation,
12 sedition, treason, or overthrow of the government of the United
13 States, as provided for in Section 1266 of Title 21 of the Oklahoma
14 Statutes;

15 30. Commit, attempt to commit, or aid in the commission of any
16 act intended to overthrow, destroy, or alter the government of the
17 United States, as provided for in Section 1266.4 of Title 21 of the
18 Oklahoma Statutes;

19 31. Biochemical terrorism, as provided for in subsection D of
20 Section 1268.2 of Title 21 of the Oklahoma Statutes;

21 32. Biochemical assault when the person knows the substance is
22 toxic, noxious, or lethal to humans, as provided for in subsection C
23 of Section 1268.5 of Title 21 of the Oklahoma Statutes;

1 33. Second or subsequent conviction of using a firearm while
2 committing a felony, as provided for in subsection A of Section 1287
3 of Title 21 of the Oklahoma Statutes;

4 34. Discharging a firearm or other deadly weapon at or into a
5 dwelling or building used for public or business purposes, as
6 provided for in Section 1289.17A of Title 21 of the Oklahoma
7 Statutes;

8 35. Directing, advising, encouraging, or soliciting other
9 persons to commit acts of force or violence while participating in a
10 riot, as provided for in paragraph 4 of Section 1312 of Title 21 of
11 the Oklahoma Statutes;

12 36. Burglary in the first degree, as provided for in Section
13 1431 of Title 21 of the Oklahoma Statutes;

14 37. Seizing or exercising control of any bus by force or
15 violence or by threats of force or violence, as provided for in
16 subsection A of Section 1903 of Title 21 of the Oklahoma Statutes;

17 38. Using a dangerous or deadly weapon while seizing or
18 exercising control of a bus or when intimidating, threatening,
19 assaulting, or battering a bus driver, as provided for in subsection
20 C of Section 1903 of Title 21 of the Oklahoma Statutes;

21 39. Receiving, acquiring, and concealing proceeds derived from
22 unlawful activities in an amount of more than Fifty Thousand Dollars
23 (\$50,000.00), as provided for in paragraph 4 of subsection G of
24 Section 2001 of Title 21 of the Oklahoma Statutes;

1 40. Participating in racketeering activities, as provided for
2 in subsection A of Section 1403 of Title 22 of the Oklahoma
3 Statutes;

4 41. Acquiring or maintaining any interest in or control of any
5 enterprise or real property through racketeering activities, as
6 provided for in subsection B of Section 1403 of Title 22 of the
7 Oklahoma Statutes;

8 42. Using or investing any part of proceeds derived from
9 racketeering activities, as provided for in subsection C of Section
10 1403 of Title 22 of the Oklahoma Statutes;

11 43. Conspiring with others to conduct or participate in
12 unlawful racketeering activities, as provided for in subsection D of
13 Section 1403 of Title 22 of the Oklahoma Statutes;

14 44. Causing an accident resulting in great bodily injury while
15 driving under the influence of alcohol or other intoxicating
16 substance, as provided for in paragraph 1 of subsection B of Section
17 11-904 of Title 47 of the Oklahoma Statutes; and

18 45. Trafficking in fentanyl or carfentanil, or any fentanyl
19 analogs or derivatives, as provided for in subparagraph a of
20 paragraph 12 of subsection C of Section 2-415 of Title 63 of the
21 Oklahoma Statutes.

22 SECTION 7. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 20G of Title 21, unless there is
24 created a duplication in numbering, reads as follows:

3 1. Transport, move, or attempt to transport in this state any
4 alien knowing that the alien has entered the United States in
5 violation of law, as provided for in subsection A of Section 446 of

7 2. Conceal, harbor, or shelter from detection any alien in any
8 place within this state knowing that the alien has entered the
9 United States in violation of law, as provided for in subsection B
10 of Section 446 of Title 21 of the Oklahoma Statutes;

11 3. Intentionally destroy, hide, alter, abscond with, or keep
12 certain identification documentation of an individual for the
13 purpose of trafficking the individual, as provided for in subsection
14 C of Section 446 of Title 21 of the Oklahoma Statutes;

15 4. Allowing any person lawfully held in custody to escape or go
16 at large by a sheriff, coroner, clerk of a court, constable, or
17 other ministerial officer and any deputy, as provided for in Section
18 532 of Title 21 of the Oklahoma Statutes;

19 5. Kidnapping, as provided for in Section 741 of Title 21 of
20 the Oklahoma Statutes;

21 6. Causing, aiding, abetting, or encouraging a minor child to
22 distribute, dispense, possess, or manufacture a controlled dangerous
23 substance or a counterfeit or imitation controlled dangerous
24

1 substance, as provided for in Section 856.1 of Title 21 of the
2 Oklahoma Statutes;

3 7. Trafficking in children, as provided for in Section 866 of
4 Title 21 of the Oklahoma Statutes;

5 8. Photographing, publishing, distributing, or participating in
6 the preparation of child pornography, as provided for in subsection
7 C of Section 1040.8 of Title 21 of the Oklahoma Statutes;

8 9. Procuring another for the purpose of prostitution, as
9 provided for in Section 1081 of Title 21 of the Oklahoma Statutes;

10 10. Keeping, holding, detaining, or restraining against her
11 will a female in a house of prostitution, as provided for in Section
12 1085 of Title 21 of the Oklahoma Statutes;

15 Section 1623 of Title 21 of the Oklahoma Statutes;

16 17. Total or partial erasure or obliteration of any instrument
17 or writing with intent to defraud, as provided for in Section 1624
18 of Title 21 of the Oklahoma Statutes;

19 18. Signing fictitious name as an officer or agent of a
20 corporation, as provided for in Section 1626 of Title 21 of the
21 Oklahoma Statutes;

22 19. Procuring, soliciting, selling, or receiving more than ten
23 telephone records by fraudulent, deceptive, or false means, as
24

1 provided for in paragraph 3 of subsection B of Section 1742.2 of
2 Title 21 of the Oklahoma Statutes;

3 20. Violating the Viatical Settlements Act of 2008, as provided
4 for in paragraph 1 of subsection F of Section 4055.14 of Title 36 of
5 the Oklahoma Statutes;

6 21. Third or subsequent conviction of driving under the
7 influence of alcohol or other intoxicating substance, as provided
8 for in paragraph 4 of subsection C of Section 11-902 of Title 47 of
9 the Oklahoma Statutes;

10 22. Driving under the influence with a blood or breath alcohol
11 concentration of fifteen-hundredths (0.15) or more, as provided for
12 in subsection D of Section 11-902 of Title 47 of the Oklahoma
13 Statutes;

14 23. Injuring, destroying, or attempting to injure or destroy
15 any hazardous liquid transportation system, as provided for in
16 Section 47.6 of Title 52 of the Oklahoma Statutes;

18 jail, state penal institution, or other place where prisoners are
19 located, any gun, knife, bomb, other dangerous instrument,
20 controlled dangerous substance, alcoholic beverage, money, or

23 25. Purchasing or attempting to purchase, receive, or otherwise
24 acquire any product, mixture, or preparation containing any

2 conviction of manufacturing or attempting to manufacture
3 methamphetamine, as provided for in paragraph 5 of subsection G of
4 Section 2-401 of Title 63 of the Oklahoma Statutes;

5 26. Distributing, other than by dispensing, a Schedule I or
6 Schedule II controlled dangerous substance, in the course of
7 legitimate business, as provided for in paragraph 1 of subsection A

9 27. Using a fictitious, revoked, suspended, or fraudulent
10 registration number in the course of manufacturing or distributing a
