6	AS INTRODUCED
7	An Act relating to civil procedure; amending 12 O.S.
8	2021, Section 3252, which relates to requests for issuance of subpoenas; providing for payment of
9	applicable fee; requiring assignment of certain number; requiring entry on docket; amending 28 O.S.
10	2021, Section 152.1, which relates to fees in civil actions; prescribing fee for issuance of foreign
11	subpoena; and providing an effective date.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 12 O.S. 2021, Section 3252, is
16	amended to read as follows:
17	Section 3252. A. To request issuance of a subpoena under this
18	section, a party must submit a foreign subpoena to a clerk of court
19	in the county in which discovery is sought to be conducted in this
20	state and pay any applicable fee as prescribed by law. A request
21	for the issuance of a subpoena under this act does not constitute an
22	appearance in the courts of this state.

1	B. When a party submits a foreign subpoena to a clerk of court
2	in this state, the clerk, in accordance with that court's procedure,
3	shall <del>promptly</del> :
4	1. Promptly issue a subpoena for service upon the person to
5	which the foreign subpoena is directed; and
6	2. Assign the subpoena a case file number and enter it on the
7	docket as a civil action for foreign subpoena.
8	C. A subpoena under subsection B of this section must:
9	1. Incorporate the terms used in the foreign subpoena; and
10	2. Contain or be accompanied by the names, addresses and
11	telephone numbers of all counsel of record in the proceeding to
12	which the subpoena relates and of any party not represented by
13	counsel.
14	SECTION 2. AMENDATORY 28 O.S. 2021, Section 152.1, is
15	amended to read as follows:
16	Section 152.1 A. In civil cases, the court clerk shall collect
17	and deposit in the court fund the following charges in addition to
18	the flat fee:
19	1. For posting notices and filing
20	certificates required by statute\$30.00
21	2. For the filing of any counterclaim or
22	setoff pursuant to Section 1758 of
23	Title 12 of the Oklahoma Statutes\$20.00

1	3. For mailing by any type of mail writs,
2	warrants, orders, process, command, or
3	notice for each person\$10.00
4	4. For the actual cost of all postage in
5	each case in excess of\$10.00
6	5. For serving or endeavoring to serve each
7	writ, warrant, order, process,
8	command, or notice for each person in
9	one or more counties\$50.00
10	provided that if more than one person is
11	served at the same address, one flat fee
12	of Fifty Dollars (\$50.00) may be charged
13	6. For sheriff's fees on court-ordered
14	sales of real or personal property\$75.00
15	7. When a jury is requested\$349.00
16	8. For issuing each summons for each person\$10.00
17	9. For services of a court reporter at each
18	trial held in the case\$20.00
19	10. For filing a motion for summary
20	judgment or summary disposition of
21	issue(s)\$50.00
22	11. For issuance of a foreign subpoena\$50.00
23	The fees prescribed in paragraphs 5 and 6 of this subsection
24	shall be paid by the court clerk into the Sheriff's Service Fee

Account, created pursuant to the provisions of Section 514.1 of Title 19 of the Oklahoma Statutes, of the sheriff in the county where service is made or attempted or where the sheriff's sale occurs. All other fees shall be deposited into the local court fund in the county where collected. The fee prescribed in paragraph 7 of subsection A of this В. section shall be paid at the time of the pretrial conference by the party requesting a jury. SECTION 3.
