6 AS INTRODUCED

7 An Act relating to schools; prohibiting use of state  
8 funds for private extracurricular lessons; defining  
9 terms; requiring the promulgation of rules;  
10 prohibiting bonus payments for recruitment of  
11 teachers and students away from public, charter or  
12 virtual charter schools; requiring the promulgation  
13 of rules; providing for codification; providing an  
14 effective date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 5-191 of Title 70, unless there  
18 is created a duplication in numbering, reads as follows:

19 A. A public school district, a charter school sponsored as  
20 provided for in Section 3-132 of Title 70 of the Oklahoma Statutes  
21 and a virtual charter school sponsored by the Statewide Virtual  
22 Charter School Board pursuant to Section 3-145.3 of Title 70 of the  
23 Oklahoma Statutes shall be prohibited from using State Aid  
24 allocation or any other state-appropriated revenue to contract with

1 an individual business or entity to provide private extracurricular  
2 lessons to students.

3 B. For the purposes of this section, "private extracurricular  
4 lessons" shall include, but not be limited to:

- 5 1. Gymnastics lessons;
- 6 2. Music lessons; and
- 7 3. Athletic performance lessons.

8 C. The provisions of this section shall not apply to teachers  
9 contracted by a public school district pursuant to Section 6-101 of  
10 Title 70 of the Oklahoma Statutes or teachers or other personnel  
11 contracted by a virtual charter school or a charter school pursuant  
12 to Section 3-135 of Title 70 of the Oklahoma Statutes.

13 D. The State Board of Education and the Statewide Virtual  
14 Charter School Board shall promulgate rules necessary to implement  
15 the provisions of this section.

16 SECTION 2. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 1-125 of Title 70, unless there  
18 is created a duplication in numbering, reads as follows:

19 A. A public school district, a charter school sponsored as  
20 provided for in Section 3-132 of Title 70 of the Oklahoma Statutes  
21 and a virtual charter school sponsored by the Statewide Virtual  
22 Charter School Board pursuant to Section 3-145.3 of Title 70 of the  
23 Oklahoma Statutes shall be prohibited from providing bonus payments  
24 to teachers or other personnel for recruiting teachers or students

1 from another public school, charter school or virtual charter  
2 school.

3 B. The State Board of Education and the Statewide Virtual  
4 Charter School Board shall promulgate rules necessary to implement  
5 the provisions of this section.

6 SECTION 3. This act shall become effective July 1, 2020.

7 SECTION 4. It being immediately necessary for the preservation  
8 of the public peace, health or safety, an emergency is hereby  
9 declared to exist, by reason whereof this act shall take effect and  
10 be in full force from and after its passage and approval.
