14	SECTION 1. AMENDATORY 26 O.S. 2011, Section 4-102, is

16	Section 4-102. A. No person shall be permitted to vote in any						
17	election conducted by any county election board unless such person						
18	is a registered voter, unless otherwise provided by law.						
19	B. Effective December 31, 2023, to be eligible to vote in any						
20	state or federal election, all eligible voters shall be required to						
21	reregister to vote and provide the following information to the						
22	appropriate county election board:						
23	1. Proof of United States citizenship;						
24	2. Proof of current residence; and

- 3 C. Any voter failing to reregister pursuant to subsection B of

- 5 Voter Registration Act of 1993, shall be placed on a Federal
- 6 Election Only list, and shall not be eligible to vote in any state
- 7 election.
- D. As used in this section, "proof of United States 8
- 9 citizenship" shall mean one of the following documents:
- 10 1. An original birth document issued by a state, the
- 11 Commonwealth of Puerto Rico, or the District of Columbia, or a
- 12 certified copy thereof;
- 1.3 2. An original birth certificate issued by the federal
- 14 government, or a certified copy thereof;
- 15 3. An original United States Certificate of Birth Abroad;
- 16 4. An original Report of Birth Abroad of a Citizen of the
- 17 United States;
- 18 5. An original Certificate of Citizenship (Form N-560 or N-
- 19 561); or
- 20 6. An original Certificate of Naturalization (Form N-550, N-570
- 21 or N-578) or a valid United States passport.
- 22 Copies of these documents shall be made by the appropriate county
- 23 election board and kept available for public inspection pursuant to

24 the Oklahoma Open Records Act.
