19	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
20	SECTION 1. AMENDATORY 59 O.S. 2011, Section 396.27, is
21	amended to read as follows:
22	Section 396.27 <u>A.</u> In handling and preparing dead human remains
23	for final disposition, any person who comes in direct contact with
24	an unembalmed dead human body or who enters a room where dead human

bodies are being embalmed shall exercise all reasonable precautions to minimize the risk of transmitting any communicable disease from the body in accordance with federal regulations regarding the control of infectious diseases and occupational and workplace health and safety.

B. Each funeral director shall notify employees concerning risk
exposures pursuant to Section 1-502.3 of Title 63 of the Oklahoma
Statutes and the rules and guidelines promulgated by the State Board
of Health.

10 <u>C. If a funeral director or embalmer has been notified that a</u> 11 <u>deceased person has tested positive for human immunodeficiency virus</u> 12 <u>(HIV), MRSA, hepatitis or any other communicable disease the funeral</u> 13 <u>director or embalmer shall notify any person who may be transporting</u> 14 <u>the body or preparing the body for burial or other disposition of</u> 15 <u>the positive test.</u>

16SECTION 2.AMENDATORY63 O.S. 2011, Section 1-502.3, is17amended to read as follows:

Section 1-502.3 A. No person who withdraws or tests blood for human immunodeficiency virus (HIV), methicillin-resistant

20 staphylococcus aureus (MRSA), hepatitis or any other communicable

21 disease or employer of such person nor or any hospital or health

- 22 care facility where blood is withdrawn or tested for human
- 23 immunodeficiency virus HIV, MRSA, hepatitis or any other
- 24 communicable disease shall incur any civil or criminal liability as

a result of the proper withdrawal of blood or testing for human
 immunodeficiency virus <u>HIV, MRSA, hepatitis or any other</u>
 <u>communicable disease</u> when acting in compliance with the provisions
 of this section. The withdrawal or testing shall be performed in a

5 reasonable manner, according to generally accepted <u>standards of</u> 6 clinical practice. The person, employer or facility shall be 7 presented with:

8 1. A written statement by the person whose blood is to be9 withdrawn and tested; or

10 2. A written statement from a health care or emergency care 11 worker verifying that the health care or emergency care worker in an 12 occupational setting has been exposed to the bodily fluids of the 13 person whose blood is to be withdrawn and tested, which exposure 14 placed the health care or emergency care worker at risk for transfer 15 of the bodily fluids; or

16 3. An order from a court of competent jurisdiction that blood17 be withdrawn and tested.

When presented with such a statement or court order, the person authorized to withdraw the blood, the employer and the hospital or other health care facility where the withdrawal or testing occurs may rely on such statement or order as evidence that the person has consented to or has been required to submit to the clinical procedure and shall not be required to obtain any additional consent, acknowledgement or waiver form. In such case, the person

1 authorized to perform the procedure, the employer of such person, and the hospital or other health care facility shall not be liable 2 in any action alleging lack of consent or lack of informed consent. 3 4 B. No person specified in this section shall incur any civil or 5 criminal liability for: 1. Providing results of the testing to: 6 7 the person whose blood was tested, a. b. the person incurring the exposure, or 8 9 с. the funeral director or embalmer who will be or is 10 preparing the body of a person who has been tested 11 pursuant to this section for burial or other 12 disposition, or 13 the State Department of Health or such agency it may d. 14 designate; 15 2. Not providing the results of the testing to any other 16 person; or 17 3. Failing to diagnose or falsely diagnosing the presence of 18 the human immunodeficiency virus HIV, MRSA, hepatitis or any other 19 communicable disease where the procedure was performed in a 20 reasonable manner according to generally accepted standards of 21 clinical practice. 22 C. For the purposes of this section: 23 "Bodily fluids" means fluids which have been medically 1. 24 proven and medically accepted as transmitters or conductors of human 1 immunodeficiency virus HIV, MRSA, hepatitis or any other

2 communicable disease; and

3 2. "Health care worker" or "emergency care worker" means one of
4 the persons specified in subsection A of Section 1-502.1 of this
5 title.

6 SECTION 3. AMENDATORY 63 O.S. 2011, Section 1-523, is 7 amended to read as follows:

8 Section 1-523. A. 1. Any and all institutions in this state, 9 whether penal or eleemosynary, public or private, and free or for 10 pay, shall make, and preserve for a period of at least one (1) year, 11 a record showing the name, age, sex, race, nationality and place of 12 residence of any <u>infected</u> inmate <u>infected with a communicable</u> 13 disease of such institution who may come to their knowledge.

14 2. The institution shall make available such record at all 15 reasonable hours for inspection by the State Commissioner of Health 16 or the local health officer.

3. Such institutions shall further furnish a physician and all
proper medicines, instruments and apparatus for the proper treatment
of such infected inmate.

B. Each institution and each Department of Corrections district
office, and each county or municipal jail shall notify their
correctional officers, probation and parole officers, and any
jailor, or other employee or any employee of the Pardon and Parole
Board, who has or will have direct contact with an inmate, when such

1 inmate is infected with the human immunodeficiency virus (HIV) or 2 has the, Acquired Immune Deficiency Syndrome (AIDS), methicillin-3 resistant staphylococcus aureus (MRSA), hepatitis or any other 4 communicable disease.

5 C. 1. If an officer or employee of the State of Oklahoma, or any other person comes into contact with the bodily fluids of an 6 7 inmate in a state correctional facility, the Director of the Department of Corrections or designee, under such rules as the 8 9 Director shall promulgate to carry out the provisions of this 10 section, shall cause such inmate to be tested for such disease, if 11 no prior record of the existence of such disease exists. If an 12 officer or employee of a county jail, or any other person, comes 13 into contact with the bodily fluids of an inmate in a county jail, 14 the sheriff or designee, under policies the sheriff shall promulgate 15 to carry out the provisions of this section, shall cause the inmate 16 to be tested for such disease, if no prior record of the existence 17 of such disease exists.

2. The Director or designee shall promptly communicate in writing the results of the test to the person so exposed and refer the employee to the Department of Correction's Employee Assistance Program for appropriate referrals for counseling, health care, and support services for the person so exposed. If the exposure occurs within a county jail, the sheriff or designee shall promptly communicate in writing the results of the test to the person so

1 exposed and refer the employee to the employee assistance program of 2 the county for appropriate referrals for counseling, health care, 3 and support services for the person so exposed.

3. As used in this section, the term "serious transmissible 4 5 disease" means the human immunodeficiency virus (HIV) and, MRSA, hepatitis or any other communicable disease. 6

7 D. In the event a person who has tested positive for a serious transmissible disease dies, each institution in this state, whether 8 9 penal or eleemosynary, and whether public or private, shall notify 10 the funeral director or embalmer who will be preparing the body for 11 burial or other disposition by written notice as to the positive 12 test upon first call, as defined in Section 396.2 of Title 59 of the 13 Oklahoma Statutes.

14 63 O.S. 2011, Section 1-525, is SECTION 4. AMENDATORY 15 amended to read as follows:

16 Section 1-525. A. 1. Except as otherwise provided by law, the 17 prescription and records required by the foregoing provisions 18 Sections 1-522 and 1-523 of this title to be filed and kept 19 maintained shall not be exposed released to or opened by any person 20 other than the State Commissioner of Health or local health officer, 21 or in the event a person has tested positive for human 22

immunodeficiency virus (HIV), methicillin-resistant staphylococcus

23 aureus (MRSA), hepatitis or any other communicable disease to the

24 funeral director or embalmer who will be or is preparing the body 1 <u>for burial or other disposition</u>, or when properly ordered by a court 2 of competent jurisdiction to be used as evidence in such court, and 3 no.

4 <u>2. No</u> information whatever shall be given to any person
5 concerning any infected person except to appropriate persons for use
6 in the proper courts of this state authorized pursuant to Sections
7 <u>1-502.1 and 1-523 of this title to receive such information</u>.

8 Provided, that records <u>3. Records</u> of diagnosis and treatment 9 may be transmitted to physicians and to health authorities in this 10 and other states upon written request of the person affected.

<u>B. 1. Results</u> of examinations conducted on persons arrested by lawful warrant for the offense of first or second degree rape, forcible sodomy, or intentional infection or attempted infection of a person with the human immunodeficiency virus, shall be provided to the alleged victim of the crime upon the request of the victim, the parent of the victim if the victim is a minor, or upon request of the legal guardian or custodian of the victim.

19 <u>2.</u> The name of the arrested and examined person shall not be
 20 disclosed on the transmitted record. The State Department of Health
 21 shall provide to the victims the positive test results.

22 <u>3.</u> The Department shall provide free testing to the alleged 23 victim for any sexually transmitted infection (STI) or communicable 24

1 disease for which the arrestee tests positive, as indicated in the 2 transmitted record of diagnosis.

3 4. Such testing shall be accompanied with pretest and post-test 4 posttest counseling. Such counseling shall include the provision of 5 information to the victim or the parent, legal guardian or custodian of the victim concerning the venereal STI or communicable disease 6 7 indicated in the transmitted record and the location of public and private facilities in the vicinity offering tests and counseling for 8 9 persons who have the sexually transmitted infection (STI) or 10 communicable disease.

B. C. The State Board of Health shall promulgate rules and regulations for the examination authorized or required by Section 1-524 of this title and for the release of records containing results of examinations authorized by subsection subsections A and B of this section. The rules and regulations shall establish procedural guidelines which respect the rights of the person arrested for the alleged offense and the victim of the alleged offense.

SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 502.4 of Title 63, unless there is created a duplication in numbering, reads as follows:

Any hospital, physician or other person who is responsible for the release of the body of a person who has tested positive for human immunodeficiency virus (HIV), methicillin-resistant staphylococcus aureus (MRSA), hepatitis or any other communicable

1	disease to a funeral director or embalmer who will be preparing the
2	body for burial or other disposition shall notify, in writing, the
3	funeral director or embalmer of the positive test upon first call,
4	as the term is defined by the Funeral Services Licensing Act.
5	SECTION 6. This act shall become effective November 1, 2020.
