7 An Act relating to schools; amending 70 O.S. 2021,
8 Section 1-124, which relates to per-pupil
9 expenditure; requiring certain inclusion in certain
10 calculation; and providing an effective date.

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 70 O.S. 2021, Section 1-124, is
13 amended to read as follows:

14 Section 1-124. A. Unless otherwise specifically defined, "per-
15 pupil expenditure" shall mean the aggregate current expenditures of
16 school districts, from all funding sources including federal funds,
17 state funds and local funds, plus the direct support aggregate
18 current expenditures of the state for the day-to-day operations of
19 schools and school districts from all funding sources including
20 federal funds, divided by the aggregate student membership number
21 for the same fiscal year for which the expenditures are determined.
22 The aggregate student membership number shall be the count of
23 students enrolled on October 1 or the school day closest to October
24 1 to whom school districts in the state provide a public education.

1 The aggregate current expenditures shall include without limitation
2 the following categories of expenditures:

- 3 1. Instruction;
- 4 2. Support services for students;
- 5 3. Support services for instructional staff;
- 6 4. Support services for general administration;
- 7 5. Support services for school administration;
- 8 6. Support services for business;
- 9 7. Operation and maintenance of plant services;
- 10 8. Student transportation services;
- 11 9. Child nutrition services; ~~and~~
- 12 10. Enterprise services; and
- 13 11. Concurrent enrollment services provided pursuant to Section
14 628.13 of this title funded annually through legislative
15 appropriations.

16 B. Aggregate current expenditures shall not include
17 expenditures for adult and community education, facilities
18 acquisition and construction services, debt services, property and
19 other expenditures not related to the day-to-day operations.

20 C. The provisions of subsection A of this section shall apply
21 when related to the expenditure of public funds by educational and
22 governmental entities. When reporting or publishing the per-pupil
23 expenditure for any purpose, the State Department of Education shall

1 also report or publish each category of expenditure as listed in
2 subsection A of this section as well as the aggregate expenditure.

3 SECTION 2. This act shall become effective November 1, 2022.
