L7	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
L8	SECTION 1. From the funds appropriated to the Oklahoma
L 9	Historical Society in Enrolled Senate Bill No. 1922 of the 2nd
20	Session of the 57th Oklahoma Legislature, not less than Four Hundred
21	Ten Thousand Dollars (\$410,000.00) shall be used to offset revenue
22	losses among the museums.
23	SECTION 2. Appropriations made to the Oklahoma Historical
24	Society by Enrolled Senate Bill No. 1922 of the 2nd Session of the

1 57th Oklahoma Legislature, not including appropriations made for 2 capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21) or may be budgeted for the fiscal 3 4 year ending June 30, 2022 (hereafter FY-22). Funds budgeted for FY-5 21 may be encumbered only through June 30, 2021, and must be expended by November 15, 2021. Any funds remaining after November 6 7 15, 2021, and not budgeted for FY-22, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted 8 for FY-22 may be encumbered only through June 30, 2022. Any funds 10 remaining after November 15, 2022, shall lapse to the credit of the 11 proper fund for the then current fiscal year. These appropriations 12 may not be budgeted in both fiscal years simultaneously. Funds 13 budgeted in FY-21, and not required to pay obligations for that 14 fiscal year, may be budgeted for FY-22, after the agency to which 15 the funds have been appropriated has prepared and submitted a budget 16 work program revision removing these funds from the FY-21 budget 17 work program and after such revision has been approved by the Office 18 of Management and Enterprise Services.
