11	A Concurrent Resolution relating to expenditure of
12	federal funds; making findings; and expressing legislative intent.

15	WHEREAS, Congress passed three tranches of Elementary and
16	Secondary School Emergency Relief (ESSER) Funds for schools in the
17	Coronavirus Aid, Relief, and Economic Security Act (CARES) as well
18	as the American Rescue Plan Act (ARPA) totaling Two Billion Three
19	Hundred Nineteen Million Five Hundred Seventy One Thousand Seven
20	Hundred Ninety Nine Dollars (\$2,319,571,799.00); and
21	WHEREAS, Oklahoma passed and signed into law Enrolled House Bill
22	No. 2932 stating unless expressly authorized by the Legislature, no
23	agency, board, commission, department, council, instrumentality, or
24	other entity organized within the executive branch of state

1 government shall utilize the federal funds from the Coronavirus Aid,
2 Relief, and Economic Security Act (CARES) in a manner that will or
3 likely will lead to increased demand for state-appropriated funds or
4 any other state funds; and

5 WHEREAS, Oklahoma schools received each of their ESSER
6 allocations outside of the recurring state and federal
7 appropriations process.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
OF THE 2ND EXTRAORDINARY SESSION OF THE 58TH OKLAHOMA LEGISLATURE,
THE SENATE CONCURRING THEREIN:

11 THAT the Oklahoma Legislature strongly encourages local school 12 districts to exercise extreme caution before expending one-time 13 ESSER funds on any recurring expense.

14 THAT the Oklahoma Legislature affirms its commitment to Enrolled 15 House Bill No. 2932 in not approving projects that will incur 16 recurring expenses on future legislatures with funding received from 17 the ARPA as well as the CARES Act.

18 THAT school districts, agency, boards, commissions, departments, 19 councils, instrumentalities, or other entities organized within the 20 executive branch of state government should look to Enrolled House 21 Bill No. 2932 as a guiding principle for one-time funds received 22 from ARPA as well as the CARES Act.
