1	Taiwan's meaningful participation as an observer in the
2	International Civil Aviation Organization (ICAO), will contribute to
3	its prosperity, and to the synergies created by the close and
4	dynamic partnership between Taiwan and the United States; and
5	WHEREAS, the State of Oklahoma and Taiwan initiated a Sister-
6	State Agreement on July 25, 1980, have enjoyed the benefits of the
7	bonds of friendship and goodwill since that time, and now prepare to
8	celebrate their thirty-fifth anniversary in 2015; and
9	WHEREAS, the United States ranks as Taiwan's second largest
10	trading partner and Taiwan is the tenth largest trading partner of
11	the United States. Bilateral trade in goods and services between
12	the United States and Taiwan reached \$67.4 billion in 2014.
13	NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
14	OF THE 1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE, THE SENATE
15	CONCURRING THEREIN:
16	THAT the Oklahoma State Legislature hereby celebrates the
17	thirty-fifth anniversary of the Sister-State relationship between
18	the State of Oklahoma and Taiwan and expresses its steadfast support
19	for Taiwan's growing role in the international community.
20	THAT the Oklahoma State Legislature hereby recognizes the mutual
21	benefit to business and travel created by the May 2014 mutual
22	agreement between the Oklahoma Department of Public Safety and the
23	Republic of China (Taiwan) through the Ministry of Transportation
24	and Communications on the Reciprocal Issuance of Driver Licenses.

1	THAT the Oklahoma State Legislature hereby commends Taiwan,
2	under the leadership of President Ma Ying-jeou, for its East China
3	Sea Peace Initiative, which promotes peace and stability by
4	providing political and economic cooperation and common ground for
5	all parties and brings economic vitality to a troubled zone.
6	THAT an official copy of this resolution be distributed to the
7	Honorable Louis Min-Jing Huang, Director General of the Taipei
8	Economic and Cultural Office in Houston, as an expression of the
9	sentiment of the Oklahoma State Legislature.
