| 12 | binds all Oklahomans to a rich past and promising future; and |
| 13 | WHEREAS, Oklahoma has 1,400 square miles of water in lakes and |
| 14 | ponds, 320 million acre-feet of water stored in its major aquifers, |
| 15 | and 167,000 miles of rivers and streams, making it a state abundant |
| 16 | in water resources. No natural resource is as vital to the welfare |
| 17 | of Oklahoma as clean, accessible water, of which more than 1.5 |
| 18 | trillion gallons are used every day throughout the state; and |
| 19 | WHEREAS, the proper care and management of water is vital to |
| 20 | Oklahoma due to its value to public health, industry and commerce, |
| 21 | aquatic and wildlife species, and vibrant tourism industry in |
| 22 | Oklahoma; and |
| 23 | WHEREAS, the 2012 Update of the Oklahoma Comprehensive Water |
| 24 | Plan (OCWP) remains unprecedented in its review of the state's |

current and future water demands, water and wastewater 1 2 infrastructure needs and priority water management issues; and

3 WHEREAS, several legislative initiatives have arisen from the 4 recommendations contained in the OCWP to guide the management and 5 protection of Oklahoma's water resources for the next fifty years and beyond, including the passage of House Bill 3055 in 2012 which 6 7 created the Water For 2060 Act and made Oklahoma the first state in the nation to establish a bold, statewide goal of consuming no more 8 9 fresh water in 2060 than was consumed in 2012 while preserving 10 Oklahoma's population growth and economic development goals; and

WHEREAS, on October 6, 2015, the Water for 2060 Advisory Council 12 submitted its final report of recommendations for achieving the goal 13 established under the Water for 2060 Act; and

14 WHEREAS, the dedicated public servants of the Oklahoma Water 15 Resources Board are passionate about their mission of protecting and 16 enhancing the quality of life for Oklahomans by managing and 17 improving the state's water resources to ensure clean and reliable 18 water supplies, a strong economy and a safe and healthy environment. 19 That dedication and passion has resulted in the agency recently 20 being awarded one of The Oklahoman's Top Workplaces for the third 21 consecutive year.
