14 compensation, remuneration or reimbursement from  
15 state governmental entities for prescribed period;  
16 providing exception for legislators returning to  
17 certain employment; providing ballot title; and  
18 directing filing.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE  
1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for  
their approval or rejection, as and in the manner provided by law,  
the following proposed amendment to Section 23 of Article V of the  
Constitution of the State of Oklahoma to read as follows:

Section 23. A. No member of the Legislature shall, during the  
term for which ~~he~~ the member was elected, be appointed or elected to  
any office or commission in the State, which shall have been

1 created, or the emoluments of which shall have been increased,  
2 during ~~his~~ the term of office, ~~nor shall any member to which the~~  
3 member was elected.

4 B. Except as otherwise provided by this section, no former  
5 member of the Legislature shall be employed by or receive any form  
6 of compensation, payment or expense reimbursement from any state  
7 governmental entity regardless of the source of revenue until July 1  
8 of the year following the end of the term of office for which the  
9 member shall have been elected.

10 C. The provisions of subsection B of this section shall not  
11 prohibit a former member of the Legislature from being appointed to  
12 the cabinet system of the Governor.

13 D. The provisions of subsection B of this section shall not be  
14 applicable to retirement benefit payments or distributions from a  
15 governmental tax-qualified retirement plan.

16 E. No member shall receive any appointment from the Governor,  
17 the Governor and Senate, or from the Legislature, during the term  
18 for which ~~he~~ the member shall have been elected, ~~nor shall any.~~

19 F. Except as otherwise provided by subsection D of this  
20 section, no member shall, during the term for which ~~he~~ the member  
21 shall have been elected, or within two (2) years thereafter, be  
22 interested, directly or indirectly, in any contract with the State,  
23 or any county or other political subdivision thereof, authorized by  
24

1 law passed during the term for which ~~he~~ the member shall have been  
2 elected.

3 G. The provisions of this section shall not prohibit a former  
4 legislator from receiving the lawful compensation provided by law  
5 upon election to another state office.

6 SECTION 2. The Ballot Title for the proposed Constitutional  
7 amendment as set forth in SECTION 1 of this resolution shall be in  
8 the following form:

11 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

12 This measure amends Section 23 of Article 5 of the Oklahoma  
13 Constitution. It would prohibit a former legislator from being  
14 employed by a state governmental entity until July 1 of the year  
15 following the end of the term of office. It would also prohibit  
16 a former legislator from receiving any form of compensation,  
17 payment or reimbursement from any state governmental entity  
18 until July 1 of the year following the end of the term of  
19 office. Former legislators could be appointed to the Governor's  
20 cabinet. Former legislators could receive retirement money and  
21 money paid into a retirement plan. This measure would allow  
22 former legislators to be paid if elected to another state  
23 office.

7 Attorney General.
