The Secretary of State shall refer to the people for 16 their approval or rejection, as and in the manner provided by law, 17 the following proposed amendment to Section 2 of Article V of the 18 Constitution of the State of Oklahoma to read as follows: 19 Section 2. The first power reserved by the people is the 20 initiative, and eight per centum percent (8%) of the legal voters 21 shall have the right to propose any legislative measure, and fifteen 22 per centum percent (15%) of the legal voters shall have the right to 23 propose amendments to the Constitution by petition, and every such

petition shall include the full text of the measure so proposed.

1	The second power is the referendum, and it may be ordered (except as
2	to laws necessary for the immediate preservation of the public
3	peace, health, or safety), either by petition signed by five per
4	centum of the legal voters or by the Legislature as other bills are
5	enacted. The ratio and per centum of legal voters hereinbefore
6	stated shall be based upon the total number of votes cast at the
7	last general election for the Office of Governor.
8	SECTION 2. The Ballot Title for the proposed Constitutional
9	amendment as set forth in SECTION 1 of this resolution shall be in
10	the following form:

14	This measure amends Section 2 of Article 5 of the Oklahoma

19	SECTION 3. The Speaker of the House of Representatives shall,
20	immediately after the passage of this resolution, prepare and file
