14 language gender neutral; providing ballot title; and
15 directing filing.

1 year, and publish his or her report as to every such treasurer once
2 each year. For the purpose of such examination he or she shall take
3 complete possession of such treasurer's office. He or she shall
4 also prescribe a uniform system of bookkeeping for the use of all
5 treasurers. The State Auditor and Inspector shall perform such
6 other duties and have such other powers as may be prescribed by law.

7 SECTION 2. The Ballot Title for the proposed Constitutional
8 amendment as set forth in SECTION 1 of this resolution shall be in
9 the following form:

12 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

13 This measure amends Section 19 of Article 6 of the Oklahoma
14 Constitution. It changes the qualifications for the State
15 Auditor and Inspector. It requires the State Auditor and
16 Inspector to have three years of experience as a certified
17 public accountant.
