- 4 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
- 5 SECTION 1. NEW LAW A new section of law not to be

- 7 A. This act shall be known and may be cited as the "Elimination 8 of Non-Essential Governmental Spending Act".
 - B. Effective July 1, 2015, the following state entities are hereby abolished:
 - 1. The Space Industry Development Authority;
 - 2. The J.M. Davis Memorial Commission;
 - 3. The Will Rogers Memorial Commission; and
 - 4. The Native American Cultural and Educational Authority.
- C. All orders, determinations, rules, regulations, permits,
