NEW LAW 19 codified in the Oklahoma Statutes reads as follows: 20 This act shall be known and may be cited as the "Oklahoma 21 Return to Work and Bill of Rights Conformity Act". 22 В. SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 6406.1 of Title 63, unless there is created a duplication in numbering, reads as follows:

A. The State of Oklahoma hereby preempts all legislation, orders, mandates, opinions, rulings, rules and regulations touching in any way the closing of businesses due to a health emergency whether officially declared by the President, Governor or any other

or having any other designation, due to a catastrophic health emergency, as declared pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes or any other health emergency provided the business has met and maintains all required licensing, permits or other regulations for normal business operations when there is no declared emergency.

C. No political subdivision of this state including the county and municipal level, shall force any business to limit or modify its hours of operation or continue limiting or modifying the hours of any business currently limited or modified on the effective date of this act, whether deemed essential or nonessential or having any other designation due to a catastrophic health emergency, as declared pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes, or any other health emergency provided the business has met and maintains all required licensing, permits or other regulations for normal business operations when there is no declared emergency.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 6406.2 of Title 63, unless there is created a duplication in numbering, reads as follows:

A. During the duration of any Catastrophic Health Emergency declared by the Governor pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes, the Department of Health shall provide to any business either directly or by providing resources online for

the business to access and print themselves, signage of the current guidelines being encouraged by the Department of Health to address the current health emergency for the business to post in their establishments.

- B. For purposes of this section, signage shall include but not be limited to:
- Guidelines on social distancing for placement at entrances, exits and throughout the business;
- 2. Instructions and guidance on appropriate hand washing methods for placement in bathrooms, kitchens, break rooms and other rooms containing a sink or hand washing station;
- 3. Instructions for employees to heed health guidelines for placement in employee gathering areas, conference rooms, bathrooms, break rooms, at vending machines and throughout the business; and
- 4. Any additional guidelines or instructions available to the Department of Health useful for addressing the health emergency.
- SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 6406.3 of Title 63, unless there is created a duplication in numbering, reads as follows:

During a declared Catastrophic Health Emergency pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes, businesses that do not voluntarily close and choose to remain open shall be encouraged to implement responsible measures including but not limited to the following:

1. Follow social distancing guidelines of maintaining six (6) feet or greater whenever possible between employee and employees and customers:

- 2. Increase cleaning schedules and additional sanitary measures;
- 3. Regular disinfecting of restrooms, workspaces, public access points and shared equipment;
 - 4. Discourage the sharing of equipment and supplies;
- 5. Designate as many employees as possible to work remotely from home;
- 6. Conduct virtual, rather than in person, meetings whenever possible;
 - 7. Limit or suspend nonessential activities and operations;
- 8. Stagger employee work shifts and break periods to limit inperson interactions;
 - 9. Minimize group gatherings;

- 10. Post notices and signage with guidelines and recommendations throughout the business; and
- 11. Provide additional sick leave to employees who may be showing symptoms or who have a family member in their immediate care who may be showing symptoms.
- SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 6406.4 of Title 63, unless there is created a duplication in numbering, reads as follows:

No additional liability shall be assigned to any business owner, manager, employee or other representative of a business for opening or continuing to operate their business during a declared Catastrophic Health Emergency pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes.

SECTION 6. NEW LAW A new section of law to be codified in the Oklahoma Statutes as 6406.5 of Title 63, unless there is created a duplication in numbering, reads as follows:

During a declared Catastrophic Health Emergency pursuant to Section 6401 et seq. of Title 63 of the Oklahoma Statutes, an employer may permit:

- 1. Any employee who is showing symptoms of the current disease causing the declared health emergency to take additional sick leave for the recommended period suggested by Department of Health guidelines or until a test is performed showing the employee is not contagious.
- 2. Any employee who has a family member in their immediate care who is showing symptoms of the current disease causing the declared health emergency to take additional sick leave to care for their family member during the recommended period suggested by Department of Health guidelines or until a test is performed showing the family member of the employee is not contagious.

SECTION 7. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby

1	declared to exist, by reason whereof this act shall take effect and
2	be in full force from and after its passage and approval.
