L3	SECTION 1. AMENDATORY 47 O.S. 2011, Section 6-106, as
L 4	last amended by Section 1, Chapter 242, O.S.L. 2014 (47 O.S. Supp.
L5	2015, Section 6-106), is amended to read as follows:
L 6	Section 6-106. A. 1. Every application for a driver license
L7	or identification card shall be made by the applicant upon a form
L8	furnished by the Department of Public Safety.
L 9	2. Every original, renewal, or replacement application for a
20	driver license or identification card made by a male applicant who
21	is at least sixteen (16) but less than twenty-six (26) years of age
22	shall include a statement that by submitting the application, the
23	applicant is consenting to registration with the Selective Service

System. The pertinent information from the application shall be

- 1 forwarded by the Department to the Data Management Center of the Selective Service System in order to register the applicant as 2 required by law with the Selective Service System. Any applicant 3 refusing to sign the consent statement shall be denied a driver 4 license or identification card.
 - 3. Except as provided for in subsection G of this section, every applicant for a driver license or identification card shall provide to the Department at the time of application both primary and secondary proofs of identity. The Department shall promulgate rules prescribing forms of primary and secondary identification acceptable for an original Oklahoma driver license.
 - B. Every applicant for a driver license shall state upon the application the following information:
 - 1. Full name;
 - 2. Date of birth;
 - 3. Sex;

- Residence address or mailing address and county of residence 17 to be displayed on the license; 18
 - 5. Mailing address and residence address to be maintained by the Department for the purpose of giving notice, if necessary, as required by Section 2-116 of this title;
- 6. Medical information, as determined by the Department, which 22 shall assure the Department that the person is not prohibited from 23

being licensed as provided by paragraph 7 of subsection A of Section 6-103 of this title:

- 7. Whether the applicant is deaf or hard-of-hearing;
- 8. A brief description of the applicant, as determined by the Department;
- 9. Whether the applicant has previously been licensed, and, if so, when and by what state or country, and whether any license has ever been suspended or revoked, or whether an application has ever been refused, and, if so, the date of and reason for the suspension, revocation or refusal;
- 10. Whether the applicant is an alien eligible to be considered for licensure and is not prohibited from licensure pursuant to paragraph 9 of subsection A of Section 6-103 of this title;
 - 11. Whether the applicant has:

- a. previously been licensed and, if so, when and by what state or country, and
- b. held more than one license at the same time during the immediately preceding ten (10) years; and
- 12. Social security number.

No person shall request the Department to use the social security
number of that person as the driver license number. Upon renewal or
replacement of any driver license issued after the effective date of
this act, the licensee shall advise the Department or the motor
license agent if the present driver license number of the licensee

is the social security number of the licensee. If the driver license number is the social security number, the Department or the motor license agent shall change the driver license number to a computer-generated alphanumeric identification.

- 5 In addition to the requirements of subsections A and B of this section, every applicant for a commercial driver license who 6 7 is subject to the requirements of 49 C.F.R., Part 391, and is applying for an original, renewal, or replacement license, and every 8 9 person who, upon the effective date of this act, is currently the holder of a commercial driver license and is subject to the 10 requirements of 49 C.F.R., Part 391, and who does not apply for a 11 12 renewal or replacement license prior to January 30, 2014, shall 13 submit to the Department and maintain with the Department a current approved medical examination certificate signed by a licensed 14 physician authorized to perform and approve medical examination 15 certifications. The Department shall adopt rules regarding 16 procedures for maintaining medical examination certificates pursuant 17 to the requirements in 49 C.F.R., Parts 383 and 384. Any commercial 18 driver licensee subject to the requirements of this paragraph who 19 fails to maintain on file with the Department a current, approved 20 medical examination certificate shall have the driving privileges of 21 the person downgraded to a Class D driver license by the Department. 22
 - 2. If the applicant is applying for an original commercial driver license in Oklahoma or is transferring a commercial driver

license from another state to Oklahoma, the Department shall review the driving record of the applicant in other states for the immediately preceding ten (10) years, unless the record review has already been performed by the Department. As a result of the review, if it is determined by the Department that the applicant is subject to a period of disqualification as prescribed by Section 6-205.2 of this title which has not yet been imposed, the Department shall impose the period of disqualification and the applicant shall serve the period of disqualification before a commercial driver license is issued to the applicant; provided, nothing in this paragraph shall be construed to prevent the issuance of a Class D driver license to the applicant.

- 3. If the applicant has or is applying for a hazardous material endorsement, the applicant shall submit to a security threat assessment performed by the Transportation Security Administration of the Department of Homeland Security as required by and pursuant to 49 C.F.R., Part 1572, which shall be used to determine whether the applicant is eligible for the endorsement pursuant to federal law and regulation.
- 4. The Department of Public Safety shall notify each commercial driving school of the passage of this section, and each commercial driving school shall notify prospective students of its school of the hazardous material endorsement requirement.

- D. In addition to the requirements of subsections A and B of this section, every applicant shall be given an option on the application for issuance of a driver license or identification card or renewal pursuant to Section 6-115 of this title to provide an emergency contact person. The emergency contact information requested may include full name, address, and phone number. The emergency contact information shall be maintained by the Department and shall be used by the Department and law enforcement for emergency purposes only. A person listed as an emergency contact may request to be removed at any time. Any update to a change of name, address, or phone number may be made by the applicant listing the emergency contact person or by the person listed as the emergency contact.
- E. Whenever application is received from a person previously licensed in another jurisdiction, the Department shall request a copy of the driving record from the other jurisdiction and, effective September 1, 2005, from all other jurisdictions in which the person was licensed within the immediately previous ten (10) years. When received, the driving record shall become a part of the driving record of the person in this state with the same force and effect as though entered on the driver's record in this state in the original instance.

- F. Whenever the Department receives a request for a driving record from another licensing jurisdiction, the record shall be forwarded without charge.
- G. A valid and unexpired Oklahoma driver license shall serve as both primary and secondary proofs of identity whenever application for an identification card is submitted to the Department. The provisions of subsection B of Section 1550.42 of Title 21 of the Oklahoma Statutes shall not apply when issuing an identification card pursuant to the provisions of this subsection. The Department shall promulgate rules necessary to implement and administer the provisions of this subsection.
- H. In addition to the requirements of subsections A and B of this section, every applicant who has been previously licensed in another state or jurisdiction, must secure a current motor vehicle record, national driver register, driver license status check or a record from the Problem Driver Pointer System database showing the applicant's current driving record. The current driving record must be provided to the Department or motor license agent for review prior to processing the new Oklahoma license.
- SECTION 2. This act shall become effective November 1, 2016.
