6 AS INTRODUCED

7 An Act relating to pawnbrokers; amending 59 O.S.
8 2011, Section 1515, which relates to pawn
9 transactions; providing photographs of certain
information and items; and providing an effective
date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1515, is
14 amended to read as follows:

15 Section 1515. A. Any pawnbroker shall make available a copy or
16 report within three (3) days of any buy transaction to the local law
17 enforcement agency of the municipality or other political
18 subdivision in which the pawnshop is located; provided, merchandise
19 bought on invoice from a manufacturer or wholesaler with an
20 established place of business is exempt from this reporting
21 requirement. However, such invoice shall be shown upon request to
22 the Administrator or his duly authorized representative or any
23 authorized peace officer. The copy or report shall include:

- 24 1. The name and address of the pawnshop;

1 2. ~~The~~ A photograph of the person making the pawn transaction
2 and a copy of the state-issued identification card, driver's license
3 or federal government-issued identification card that clearly shows
4 the name, address, race, sex, weight, height, date of birth and
5 either identification number of the seller as verified by either a
6 state-issued identification card, driver's license or federal
7 government-issued identification card ~~or by~~ and a readable
8 fingerprint of right or left index finger on the back of the pawn or
9 buy transaction copy to be retained for the pawnbroker's record;

10 3. The buy transaction number;

11 4. The date and time of the transaction;

12 5. The manufacturer of the item;

13 6. A photograph and description of the item; and

14 7. ~~The~~ A photograph of the serial number and model number where
15 available and any other identifying markings.

16 B. Items bought, except on invoice from a manufacturer or
17 wholesaler with an established place of business, shall be held for
18 ten (10) days before being disposed of or sold.

19 C. Any pawnbroker shall make available a copy or report within
20 three (3) days of any pawn transaction to the local law enforcement
21 agency of the municipality or other political subdivision in which
22 the pawnshop is located. The copy or report shall include:

23 1. The name and address of the pawnshop;

1 2. ~~The~~ A photograph of the person making the pawn transaction
2 and a copy of the state-issued identification card, driver's license
3 or federal government-issued identification card that clearly shows
4 the name, address, race, sex, weight, height, date of birth and
5 either identification number of the person making the pawn
6 transaction with the pawnshop as verified by either a state-issued
7 identification card, driver's license or federal government-issued
8 identification card ~~or by~~ and a readable fingerprint of right or
9 left index finger on the back of the pawn or buy transaction copy to
10 be retained for the pawnbroker's record;

11 3. The pawn transaction number;

12 4. The date and time of the transaction;

13 5. The manufacturer of the item;

14 6. A photograph and description of the item; and

15 7. ~~The~~ A photograph of the serial number and model number where
16 available and any other identifying markings.

17 D. The pawnbroker shall obtain a written declaration of
18 ownership from the seller or pledgor on all buy and pawn
19 transactions, except refinance pawn transactions or merchandise
20 bought from a manufacturer or wholesaler with an established place
21 of business. The seller or pledgor shall be required to state how
22 long he has owned the property described in the transaction. The
23 declaration of ownership shall appear on the bill of sale or pawn

1 ticket, to be completed by the seller or the pledgor at the time of
2 the transaction.

3 SECTION 2. This act shall become effective November 1, 2016.
