10 COMMITTEE SUBSTITUTE

11 An Act relating to the Office of Management and
12 Enterprise Services; requiring that portions of
13 certain appropriated funds be used for certain
14 purposes; prohibiting supplantation of funding;
15 requiring a certain amount of funding be budgeted for
16 a stated purpose; providing an effective date; and
17 declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. From the funds appropriated to the Office of
20 Management and Enterprise Services in Enrolled House Bill No. 2765
21 of the 1st Session of the 57th Oklahoma Legislature, the sum of Six
22 Million Three Hundred Thousand Dollars (\$6,300,000.00) shall be used
23 to fund operations of the Capital Assets Management and Central
24 Accounting and Reporting Divisions. These funds shall not supplant
the current Capital Assets Management and Central Accounting and

1 Reporting Divisions funding and the agency shall budget no less than
2 the total of the amount budgeted in the fiscal year ending June 30,
3 2019, plus the amount listed above for this purpose.

4 SECTION 2. From the funds appropriated to the Office of
5 Management and Enterprise Services in Enrolled House Bill No. 2765
6 of the 1st Session of the 57th Oklahoma Legislature, the sum of One
7 Million Five Hundred Thousand Dollars (\$1,500,000.00) shall be used
8 to provide for the Pay For Success program. These funds shall not
9 supplant the current Pay for Success program funding and the agency
10 shall budget no less than the total of the amount budgeted in the
11 fiscal year ending June 30, 2019, plus the amount listed above for
12 this purpose.

13 SECTION 3. From the funds appropriated to the Office of
14 Management and Enterprise Services in Enrolled House Bill No. 2765
15 of the 1st Session of the 57th Oklahoma Legislature, the sum of
16 Sixteen Million Four Hundred Seventeen Thousand Dollars
17 (\$16,417,000.00) shall be used to fund the Information Services
18 Division. These funds shall not supplant the current Information
19 Services Division funding and the agency shall budget no less than
20 the total of the amount budgeted in the fiscal year ending June 30,
21 2019, plus the amount listed above for this purpose.

22 SECTION 4. This act shall become effective July 1, 2019.

23 SECTION 5. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
