11	An Act relating to motor vehicle disability placard; amending 47 O.S. 2021, Section 15-112, as amended by
12	Section 98, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2022, Section 15-112), which relates to the physical
13	disability temporary placard; modifying certain definition; requiring Service Oklahoma to issue
14	certain temporary placards; requiring certain
15	expiration; requiring a certain fee; updating statutory language; and providing an effective date.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY 47 O.S. 2021, Section 15-112, as
20	amended by Section 98, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2022,
21	Section 15-112), is amended to read as follows:
22	Section 15-112. A. As used in this section:
23	1. "Physician" means any person holding a valid license to
24	practice medicine and surgery, osteopathic medicine, chiropractic,
22 23	Section 15-112. A. As used in this section: 1. "Physician" means any person holding a valid license to

podiatric medicine, or optometry, pursuant to the state licensing
provisions of Title 59 of the Oklahoma Statutes;

2. "Physician assistant" means any person holding a valid
4 license as a physician assistant, pursuant to the state licensing
5 provisions of the Physician Assistant Act;

3. <u>"Advanced registered nurse practitioner"</u> <u>"Advanced Practice</u>
<u>Registered Nurse"</u> means any person who holds a current license as a
registered nurse and a current certificate of recognition for
practice as an Advanced <u>Registered Nurse Practitioner Practice</u>
<u>Registered Nurse</u> as set forth in the Oklahoma Nursing Practice Act
pursuant to the state licensing provisions contained in paragraph 5
of Section 567.3a of Title 59 of the Oklahoma Statutes; and

4. "Physical disability" means an illness, disease, injury orcondition by reason of which a person:

## a. cannot walk two hundred (200) feet without stopping to rest,

b. cannot walk without the use of or assistance from a 17 brace, cane, crutch, another person, prosthetic 18 device, wheelchair or other assistance device, 19 is restricted to such an extent that the person's 20 с. forced (respiratory) expiratory volume for one (1) 21 second, when measured by spirometry, is less than one 22 (1) liter, or the arterial oxygen tension is less than 23 sixty (60) mm/hg on room air at rest, 24

- 1 d. must use portable oxygen,
  - e. has functional limitations which are classified in
- 2 severity as Class III or Class IV according to 3 standards set by the American Heart Association, 4 5 f. is severely limited in the person's ability to walk due to an arthritic, neurological or orthopedic 6 condition, or from complications due to pregnancy, 7 is certified legally blind, or is missing one or more 8 g. 9 limbs, or
- 10

## h. is up to six (6) months postpartum.

Service Oklahoma shall issue a detachable placard indicating 11 Β. 12 physical disability to any person who submits an application on a form furnished by Service Oklahoma and certified by a physician, 13 physician assistant, or advanced registered nurse practitioner 14 Advanced Practice Registered Nurse attesting that the applicant has 15 a physical disability. The attestation of the physician, physician 16 17 assistant, or advanced registered nurse practitioner Advanced Practice Registered Nurse shall denote "temporary" as the type of 18 placard requested and shall indicate an expiration date which the 19 physician, physician assistant, or advanced registered nurse 20 practitioner Advanced Practice Registered Nurse estimates to be the 21 date of termination of such physical disability; however, if the 22 physician, physician assistant, or advanced registered nurse 23 practitioner Advanced Practice Registered Nurse certifies that the 24

physical disability is permanent, the physician, physician
 assistant, or advanced registered nurse practitioner <u>Advanced</u>
 <u>Practice Registered Nurse</u> shall denote "five-year" as the type of
 placard requested.

5 C. Any placard issued by Service Oklahoma shall remain valid 6 until:

7 1. The placard expires;

8 2. The person to whom the placard was issued requests a9 replacement placard; or

3. The placard is no longer needed by the person to whom the placard was issued for the disability for which the placard was originally issued, whereupon such placard shall be returned to Service Oklahoma.

D. 1. A five-year placard shall expire five (5) years from the last day of the month in which the placard was issued. Upon the expiration of a five-year placard, the person to whom such placard was issued may obtain a subsequent placard by reapplying to Service Oklahoma, in the same manner as provided in subsection B of this section.

A temporary placard shall indicate the expiration date which
 the physician, physician assistant, or advanced registered nurse
 practitioner Advanced Practice Registered Nurse certifying the
 physical disability estimates to be the date of termination of such
 physical disability, which shall not be later than six (6) months

1 from the date of issuance and upon which date such placard shall 2 expire and shall be returned to Service Oklahoma; provided, however, nothing in this paragraph shall be construed to prevent the holder 3 from applying for another placard, as provided for in this section. 4 5 3. In the event that a placard is lost or destroyed, the person to whom such placard was issued may apply in writing to Service 6 Oklahoma for a replacement placard, which Service Oklahoma shall 7 issue with the same expiration date as the original placard. 8

9 4. On and after January 1, 1998, all placards issued prior to 10 October 31, 1990, shall expire on the last day of the month in which 11 the placard was issued, and the person to whom such placard was 12 issued may follow the procedure provided for in subsection B of this 13 section to obtain a second or subsequent placard.

14 5. On and after January 1, 2000, all placards issued between 15 November 1, 1990, and June 30, 1995, shall expire on the last day of 16 the birth month of the person to whom the placard was issued, and 17 the person to whom such placard was issued may follow the procedure 18 provided for in subsection B of this section to obtain a second or 19 subsequent placard.

E. A physician, physician assistant, or advanced registered
nurse practitioner Advanced Practice Registered Nurse may sign an
application certifying that a person has a physical disability, as
provided in subsection B of this section, only if care and treatment
of the illness, disease, injury or condition causing the physical

disability of such person falls within the authorized scope of
 practice of the physician or physician assistant, or advanced
 registered nurse practitioner <u>Advanced Practice Registered Nurse</u>.

F. Service Oklahoma shall have the power to formulate, adopt
and promulgate rules as may be necessary to implement and administer
the provisions of this section, including, but not limited to,
prescribing the manner in which the placard is to be displayed on a
motor vehicle.

9 G. Nothing in this section shall prohibit the issuance of a 10 temporary placard to a pregnant woman whose condition, as determined 11 by a physician, physician assistant, or advanced registered nurse 12 practitioner Advanced Practice Registered Nurse, meets one or more 13 of the categories described in paragraph 4 of subsection A of this 14 section.

H. Service Oklahoma shall issue a yellow temporary placard to 15 any woman who has given birth within the past six (6) months 16 provided the person requesting the temporary placard submits a birth 17 certificate or record of birth for the child and a valid Oklahoma 18 driver license, a valid Oklahoma identification card, or other proof 19 20 of principal residency in the state, as prescribed by rules promulgated by Service Oklahoma, for the mother. The temporary 21 placard for the mother shall expire six (6) months after the date of 22 birth listed on the submitted birth certificate or record of birth. 23

2	placard and Service Oklahoma may adjust the fee on an annual basis.
3	SECTION 2. This act shall become effective November 1, 2023.
