6 AS INTRODUCED

7 An Act relating to motor vehicle taxes and fees;  
8 amending 47 O.S. 2011, Sections 1115, as amended by  
9 Section 1, Chapter 337, O.S.L. 2012, 1132, as amended  
10 by Section 2, Chapter 337, O.S.L. 2012, and 1151, as  
11 amended by Section 3, Chapter 337, O.S.L. 2012 (47  
O.S. Supp. 2015, Sections 1115, 1132 and 1151), which  
relate to registration of motor vehicles; modifying  
maximum penalty for delinquent registration; and  
providing an effective date.

13  
14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1115, as  
16 amended by Section 1, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2015,  
17 Section 1115), is amended to read as follows:

18 Section 1115. A. Unless provided otherwise by statute, the  
19 following vehicles shall be registered annually: manufactured  
20 homes, vehicles registered with a permanent nonexpiring license  
21 plate pursuant to Section 1113 of this title, and commercial  
22 vehicles registered pursuant to the installment plan provided in  
23 subsection H of Section 1133 of this title. The following schedule  
24

1 shall apply for such vehicle purchased in this state or brought into  
2 this state by residents of this state:

3 1. Between January 1 and March 31, the payment of the full  
4 annual fee shall be required;

5 2. Between April 1 and June 30, the payment of three-fourths  
6 (3/4) the annual fee shall be required;

7 3. Between July 1 and September 30, the payment of one-half  
8 (1/2) the annual fee shall be required; and

9 4. Between October 1 and November 30, one-fourth (1/4) the  
10 annual fee shall be required.

11 License plates or decals for each year shall be made available  
12 on December 1 of each preceding year for such vehicles. Any person  
13 who purchases such vehicle or manufactured home between December 1  
14 and December 31 of any year shall register it within thirty (30)  
15 days from date of purchase and obtain a license plate or  
16 Manufactured Home License Registration Decal, as appropriate, for  
17 the following calendar year upon payment of the full annual fee.  
18 Unless provided otherwise by statute, all annual license,  
19 registration and other fees for such vehicles shall be due and  
20 payable on January 1 of each year and if not paid by February 1  
21 shall be deemed delinquent.

22 B. 1. All vehicles, other than those required to be registered  
23 pursuant to the provisions of subsection A of this section, shall be  
24 registered on a staggered system of registration and licensing on a

1 monthly series basis to distribute the work of registering such  
2 vehicles as uniformly and expeditiously as practicable throughout  
3 the calendar year. After the end of the month following the  
4 expiration date, the license and registration fees for the new  
5 registration period shall become delinquent.

6 2. All fleet vehicles registered pursuant to new applications  
7 approved pursuant to the provisions of Section 1120 of this title  
8 shall be registered on a staggered system monthly basis.

9 3. Applicants seeking to establish Oklahoma as the base  
10 jurisdiction for registering apportioned fleet vehicles shall have a  
11 one-time option of registering for a period of not less than six (6)  
12 months nor greater than eighteen (18) months. Subsequent renewals  
13 for these registrants will be for twelve (12) months, expiring on  
14 the last day of the month chosen by the registrant under the one-  
15 time option as provided herein. In addition, registrants with  
16 multiple fleets may designate a different registration month of  
17 expiration for each fleet.

18 As used in this section, "fleet" shall have the same meaning as  
19 set forth in the International Registration Plan.

20 4. Effective January 1, 2004, all motorcycles and mopeds shall  
21 be registered on a staggered system of registration. The Oklahoma  
22 Tax Commission shall notify in writing, prior to December 1, 2003,  
23 all owners of motorcycles or mopeds registered as of such date, who  
24 shall have a one-time option of registering for a period of not less

1 than three (3) months nor greater than fifteen (15) months.  
2 Subsequent renewals for these registrants will be for twelve (12)  
3 months, expiring on the last day of the month chosen by the  
4 registrant under the one-time option as provided herein. All  
5 motorcycles and mopeds registered pursuant to new applications  
6 received on or after December 1, 2003, shall also be registered  
7 pursuant to the provisions of this paragraph.

8 C. The following penalties shall apply for delinquent  
9 registration fees:

10 1. For fleet vehicles required to be registered pursuant to the  
11 provisions of Section 1120 of this title for which a properly  
12 completed application for registration has not been received by the  
13 Corporation Commission by the last day of the month following the  
14 registration expiration date, a penalty of thirty percent (30%) of  
15 the Oklahoma portion of the annual registration fee, or Two Hundred  
16 Dollars (\$200.00), whichever is greater, shall be assessed. The  
17 license and registration cards issued by the Corporation Commission  
18 for each fleet vehicle shall be valid until two (2) months after the  
19 registration expiration date;

20 2. For commercial vehicles registered under the provisions of  
21 subsection B of this section, except those vehicles registered  
22 pursuant to Section 1133.1 of this title, a penalty shall be  
23 assessed after the last day of the month following the registration  
24 expiration date. A penalty of twenty-five cents (\$0.25) per day

1 shall be added to the license fee of such vehicle and shall accrue  
2 for one (1) month. Thereafter, the penalty shall be thirty percent  
3 (30%) of the annual registration fee, or Two Hundred Dollars  
4 (\$200.00), whichever is greater;

5 3. For new or used manufactured homes, not registered within  
6 thirty (30) days from date of purchase or date such manufactured  
7 home was brought into this state, a penalty equal to the  
8 registration fee shall be assessed; or

9 4. For all vehicles a penalty shall be assessed after the last  
10 day of the month following the expiration date and no penalty shall  
11 be waived by the Oklahoma Tax Commission or any motor license agent  
12 except as provided for in subsection H of Section 1133 and  
13 subsection C of Section 1127 of this title. A penalty of One Dollar  
14 (\$1.00) per day shall be added to the license fee of such vehicle,  
15 provided that the penalty shall not exceed ~~One Hundred Dollars~~  
16 ~~(\$100.00)~~ Fifty Dollars (\$50.00). Of each dollar penalty collected  
17 pursuant to this subsection:

- 18 a. twenty-one cents (\$0.21) shall be apportioned as  
19 provided in Section 1104 of this title,  
20 b. twenty-one cents (\$0.21) shall be retained by the  
21 motor license agent, and  
22 c. fifty-eight cents (\$0.58) shall be deposited in the  
23 General Revenue Fund.  
24

1 D. In addition to all other penalties provided in the Oklahoma  
2 Vehicle License and Registration Act, the following penalties shall  
3 be imposed and collected by any Enforcement Officer of the  
4 Corporation Commission upon finding any commercial vehicle being  
5 operated in violation of the provisions of the Oklahoma Vehicle  
6 License and Registration Act.

7 The penalties shall apply to any commercial vehicle found to be  
8 operating in violation of the following provisions:

9 1. A penalty of not less than Fifty Dollars (\$50.00) shall be  
10 imposed upon any person found to be operating a commercial vehicle  
11 sixty (60) days after the end of the month in which the license  
12 plate or registration credentials expire without the current year  
13 license plate or registration credential displayed. Such penalty  
14 shall not exceed the amount established by the Corporation  
15 Commission pursuant to the provisions of subsection A of Section  
16 1167 of this title. Revenue from such penalties shall be  
17 apportioned as provided in Section 1167 of this title;

18 2. A penalty of not less than Fifty Dollars (\$50.00) shall be  
19 imposed for any person operating a commercial vehicle subject to the  
20 provisions of Section 1120 or Section 1133 of this title without the  
21 proper display of, or, carrying in such commercial vehicle, the  
22 identification credentials issued by the Corporation Commission as  
23 evidence of payment of the fee or tax as provided in Section 1120 or  
24 Section 1133 of this title. Such penalty shall not exceed the

1 amount established by the Corporation Commission pursuant to the  
2 provisions of subsection A of Section 1167 of this title. Revenue  
3 from such penalties shall be apportioned as provided in Section 1167  
4 of this title; and

5 3. A penalty of not less than One Hundred Dollars (\$100.00)  
6 shall be imposed for any person that fails to register any  
7 commercial vehicle subject to the Oklahoma Vehicle License and  
8 Registration Act. Such penalty shall not exceed the amount  
9 established by the Corporation Commission pursuant to the provisions  
10 of subsection A of Section 1167 of this title. Revenue from such  
11 penalties shall be apportioned as provided in Section 1167 of this  
12 title.

13 E. The Tax Commission, or Corporation Commission with respect  
14 to vehicles registered under Section 1120 or Section 1133 of this  
15 title, shall assess the registration fees and penalties for the year  
16 or years a vehicle was not registered. For vehicles not registered  
17 for two (2) or more years, the registration fees and penalties shall  
18 be due only for the current year and one (1) previous year.

19 F. In addition to any other penalty prescribed by law, there  
20 shall be a penalty of not less than Twenty Dollars (\$20.00) upon a  
21 finding by an enforcement officer that:

22 1. The registration of a vehicle registered pursuant to Section  
23 1132 of this title is expired and it is sixty (60) or more days  
24 after the end of the month of expiration; or

1           2. The registration fees for a vehicle that is subject to the  
2 registration fees pursuant to Section 1132 of this title have not  
3 been paid.

4           Such penalty shall not exceed the amount established by the  
5 Corporation Commission pursuant to the provisions of subsection A of  
6 Section 1167 of this title. Revenue from such penalties shall be  
7 apportioned as provided in Section 1167 of this title.

8           G. If a vehicle is donated to a nonprofit charitable  
9 organization, the nonprofit charitable organization shall be exempt  
10 from paying any current or past due registration fees, excise tax,  
11 transfer fees, and penalties and interest. However, after the  
12 donation, if the person donating the vehicle, or someone on behalf  
13 of such person, purchases the same vehicle back from the nonprofit  
14 charitable organization to which the vehicle was donated, such  
15 person shall be liable for all current and past-due registration  
16 fees, excise tax, title or transfer fees, and penalties and interest  
17 on such vehicle.

18           SECTION 2.           AMENDATORY           47 O.S. 2011, Section 1132, as  
19 amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2015,  
20 Section 1132), is amended to read as follows:

21           Section 1132. A. For all vehicles, unless otherwise  
22 specifically provided by the Oklahoma Vehicle License and  
23 Registration Act, a registration fee shall be assessed at the time  
24 of initial registration by the owner and annually thereafter, for



1 the use of the avenues of public access within this state in the  
2 following amounts:

3 1. For the first through the fourth year of registration in  
4 this state or any other state, Eighty-five Dollars (\$85.00);

5 2. For the fifth through the eighth year of registration in  
6 this state or any other state, Seventy-five Dollars (\$75.00);

7 3. For the ninth through the twelfth year of registration in  
8 this state or any other state, Fifty-five Dollars (\$55.00);

9 4. For the thirteenth through the sixteenth year of  
10 registration in this state or any other state, Thirty-five Dollars  
11 (\$35.00); and

12 5. For the seventeenth and any following year of registration  
13 in this state or any other state, Fifteen Dollars (\$15.00).

14 The registration fee provided for in this subsection shall be in  
15 lieu of all other taxes, general or local, unless otherwise  
16 specifically provided.

17 B. For all-terrain vehicles and motorcycles used exclusively  
18 for use off roads or highways purchased on or after July 1, 2005,  
19 and for all-terrain vehicles and motorcycles used exclusively for  
20 use off roads or highways purchased prior to July 1, 2005, which the  
21 owner chooses to register pursuant to the provisions of Section  
22 1115.3 of this title, an initial and nonrecurring registration fee  
23 of Eleven Dollars (\$11.00) shall be assessed at the time of initial  
24 registration by the owner. Nine Dollars (\$9.00) of the registration

1 fee shall be deposited in the Oklahoma Tax Commission Reimbursement  
2 Fund. Two Dollars (\$2.00) of the registration fee shall be retained  
3 by the motor license agent. The fees required by subsection A of  
4 this section shall not be required for all-terrain vehicles or  
5 motorcycles used exclusively off roads and highways.

6 C. For utility vehicles used exclusively for use off roads or  
7 highways purchased on or after July 1, 2008, and for utility  
8 vehicles used exclusively for use off roads or highways purchased  
9 prior to July 1, 2008, which the owner chooses to register pursuant  
10 to the provisions of Section 1115.3 of this title, an initial and  
11 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be  
12 assessed at the time of initial registration by the owner. Nine  
13 Dollars (\$9.00) of the registration fee shall be deposited in the  
14 Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of  
15 the registration fee shall be retained by the motor license agent.  
16 The fees required by subsection A of this section shall not be  
17 required for utility vehicles used exclusively off roads and  
18 highways.

19 D. There shall be a credit allowed with respect to the fee for  
20 registration of a new vehicle which is a replacement for:

21 1. A new original vehicle which is stolen from the  
22 purchaser/registrant within ninety (90) days of the date of purchase  
23 of the original vehicle as certified by a police report or other  
24 documentation as required by the Oklahoma Tax Commission; or

1           2. A defective new original vehicle returned by the  
2 purchaser/registrant to the seller within six (6) months of the date  
3 of purchase of the defective new original vehicle as certified by  
4 the manufacturer.

5           The credit shall be in the amount of the fee for registration  
6 which was paid for the new original vehicle and shall be applied to  
7 the registration fee for the replacement vehicle. In no event will  
8 the credit be refunded.

9           E. Upon every transfer or change of ownership of a vehicle, the  
10 new owner shall obtain title for and, except in the case of salvage  
11 vehicles and manufactured homes, register the vehicle within thirty  
12 (30) days of change of ownership and pay a transfer fee of Fifteen  
13 Dollars (\$15.00) in addition to any other fees provided for in this  
14 act. No new decal shall be issued to the registrant. Thereafter,  
15 the owner shall register the vehicle annually on the anniversary  
16 date of its initial registration in this state and shall pay the  
17 fees provided in subsection A of this section and receive a decal  
18 evidencing such payment. Provided, used motor vehicle dealers shall  
19 be exempt from the provisions of this section.

20           F. In the event a new or used vehicle is not registered, titled  
21 and tagged within thirty (30) days from the date of transfer of  
22 ownership, the penalty for the failure of the owner of the vehicle  
23 to register the vehicle within thirty (30) days shall be One Dollar  
24 (\$1.00) per day, provided that in no event shall the penalty exceed

1 ~~One Hundred Dollars (\$100.00)~~ Fifty Dollars (\$50.00). No penalty  
2 shall be waived by the Oklahoma Tax Commission or any motor license  
3 agent except as provided in subsection C of Section 1127 of this  
4 title. Of each dollar penalty collected pursuant to this  
5 subsection:

6 1. Twenty-one cents (\$0.21) shall be apportioned as provided in  
7 Section 1104 of this title;

8 2. Twenty-one cents (\$0.21) shall be retained by the motor  
9 license agent; and

10 3. Fifty-eight cents (\$0.58) shall be deposited in the General  
11 Revenue Fund.

12 SECTION 3. AMENDATORY 47 O.S. 2011, Section 1151, as  
13 amended by Section 3, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2015,  
14 Section 1151), is amended to read as follows:

15 Section 1151. A. It shall be unlawful for any person to commit  
16 any of the following acts:

17 1. To lend or to sell to, or knowingly permit the use of by,  
18 one not entitled thereto any certificate of title, license plate or  
19 decal issued to or in the custody of the person so lending or  
20 permitting the use thereof;

21 2. To alter or in any manner change a certificate of title,  
22 registration certificate, license plate or decal issued under the  
23 laws of this or any other state;

24

1           3. To procure from another state or country, or display upon  
2 any vehicle owned by such person within this state, except as  
3 otherwise provided in the Oklahoma Vehicle License and Registration  
4 Act, any license plate issued by any state or country other than  
5 this state, unless there shall be displayed upon such vehicle at all  
6 times the current license plate and decal assigned to it by the  
7 Oklahoma Tax Commission or the Corporation Commission or the vehicle  
8 shall display evidence that the vehicle is registered as a  
9 nonresident vehicle pursuant to rules promulgated by the Tax  
10 Commission, with the concurrence of the Department of Public Safety.  
11 A violation of the provisions of this paragraph shall be presumed to  
12 have occurred if a person who is the holder of an Oklahoma driver  
13 license operates a vehicle owned by such person on the public roads  
14 or highways of this state and there is not displayed on the vehicle  
15 a current Oklahoma license plate and decal, unless the vehicle is  
16 owned by a member of the Armed Forces of the United States assigned  
17 to duty in this state in compliance with official military or naval  
18 orders or the spouse of such a member of the Armed Forces;

19           4. To drive, operate or move, or for the owner to cause or  
20 permit to be driven or moved, upon the roads, streets or highways of  
21 this state, any vehicle loaded in excess of its registered laden  
22 weight, or which is licensed for a capacity less than the  
23 manufacturer's rated capacity as provided for in the Oklahoma  
24 Vehicle License and Registration Act;

1       5. To operate a vehicle without proper license plate or decal  
2 or on which all taxes due the state have not been paid;

3       6. To buy, sell or dispose of, or possess for sale, use or  
4 storage, any secondhand or used vehicle on which the registration or  
5 license fee has not been paid, as required by law, and on which  
6 vehicle the person neglects, fails or refuses to display at all  
7 times the license plate or decal assigned to it;

8       7. To give a fictitious name or fictitious address or make any  
9 misstatement of facts in application for certificate of title and  
10 registration of a vehicle;

11       8. To purchase a license plate on an assigned certificate of  
12 title. This particular paragraph shall be applicable to all persons  
13 except a bona fide registered dealer in used cars who are holders of  
14 a current and valid used car dealer license;

15       9. To operate a vehicle upon the highways of this state after  
16 the registration deadline for that vehicle without a proper license  
17 plate, as prescribed by the Oklahoma Vehicle License and  
18 Registration Act, for the current year;

19       10. For any owner of a vehicle registered on the basis of laden  
20 weight to fail or refuse to weigh or reweigh it when requested to do  
21 so by any enforcement officer charged with the duty of enforcing  
22 this law;

23       11. To operate or possess any vehicle which bears a motor  
24 number or serial number other than the original number placed

1 thereon by the factory except a number duly assigned and authorized  
2 by the state;

3 12. For any motor license agent to release a license plate, a  
4 manufactured home registration receipt, decal or excise tax receipt  
5 to any unauthorized person or source, including any dealer in new or  
6 used motor vehicles. Violation of this paragraph shall constitute  
7 sufficient grounds for discharge of a motor license agent by the Tax  
8 Commission;

9 13. To operate any vehicle registered as a commercial vehicle  
10 without the lettering requirements of Section 1102 of this title; or

11 14. To operate any vehicle in violation of the provisions of  
12 Sections 7-600 through 7-606 of this title while displaying a yearly  
13 decal issued to the owner who has filed an affidavit with the  
14 appropriate motor license agent in accordance with Section 7-607 of  
15 this title.

16 Any person convicted of violating any provision of this  
17 subsection, other than paragraph 3 of this subsection, shall be  
18 deemed guilty of a misdemeanor and upon conviction shall be punished  
19 by a fine not to exceed Five Hundred Dollars (\$500.00). Any person  
20 convicted of violating the provisions of paragraph 3 of this  
21 subsection shall be deemed guilty of a misdemeanor and, upon  
22 conviction, shall be punished by a fine of not less than One Hundred  
23 Dollars (\$100.00) and not more than Five Hundred Dollars (\$500.00)  
24 and shall be required to obtain an Oklahoma license plate.

1 Employees of the Corporation Commission may be authorized by the  
2 Corporation Commission to issue citations to motor carriers or  
3 operators of commercial motor vehicles, pursuant to the jurisdiction  
4 of the Corporation Commission, for a violation of this subsection.  
5 If a person convicted of violating the provisions of this subsection  
6 was issued a citation by a duly authorized employee of the  
7 Corporation Commission, the fine herein levied shall be apportioned  
8 as provided in Section 1167 of this title.

9 B. Except as otherwise authorized by law, it shall be unlawful  
10 to:

11 1. Lend or sell to, or knowingly permit the use of by, one not  
12 entitled thereto any certificate of title issued for a manufactured  
13 home, manufactured home registration receipt, manufactured home  
14 registration decal or excise tax receipt;

15 2. Alter or in any manner change a certificate of title issued  
16 for a manufactured home under the laws of this state or any other  
17 state;

18 3. Remove or alter a manufactured home registration receipt,  
19 manufactured home registration decal or excise tax receipt attached  
20 to a certificate of title or attach such receipts to a certificate  
21 of title with the intent to misrepresent the payment of the required  
22 excise tax and registration fees;

1       4. Buy, sell, or dispose of, or possess for sale, use or  
2 storage any used manufactured home on which the registration fees or  
3 excise taxes have not been paid as required by law; or

4       5. Purchase identification, manufactured home registration  
5 receipt, manufactured home registration decal or excise tax receipt  
6 on an assigned certificate of title.

7       Anyone violating the provisions of this subsection, upon  
8 conviction, shall be guilty of a felony.

9       C. In the event a new vehicle is not registered within thirty  
10 (30) days from date of purchase, the penalty for the failure of the  
11 owner of the vehicle to register the vehicle within thirty (30) days  
12 shall be One Dollar (\$1.00) per day; provided, that in no event  
13 shall the penalty exceed ~~One Hundred Dollars (\$100.00)~~ Fifty Dollars  
14 (\$50.00). No penalty shall be waived by the Oklahoma Tax Commission  
15 or any motor license agent except as provided in subsection C of  
16 Section 1127 of this title. Of each dollar penalty collected  
17 pursuant to this subsection:

18       1. Twenty-one cents (\$0.21) shall be apportioned as provided in  
19 Section 1104 of this title;

20       2. Twenty-one cents (\$0.21) shall be retained by the motor  
21 license agent; and

22       3. Fifty-eight cents (\$0.58) shall be deposited in the General  
23 Revenue Fund. The penalty for new commercial vehicles shall be  
24 equal to the license fee for such vehicles.

1 If a used vehicle is brought into Oklahoma by a resident of this  
2 state and is not registered within thirty (30) days, a penalty of  
3 One Dollar (\$1.00) per day shall be charged from the date of entry  
4 to the date of registration; provided, that in no event shall the  
5 penalty exceed ~~One Hundred Dollars (\$100.00)~~ Fifty Dollars (\$50.00).

6 No penalty shall be waived by the Oklahoma Tax Commission or any  
7 motor license agent except as provided in subsection C of Section  
8 1127 of this title. Of each dollar penalty collected pursuant to  
9 this subsection:

10 1. Twenty-one cents (\$0.21) shall be apportioned as provided in  
11 Section 1104 of this title;

12 2. Twenty-one cents (\$0.21) shall be retained by the motor  
13 license agent; and

14 3. Fifty-eight cents (\$0.58) shall be deposited in the General  
15 Revenue Fund. The penalty for used commercial vehicles shall be  
16 equal to the license fee for such vehicles.

17 D. Any owner who knowingly makes or causes to be made any false  
18 statement of a fact required in this section to be shown in an  
19 application for the registration of one or more vehicles shall be  
20 deemed guilty of a misdemeanor and, upon conviction, shall be fined  
21 not more than One Thousand Dollars (\$1,000.00), or shall be  
22 imprisoned in the county jail for not more than one (1) year, or by  
23 both such fine and imprisonment.

24

1 E. The following self-propelled or motor-driven and operated  
2 vehicles shall not be registered under the provisions of the  
3 Oklahoma Vehicle License and Registration Act or, except as provided  
4 for in Section 11-1116 of this title, be permitted to be operated on  
5 the streets or highways of this state:

6 1. Vehicles known and commonly referred to as "minibikes" and  
7 other similar trade names; provided, minibikes may be registered and  
8 operated in this state by food vendor services upon streets having a  
9 speed limit of thirty (30) miles per hour or less;

10 2. Golf carts;

11 3. Go-carts; and

12 4. Other motor vehicles, except motorcycles, which are  
13 manufactured principally for use off the streets and highways.

14 Transfers and sales of such vehicles shall be subject to sales  
15 tax and not motor vehicle excise taxes.

16 F. Any person violating paragraph 3 or 6 of subsection A of  
17 this section, in addition to the penal provisions provided in this  
18 section, shall pay as additional penalty a sum equal to the amount  
19 of license fees due on such vehicle or registration fees due on a  
20 manufactured home known to be in violation and such amount is hereby  
21 declared to be a lien upon the vehicle as provided in the Oklahoma  
22 Vehicle License and Registration Act. In addition to the penalty  
23 provisions provided in this section, any person violating paragraph  
24 3 of subsection A of this section shall be deemed guilty of a

1 misdemeanor and shall, upon conviction, be punished by a fine of One  
2 Hundred Dollars (\$100.00).

3 G. Each violation of any provision of the Oklahoma Vehicle  
4 License and Registration Act for each and every day such violation  
5 has occurred shall constitute a separate offense.

6 H. Anyone violating any of the provisions heretofore enumerated  
7 in this section shall be guilty of a misdemeanor and upon conviction  
8 shall be fined not less than Ten Dollars (\$10.00) and not to exceed  
9 Three Hundred Dollars (\$300.00).

10 I. Any violation of any portion of the Oklahoma Vehicle License  
11 and Registration Act where a specific penalty has not been imposed  
12 shall constitute a misdemeanor and upon conviction thereof the  
13 person having violated it shall be fined not less than Ten Dollars  
14 (\$10.00) and not to exceed Three Hundred Dollars (\$300.00).

15 J. Any provision of the Oklahoma Vehicle License and  
16 Registration Act providing for proportional registration under  
17 reciprocal agreements and the International Registration Plan that  
18 relates to the promulgation of rules and regulations shall not be  
19 subject to the provisions of this section.

20 SECTION 4. This act shall become effective January 1, 2017.
