NEW LAW A new section of law to be codified 17 in the Oklahoma Statutes as Section 27 of Title 73, unless there is 18 created a duplication in numbering, reads as follows: 19 20 The Office of Management and Enterprise Services (OMES) Α. shall promulgate rules for a flag flying program enabling the people 21 of Oklahoma to request for a flag or flags to be flown at the 22 Oklahoma State Capitol building on specific days for commemorative 23 Such flags shall be flown at the State Capitol based on

- 1 | availability and in conformity with the rules established by OMES on
- 2 | a first-come, first-served basis; provided, that the person
- 3 requesting the flag completes all necessary forms and pays all
- 4 | necessary fees required by OMES for the implementation of this
- 5 section of law.
- 6 B. OMES is hereby authorized to develop a fee structure to
- 7 | provide for the costs associated with the flag flying program
- 8 including but not limited to the cost of the purchase of the flag,
- 9 cost of employee services and cost of certificate confirming date
- 10 and time flag was flown. An additional fee of Twenty-five dollars
- 11 (\$25.00) per flag flown shall be charged and deposited into the
- 12 | Capitol Preservation Fund.
- C. The flags available to be flown over the Oklahoma State
- 14 | Capitol according to this section shall be:
- 15 1. The current flag of the State of Oklahoma;
  - 2. The current flag of the United States;
    - 3. The original (Star & 46) flag of the State of Oklahoma;
- 4. The original 13 Stars and Stripes flag of the United States
- 19 also known as the Betsy Ross flag;
- 20 5. The "An Appeal to Heaven" flag flown by General George
- 21 | Washington;

- 22 6. The Gadsden flag also known as the "Don't Tread On Me" flag;
- 7. The POW/MIA flag;
  - 8. The National Guard flag; and

1	9. Any official flag for any branch of the United States Armed
2	Forces.
3	SECTION 2. This act shall become effective July 1, 2022.
4	SECTION 3. It being immediately necessary for the preservation
5	of the public peace, health or safety, an emergency is hereby
6	declared to exist, by reason whereof this act shall take effect and
7	be in full force from and after its passage and approval.
