AS INTRODUCED

An Act relating to cities and towns; preempting any municipality, city or town regulation that infringes upon a citizen's right to fly the U.S. flag on their personal property; providing for exceptions to municipal ordinances; providing for codification; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

- A new section of law to be codified SECTION 1. NEW LAW in the Oklahoma Statutes as Section 14-115 of Title 11, unless there is created a duplication in numbering, reads as follows:
- Α. The State Legislature hereby occupies and preempts any ordinance and regulation by any municipality, city or town of this state to infringe upon the rights of a United States citizen of the State of Oklahoma from flying the flag of the United States on their personal property.
- This section shall not prohibit any municipality, city or town from enacting ordinances or regulations to limit the flag of the United States by the size, number of flags or proximity of flags to roadways to comply with ordinances for public safety.
