10	COMMITTEE SUBSTITUTE
11	An Act relating to career and technology education; amending 70 O.S. 2021, Section 14-108, which relates
12	to technology center school district governing boards; directing the State Board of Career and
13	Technology Education to divide districts with a certain number of electors into board zones;
14	providing for selection of board members after certain date; providing for filling of vacancy if
15	certain member is no longer a resident of certain zone; providing for promulgation of rules; and
16	providing an effective date.

19	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
20	SECTION 1. AMENDATORY 70 O.S. 2021, Section 14-108, is
21	amended to read as follows:
22	Section 14-108. A. The State Board of Career and Technology
23	Education shall prescribe criteria and procedures for the
24	establishment and governance of technology center school districts,

as provided by Section 9B, of Article X, of the Oklahoma
 Constitution, and such districts so established shall be operated in
 accordance with rules of the State Board of Career and Technology
 Education, except as otherwise provided in this title.

B. A technology center school district shall be a body
corporate and shall possess the usual powers of a corporation for
public purposes. Its official name shall be designated by the State
Board of Career and Technology Education, in which name it may sue
and be sued, and be capable of contracting and being contracted
with, and holding real and personal estate.

C. The governing board of a technology center school district 11 12 shall be a board of education consisting of not less than five (5) nor more than seven (7) members. Except as otherwise provided for 13 in subsection subsections D and E of this section, all members of 14 the board of education shall be elected in a manner prescribed by 15 the State Board of Career and Technology Education. The State Board 16 shall promulgate rules prescribing the manner in which the elections 17 required by this subsection are held. 18

D. In a technology center school district that serves seventy or more public school districts, the territory of the school district shall be divided into district zones by the State Board of Career and Technology Education. Between August 1 and December 31 of the year following the submission by the United States Department of Commerce to the President of the United States of the official

1 Federal Decennial Census, the Board shall reapportion the territory 2 of the technology center school district into district zones. All boundaries of district zones shall follow clearly visible, 3 definable, and observable physical boundaries which are based upon 4 5 criteria established and recognized by the Bureau of the Census of 6 the United States Department of Commerce for purposes of defining census blocks for its decennial census and shall follow, as much as 7 possible, precinct boundaries. District zones shall be compact, 8 9 contiguous and shall be as equal in population as practical with not 10 more than a five-percent variance between the most populous and least populous district zones. The board of education of a 11 12 technology center school district shall consist of one member 13 elected from each of the district zones of the school district created pursuant to this subsection. The electors of each district 14 zone shall elect a person, who is a resident of the district zone, 15 to represent the district zone on the school board. If during the 16 term of office to which a person was elected, that member ceases to 17 be a resident of the district zone for which the person was elected, 18 the office shall become vacant and the vacancy shall be filled as 19 provided in Section 13A-110 of Title 26 of the Oklahoma Statutes. 20 The State Board of Career and Technology Education shall promulgate 21 rules prescribing the manner in which the elections required by this 22 subsection are held. 23

1	E. In technology center school districts having a population of
2	more than two hundred twenty-five thousand (225,000) electors, the
3	territory of the district shall be divided into board zones by the
4	State Board of Career and Technology Education. The board of
5	education of the technology center school district shall consist of
6	one member elected from each of the district zones. Beginning July
7	1, 2024, the board of education shall have the option upon approval
8	of a board resolution, of requiring that the electors of each
9	district zone shall elect a person who is a resident of the district
10	zone to represent the district zone on the school board and to not
11	elect all board members at large, or the community continues to vote
12	for the board members at large. If during the term of office to
13	which a person was elected, that member ceases to be a resident of
14	the district zone for which the person was elected, the office shall
15	become vacant, and the vacancy shall be filled as provided for in
16	Section 13A-110 of Title 26 of the Oklahoma Statutes. The State
17	Board of Career and Technology Education shall promulgate rules
18	prescribing the manner in which the elections required by this
19	subsection are held.
20	<u>F.</u> The board of education of a technology center school
21	district shall have the same powers and duties that boards of
22	education of independent school districts have. It may require

- 23 nonresident students to pay reasonable tuition fees, which may be
- 24

1 paid for a student by the independent or elementary school district 2 in which the student resides.

F. G. An election to vote on the question of making a levy of 3 not to exceed five (5) mills on the dollar valuation of the taxable 4 5 property in a technology center school district under the provisions 6 of subsection $A_{\overline{\tau}}$ of Section 9B_{$\overline{\tau}$} of Article X_{$\overline{\tau}$} of the Oklahoma Constitution, shall be called by the board of education and 7 conducted by the county election board of such district in the same 8 9 manner that elections for emergency levies in school districts under the provisions of subsection (d) of Section 9-(d), of Article X_{τ} of 10 the Oklahoma Constitution, are called and conducted. When such levy 11 12 is approved by a majority of the electors of the technology center school district voting on the question at such election, the levy 13 shall be made each fiscal year thereafter until repealed by a 14 majority of the electors of the district voting on the question at 15 an election called for such purpose. An election to vote on the 16 question of making a local incentive levy of not to exceed five (5) 17 mills on the dollar valuation of the taxable property in a 18 technology center school district under the provisions of subsection 19 B of Section 9B of Article X of the Oklahoma Constitution, may be 20 called by the board of education; and elections on a levy for a 21 building fund for an area school district under the provisions of 22 Section 10_{τ} of Article X_{τ} of the Oklahoma Constitution, shall be 23 24 called by the board of education of such district and conducted by

1 the county election board in the same manner that elections for 2 similar levies are called and conducted in independent school 3 districts.

G. H. Annual estimates of needs of technology center school 4 5 districts shall be made and approved in the same manner that those of independent school districts are made and approved. Provided, 6 that the State Board of Career and Technology Education shall 7 prescribe a list of appropriation accounts by which the funds of 8 9 technology center school districts shall be budgeted, accounted for 10 and expended. Any such estimate of needs may include an estimate of federal funds as probable income from sources other than ad valorem 11 12 tax of the district and other than any excise or other tax assessed by legislative enactment and distributed in lieu of ad valorem 13 If a technology center school district lies in more than one 14 taxes. county, the district's estimate of needs shall be filed with and 15 approved by the county excise board of the county designated by the 16 school district board of education. 17

H. I. Territory may be annexed to or detached from a technology center school district, in accordance with rules prescribed by the State Board of Career and Technology Education. If the State Board of Career and Technology Education requires the submission of a petition in order for an election to be called for the purpose of annexation or deannexation of territory to a technology center school district, such petition shall not be required to bear a number of technology center school district electors' signatures which exceed fifty percent (50%) of the number of technology center school district electors who voted in the last school board election in the territory proposed to be annexed or deannexed. Provided, the period of time from which the petition is initiated to its time of filing with the State Board shall not exceed ninety (90) days.

7 I. J. Schools of technology center school districts shall be
8 subject to classification, inspection, and accreditation by the
9 State Board of Education.

10 J. K. The technology center school board of education may 11 designate a county treasurer to serve as treasurer of the school 12 district or may appoint an independent treasurer.

 K_{\cdot} L. Within four (4) years after the creation of a technology 13 center school district, such school district may, at its discretion, 14 permit a teacher to transfer any or all accrued benefits upon 15 employment including credit for years of service in the previous 16 17 school district by the technology center school district, if the teacher at the time of hiring is employed as a teacher by an 18 independent or elementary school district which is all or partly 19 within the boundaries of the technology center school district or is 20 employed as a teacher in a skills center within the boundaries of 21 the school district. 22

1 <u>L. M.</u> The board of education of a technology center school 2 district may convey surplus personal property without consideration 3 to:

4 1. A school district that is within the boundary of the5 technology center school district;

2. A public school offering secondary level education which was
7 created and is operated by the State of Oklahoma this state and that
8 is within the boundary of the technology center school district;

9 3. A technology center school district; or

The Oklahoma Department of Career and Technology Education
 for the support or delivery of department initiatives.

12 M. The board of education of a technology center school district may, without prior approval of the State Board of Career 13 and Technology Education, approve all plans and specifications for 14 technology center school buildings, additions, and major 15 modifications to school buildings that are designed to provide for 16 the offering of vocational-technical education programs and services 17 when the cost of the building project is to be paid with local 18 levies or state bond monies or both local levies and state bond 19 monies. 20
