Persons convicted of these offenses shall not be eligible for to receive and accumulate earned credits or any other type of credits which have the effect of reducing the length of the while serving the sentence to less than of imprisonment. The Department of Corrections shall apply the accumulated credits after eighty-five percent (85%) of the sentence imposed has been served. After eighty-five percent (85%) of the sentence imposed has been served, the person shall be eligible for immediate discharge if the sum of earned credits and service time equals the total sentence length. The granting of

earned credits shall be at the discretion of the Director based on

1	the criteria provided for in Section 138 of Title 57 of the Oklahoma
2	Statutes.
3	SECTION 2. This act shall become effective November 1, 2015.
