SECTION 3. The State Election Board is hereby authorized to deposit up to Two Hundred Fifty Thousand Dollars (\$250,000.00) from funds appropriated to the State Election Board in Sections 50 and 51 of Enrolled Senate Bill No. 1040 of the 2nd Session of the 58th Oklahoma Legislature into the State Question Recount Revolving Fund created by subsection F of Section 8-111 of Title 26 of the Oklahoma Statutes.

8 SECTION 4. The appropriation made by this act shall not be 9 subject to fiscal year limitations and shall be available for 10 encumbrance and expenditure purposes for a period of thirty (30) 11 months from the date this act is approved.

12 SECTION 5. The appropriations made by this act shall not be 13 subject to fiscal years 2023 and 2024 agency category and budget 14 limitations.

15 SECTION 6. It being immediately necessary for the preservation 16 of the public peace, health or safety, an emergency is hereby 17 declared to exist, by reason whereof this act shall take effect and 18 be in full force from and after its passage and approval.
