6 An Act relating to the Information Technology
7 Consolidation and Coordination Act; amending 62 O.S.
8 2011, Section 35.3, as last amended by Section 20,
9 Chapter 358, O.S.L. 2013 (62 O.S. Supp. 2020, Section
10 35.3), which relates to definitions; modifying
11 definition; providing exemption for the Oklahoma
12 Municipal Power Authority; and declaring an
13 emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 62 O.S. 2011, Section 35.3, as
16 last amended by Section 20, Chapter 358, O.S.L. 2013 (62 O.S. Supp.
17 2020, Section 35.3), is amended to read as follows:

18 Section 35.3. As used in the Information Technology
19 Consolidation and Coordination Act:

20 1. "Appropriated state agency" means any state agency that
21 receives funding through the annual legislative appropriations
22 process;

23 2. "Information technology assets" means any equipment or
24 interconnected system or subsystem of equipment that is used in the
acquisition, storage, manipulation, management, movement, control,
display, switching, interchange, transmission, or reception of data

1 or information. The term shall include computers, ancillary
2 equipment, software, firmware and similar procedures, services,
3 including support services and consulting services, software
4 development, and related resources, and shall further include
5 telecommunications fiber networks used for conveying electronic
6 communication or information systems to multiple physical locations;

7 3. "Information technology position" means a classified or
8 unclassified position in the following functional areas:

- 9 a. applications programming,
- 10 b. EDP audit,
- 11 c. data examination,
- 12 d. computer applications,
- 13 e. computer data entry,
- 14 f. computer networking,
- 15 g. computer operations,
- 16 h. computer programming,
- 17 i. computer security,
- 18 j. computer software design,
- 19 k. web applications,
- 20 l. database analysis,
- 21 m. data management analysis,
- 22 n. database development,
- 23 o. database programming,
- 24 p. software design/development,

- 1 q. help desk,
- 2 r. imaging,
- 3 s. systems analysis,
- 4 t. systems application planning,
- 5 u. systems application,
- 6 v. systems administration,
- 7 w. systems coordination,
- 8 x. systems integration,
- 9 y. systems operation,
- 10 z. systems planning/development,
- 11 aa. systems programming,
- 12 bb. systems engineering,
- 13 cc. systems service specialist,
- 14 dd. systems support,
- 15 ee. network administration,
- 16 ff. network management,
- 17 gg. network technical,
- 18 hh. operating systems specialist,
- 19 ii. systems program manager,
- 20 jj. telecommunications, whether data or voice,
- 21 kk. software training, and
- 22 ll. technology development or support;

1 4. "Nonappropriated state agency" means any state agency that
2 does not receive funding through the annual legislative
3 appropriations process;

4 5. "Shared services" means those state agency functions which
5 are or could be provided through:

6 a. the services and systems specified in subsection A of
7 Section 35.6 of this title, and

8 b. the programs, services, software or processes
9 specified in subsection B of Section 35.6 of this
10 title; and

11 6. "State agency" means any office, elected or appointed
12 officer, bureau, board, commission, counsel, unit, division, body,
13 authority or institution of the executive branch of state
14 government, ~~excluding institutions within The Oklahoma State System~~
15 of Higher Education, the Oklahoma Municipal Power Authority, the
16 Oklahoma State Regents for Higher Education and the
17 telecommunications network known as OneNet.

18 SECTION 2. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
