Strangulation as provided for in Section 644 of this title, 13 shall be required to serve not less than eighty-five percent (85%) 14 of any sentence of imprisonment imposed by the judicial system prior 15 to becoming eligible for consideration for parole. Persons 16 convicted of these offenses shall not be eliqible for earned credits 17 or any other type of credits which have the effect of reducing the 18 length of the sentence to less than eighty-five percent (85%) of the 19 sentence imposed. 20
- SECTION 2. This act shall become effective November 1, 2024.
