 park. Such funds and accounts shall be subject to the direct
 supervision, management, and control of the Department.

The Department shall not be responsible for any claims 4 D. 5 arising under The Governmental Tort Claims Act accrued prior to January 1, 2025, claims arising from any other actions accrued prior 6 to January 1, 2025, or tort claims arising prior to January 1, 2025, 7 for which no claim has accrued upon the date of transfer. 8 The 9 Department shall not be responsible for any claims arising out of construction begun before January 1, 2025, at Hugo Lake Park. 10

E. 1. The Department shall succeed to any contractual rights and responsibilities of the previous operators of Hugo Lake Park, including but not limited to:

a. any responsibilities for payment of rents or other
obligations, and

b. any responsibilities related to contractual agreements
with nonprofit organizations.

2. The Department may enter into one or more contracts for management services of the state park. The duties and benefits arising under any contract for management services of any part of the previous operators that is in effect on January 1, 2025, shall be assigned to the Department. The contract may be renewable at the option of the Department but not to exceed a cumulative period of fifty (50) years.
