All monies 6 accruing to the credit of the fund are hereby appropriated and may 7 be budgeted and expended by the Department for the purpose provided 9 for in this section. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as 10 prescribed by law with the Director of the Office of Management and 11 12 Enterprise Services for approval and payment.

B. Pursuant to the requirements of Section 1-3-101 of Title 27A of the Oklahoma Statutes as it relates to waters emanating from a sensitive sole source aquifer, the Department shall establish and perform a Blue River-Little Blue Creek Stream Health Assessment Study. The Department shall coordinate with the Center for Reservoir and Aquatic Systems Research at Baylor University for the purpose of defining the study scope and conducting the work necessary to complete data collection and the development of the Blue River-Little Blue Creek Stream Health Assessment Study. The Department may coordinate with other relevant state and federal agencies to effectuate the provisions of this section.
