14	SECTION 1. AMENDATORY 63 O.S. 2011, Section 1-301, as

16	Section 1-301), is amended to read as follows:
17	Section 1-301. As used in this article:
18	1. "Vital statistics" means records of birth, death, fetal
19	death and data related thereto;
20	2. "System of vital statistics" means the registration,
21	collection, preservation, amendment and certification of vital
22	statistics records, and activities related thereto, including the
23	tabulation, analysis and publication of statistical data derived
24	from such records;

3. "Filing" means the presentation of a certificate, report or
 other record provided for in this article, of a birth, death, fetal
 death or adoption, for registration by the State Commissioner of
 Health;

4. "Registration" means the acceptance by the State
Commissioner of Health and the incorporation in his official records
of certificates, reports or other records provided for in this
article, of births, deaths, fetal deaths or adoptions;

9 5. "Live birth" means the complete expulsion or extraction from 10 the mother of a product of human conception, irrespective of the 11 duration of pregnancy, which, after such expulsion or extraction, 12 breathes or shows any other evidence of life such as beating of the 13 heart, pulsation of the umbilical cord or definite movement of 14 voluntary muscles, whether or not the umbilical cord has been cut or 15 the placenta is attached;

16 6. "Stillbirth" or "stillborn child" means a fetal death;
17 7. "Certificate of birth resulting in stillbirth" means a
18 certificate issued to memorialize a stillborn child;

8. "Fetal death" means death prior to the complete expulsion or
 extraction from its mother of a product of human conception after
 the fetus has advanced to or beyond the twelfth week of
 uterogestation. The death is indicated by the fact that, after such
 expulsion or extraction, the fetus does not breathe or show any

1 other evidence of life such as beating of the heart, pulsation of 2 the umbilical cord or definite movement of voluntary muscles;

9. "Dead body" means an individual who is determined to be dead pursuant to the provisions of the Uniform Determination of Death Act;

6 10. "Final disposition" means the burial, interment, cremation,7 or other disposition of a dead body or fetus;

8 11. "Physician" means a person who is a member of the class of 9 persons authorized to use the term "physician" pursuant to Section 10 725.2 of Title 59 of the Oklahoma Statutes;

11 12. "Institution" means any establishment, public or private, 12 which provides inpatient medical, surgical or diagnostic care or 13 treatment, or nursing, custodial or domiciliary care, to two or more 14 unrelated individuals, or to which persons are committed by law; and

15 13. "Disinterment" means the recovery of human remains by 16 exhumation or disentombment. "Disinterment" does not include the 17 raising and lowering of remains to accommodate two interments within 18 a single grave and does not include the repositioning of an outside 19 burial container that encroaches on adjoining burial space; and

20 <u>14. "Court order" means an order issued by a state or federal</u> 21 <u>court of competent jurisdiction or by a tribal court of a federally</u> 22 <u>recognized tribe</u>.

23 SECTION 2. This act shall become effective November 1, 2020.
