13	SECTION 1. AMENDATORY 21 O.S. 2021, Section 1171, is
14	amended to read as follows:
15	Section 1171. A. Every person who hides, waits or otherwise
16	loiters in the vicinity of any private dwelling house, apartment
17	building, any other place of residence, or in the vicinity of any
18	locker room, dressing room, restroom or any other place where a
19	person has a right to a reasonable expectation of privacy, with the
20	unlawful and willful intent to watch, gaze, or look upon any person
21	in a clandestine manner, shall, upon conviction, be guilty of a
22	misdemeanor. The violator shall be punished by imprisonment in the
23	county jail for a term $\frac{\partial f}{\partial t}$ not more than one (1) year, or by a fine
24	not to exceed Five Thousand Dollars (\$5,000.00), or by both such

1 fine and imprisonment. <u>Upon a second or subsequent conviction</u>, the
2 <u>violator shall be required to register as a sex offender under the</u>
3 Sex Offenders Registration Act.

Every person who uses photographic, electronic or video 4 в. 5 equipment in a clandestine manner for any illegal, illegitimate, prurient, lewd or lascivious purpose with the unlawful and willful 6 intent to view, watch, gaze or look upon any person without the 7 knowledge and consent of such person when the person viewed is in a 8 9 place where there is a right to a reasonable expectation of privacy, or who publishes or distributes any image obtained from such act, 10 shall, upon conviction, be guilty of a felony. The violator shall 11 be punished by imprisonment in the custody of the Department of 12 13 Corrections for a term of not more than five (5) years, or by a fine not exceeding Five Thousand Dollars (\$5,000.00), or by both such 14 fine and imprisonment, and the violator shall be required to 15 register as a sex offender under the Sex Offenders Registration Act. 16 C. Every person who uses photographic, electronic or video 17 equipment in a clandestine manner for any illegal, illegitimate, 18 prurient, lewd or lascivious purpose with the unlawful and willful 19 intent to view, watch, gaze or look upon any person and capture an 20 image of a private area of a person without the knowledge and 21 consent of such person and knowingly does so under circumstances in 22 which a reasonable person would believe that the private area of the 23
