10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless
13 there is created a duplication in numbering, reads as follows:

14 A. Beginning with the 2017-2018 school year, a school district
15 board of education shall not enter into a new contract or renew a
16 contract with a superintendent after the effective day of this act
17 that is less than the minimum compensation or exceeds the maximum
18 compensation amounts provided for in the following schedule:

19 1. Twenty Thousand Dollars (\$20,000.00) to Sixty-Five Thousand
20 Dollars (\$65,000.00) for the superintendent of a district or
21 districts with an average daily membership (ADM) of under 100;

22 2. A maximum of Eighty-Five Thousand Dollars (\$85,000.00) for
23 the superintendent of a district or districts with an ADM of one
24 hundred fifty (150) or less but more than one hundred (100);

1 3. A maximum of Ninety-five Thousand Dollars (\$95,000.00) for
2 the superintendent of a district or districts with an ADM of two
3 hundred (200) or less but more than one hundred fifty-one (150);

4 4. A maximum of One Hundred Thousand Dollars (\$100,000.00) for
5 the superintendent of a district or districts with an ADM of two
6 hundred-fifty (250) or less but more than two hundred (200);

7 5. A maximum of One Hundred Ten Thousand Dollars (\$110,000.00)
8 for the superintendent of a district or districts with an ADM of
9 seven hundred fifty (750) or less but more than two hundred fifty
10 (250);

11 6. A maximum of One Hundred Twenty Thousand Dollars
12 (\$120,000.00) for the superintendent of a district or districts with
13 an ADM of one thousand five hundred (1,500) or less but more than
14 seven hundred fifty (750);

15 7. A maximum of One Hundred Thirty Thousand Dollars
16 (\$130,000.00) for the superintendent of a district or districts with
17 an ADM of three thousand (3,000) or less but more than one thousand
18 five hundred (1,500);

19 8. A maximum of One Hundred Forty Thousand Dollars
20 (\$140,000.00) for the superintendent of a district or districts with
21 an ADM of six thousand five hundred (6,500) or less but more than
22 three thousand (3,000); and

1 9. A maximum of One Hundred Fifty Thousand Dollars
2 (\$150,000.00) for the superintendent of a district or districts with
3 an ADM of more than six thousand five hundred (6,500).

4 B. A school district board of education may enter into a new
5 contract or renew a contract with a superintendent that exceeds the
6 maximum compensation amounts provided for in subsection A of this
7 section provided that no state appropriated funds are used for any
8 amount above the maximum amount allowed.

9 C. The State Board of Education, upon written application by
10 the school district board of education, may approve a waiver of the
11 maximum compensation amounts for any district or districts with an
12 ADM of ten thousand (10,000) or more.

13 D. For the purposes of this section, "compensation" shall mean
14 any base salary an individual receives as a superintendent, teacher,
15 counselor, principal or any other capacity and fringe benefits.

16 E. The State Board of Education shall promulgate rules
17 necessary to implement the provisions of this act.

18 ~~SECTION 2. This act shall become effective July 1, 2017.~~

19 ~~SECTION 3. It being immediately necessary for the preservation~~
20 ~~of the public peace, health or safety, an emergency is hereby~~
21 ~~declared to exist, by reason whereof this act shall take effect and~~
22 ~~be in full force from and after its passage and approval.~~
