6 AS INTRODUCED

7 An Act relating to county elections; amending 26 O.S.
8 2011, Section 12-111, as amended by Section 6,
9 Chapter 3, O.S.L. 2012 (26 O.S. Supp. 2014, Section
10 12-111) and 51 O.S. 2011, Section 10, which relate to
11 vacancies in elective offices; requiring special
12 election to fill vacancy in any elective county
13 office; deleting procedure for filling certain
14 vacancies by appointment; and providing an effective
15 date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 26 O.S. 2011, Section 12-111, as
18 amended by Section 6, Chapter 3, O.S.L. 2012 (26 O.S. Supp. 2014,
19 Section 12-111), is amended to read as follows:

20 Section 12-111. ~~A.~~ Whenever a vacancy shall occur in ~~the~~
21 ~~office of a county commissioner~~ any elective county office, the
22 vacancy shall be filled at a special election to be called by the
23 Governor within thirty (30) days after the vacancy occurs.

24 Provided, no special election shall be called if the vacancy occurs
in an even-numbered year if the term of the office expires the
following year. In such case, the candidate elected to the office

1 at the Primary Election, runoff Primary Election, or the regular
2 General Election shall be appointed by the Governor as soon as
3 practical after the applicable election to fill the unexpired term.

4 ~~B. Whenever a vacancy shall occur in any elective county office
5 of any county in this state having a population of more than the
6 population figure specified in subsection B of Section 10 of Title
7 51 of the Oklahoma Statutes, the vacancy shall be filled at a
8 special election to be called by the Governor within thirty (30)
9 days after the vacancy occurs. Provided, no special election shall
10 be called if the vacancy occurs in an even-numbered year if the term
11 of the office expires the following year. In such case, the
12 candidate elected to the office at the Primary Election, runoff
13 Primary Election, or the regular General Election shall be appointed
14 by the Governor as soon as practical after the applicable election
15 to fill the unexpired term.~~

16 SECTION 2. AMENDATORY 51 O.S. 2011, Section 10, is
17 amended to read as follows:

18 Section 10. A. All vacancies in state offices, except in
19 offices of the members of the Legislature, members of the House of
20 Representatives from Oklahoma in the Congress of the United States
21 of America and members of the Senate of the United States of
22 America, shall be filled by appointment by the Governor. When a
23 vacancy occurs in the office of district judge, associate district
24 judge, or judge of any intermediate appellate court, the Governor

1 shall, in filling such vacancy, utilize the services of the Judicial
2 Nominating Commission in the manner as provided for in the filling
3 of judicial offices under Section 4, Article 7B of the Oklahoma
4 Constitution.

5 B. All vacancies in county offices ~~except the board of county~~
6 ~~commissioners or except for any elective county office of any county~~
7 ~~in the State of Oklahoma having a population of more than six~~
8 ~~hundred thousand (600,000), according to the latest Federal~~
9 ~~Decennial Census shall be filled by appointment by the board of~~
10 ~~county commissioners. If such an appointment is made prior to the~~
11 ~~prescribed filing period for county officers in accordance with the~~
12 ~~provisions of Section 131 of Title 19 of the Oklahoma Statutes, the~~
13 ~~county commissioners shall, at the time said appointment is made,~~
14 ~~proclaim a special election to fill the balance of the unexpired~~
15 ~~term, providing the balance of the term does not expire in the year~~
16 ~~following the next succeeding general election. In making the~~
17 ~~proclamation, the county commissioners shall establish the dates for~~
18 ~~the filing period, primary election, runoff primary election and~~
19 ~~general election to be the same as the next succeeding filing~~
20 ~~period, primary election, runoff primary election and general~~
21 ~~election for county officers. The appointee shall be eligible to~~
22 ~~become a candidate at said special election, providing said~~
23 ~~appointee is otherwise qualified. The office to be filled shall be~~

1 ~~printed on the same ballot as other county offices shall be filled~~
2 as provided in Section 12-111 of Title 26 of the Oklahoma Statutes.

3 SECTION 3. This act shall become effective January 1, 2016.
