7	An Act relating to child care; providing nutrition
8	standards; specifying certain activities; eliminating screen time; providing exemptions and certain

12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. NEW LAW A new section of law to be codified
14	in the Oklahoma Statutes as Section 405.6 of Title 10, unless there
15	is created a duplication in numbering, reads as follows:
16	All licensed child care centers, except those facilities
17	licensed as drop-in programs or as programs for sick children shall:
18	1. Follow the most recent version of the Child and Adult Care
19	Food Program (CACFP) nutrition standards for infants;
20	2. Follow the Healthy Eating Research 2013 Recommendations for
21	Healthier Beverages, and limit sugar-sweetened beverages to one
22	serving per day;
23	3. Provide children with opportunities for moderate and
24 27	vigorous physical activity for at least sixty (60) cumulative

1 minutes per day during a full-day program, and for thirty (30) 2 cumulative minutes for programs that operate less than a full day, 3 including daily outdoor physical activity when possible, and by 4 providing infants daily opportunities to freely explore their indoor 5 and outdoor environments under adult supervision, including engaging 6 with infants on the ground each day to optimize adult-infant 7 interactions and providing daily time in the prone position for 8 infants less than twelve (12) months of age; and

9 4. Eliminate screen time, including television, movies,
10 cellular phones, video games, computers and other digital devices
11 for children less than two (2) years of age. The provisions of this
12 paragraph shall not apply to:

- a. electronic media involving facilitated physical
   activity participation,
- b. e-readers when used for reading to the children, c. smart boards and tablets when used for facilitated hands-on learning activities, such as drawing or puzzles,
- 19d. occasional special activities, such as watching a20movie, limited to one per month, except in the21following situations:

## (1) Saturday mornings may include an additional thirty (30) minutes for children in mixed groups, and

2	child in mixed groups in evening or overnight
3	care, and
4	e. assistive or adaptive technology for children with
