11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:		
12	SECTION 1. AMENDATORY 70 O.S. 2011, Section 6-204.2, as		
13	last amended by Section 2, Chapter 394, O.S.L. 2013 (70 O.S. Supp.		
14	2017, Section 6-204.2), is amended to read as follows:		
15	Section 6-204.2. A. The Oklahoma Commission for Teacher		
16	Preparation Educational Quality and Accountability and the State		
17	Board of Education are authorized to establish the Education		
18	Leadership Oklahoma program.		
19	B. The purposes of the Education Leadership Oklahoma program		
20	are to:		
21	1. Provide teachers throughout the state information about		
22	National Board certification and the Education Leadership Oklahoma		
23	program services;		
24			

2. Provide technical assistance and National-Board-certified mentors to all teachers seeking National Board certification upon request;

- 3. Reward teachers who are seeking National Board certification by awarding them a portion of the application processing charge and assessment fee and scholarship as provided in subsection D of this section; and
 - 4. Provide recognition to National-Board-certified teachers.
- C. To fulfill the objectives of the Education Leadership
 Oklahoma Act, the Oklahoma Commission for Teacher Preparation shall:
- 1. Inform teachers of the Education Leadership Oklahoma program and services it provides to teachers seeking National Board certification, emphasizing recruiting efforts toward teachers at high-poverty schools, schools identified as in need of improvement and in counties with the lowest percentage of teachers who have achieved National Board certification; and
- 2. Ensure that all teachers seeking National Board certification receive adequate information regarding the level of commitment required to acquire National Board certification.
- D. The 1. Until June 30, 2020, the Commission shall select not more than one hundred applicants to participate in the program each fiscal year for whom the Commission shall pay one-half (1/2) of the application processing charge and assessment fee for National Board certification. The total amount paid by the Commission shall not

- 1 exceed One Thousand Three Hundred Dollars (\$1,300.00). In addition
- 2 | the Commission shall also provide to the selected applicants a
- 3 | scholarship in the amount of Five Hundred Dollars (\$500.00) to cover
- 4 other expenses associated with obtaining National Board
- 5 | certification.
- 6 2. Beginning July 1, 2020, the Commission shall select
- 7 applicants to participate in the program each fiscal year for whom
- 8 | the Commission shall provide an up-front payment of one-half (1/2)
- 9 of the application processing charge and assessment fee for National
- 10 | Board certification, not to exceed Nine Hundred Fifty Dollars
- 11 (\$950.00).
- 12 E. 1. The Commission shall promulgate rules establishing a
- 13 process for accepting applications for the Education Leadership
- 14 Oklahoma program and for providing to applicants selected for the
- 15 program up-front payment of the application processing charge and
- 16 assessment fee and scholarship. If a selected applicant who
- 17 | receives the up-front payment does not complete National Board
- 18 | certification within three (3) years, the applicant shall repay the
- 19 | Commission the full amount paid by the Commission pursuant to
- 20 | subsection D of this section. All selected applicants who do not
- 21 | receive an up-front payment and successfully complete National Board
- 22 | certification shall be reimbursed by the Commission for the
- 23 application processing charge and assessment fee. The total amount
- 24 | of reimbursement paid by the Commission shall not exceed One

- Thousand Three Hundred Dollars (\$1,300.00). The provisions of this
 paragraph shall apply to applicants who seek National Board
 certification prior to July 1, 2020.
- 4 2. Beginning July 1, 2020, the Commission shall promulgate 5 rules establishing a process for accepting applications for the 6 Education Leadership Oklahoma program and for providing to 7 applicants the up-front payment of the application processing charge and assessment fee. If a selected applicant who receives the up-8 9 front payment does not complete National Board certification within 10 three (3) years, the applicant shall repay the Commission the full 11 amount paid by the Commission pursuant to subsection D of this 12 section and shall not be eligible to receive any future up-front payment of the application processing charge and assessment fee. 13 Upon successful completion of National Board certification, the 14 15 applicant shall be eligible to receive an up-front payment of one-16 half (1/2) of the application processing charge and assessment fee for National Board certification renewal, not to exceed Nine Hundred 17 Fifty Dollars (\$950.00). 18
- F. It is the intent of the Legislature that the Oklahoma
 Commission for Teacher Preparation contract with Southeastern
 Oklahoma State University to establish Education Leadership Oklahoma
 program training in higher education teacher preparation programs in
 the state to assist teachers in meeting the requirements to obtain
 National Board certification.

G. All teachers seeking National Board certification shall be eligible to participate in Education Leadership Oklahoma program training to assist them in meeting the requirements of the National Board certification process, free of charge.

- H. Subject to district board of education policy or collective bargaining agreement, additional professional leave days may be granted to teachers seeking National Board certification for National Board certification portfolio development. During the two (2) days of the additional professional days granted to teachers for National Board certification portfolio development, a substitute teacher shall be provided by the school district at no cost to the teacher.
- I. 1. The State Board of Education shall provide to teachers who attained National Board certification prior to June 30, 2013, a bonus in the amount of Five Thousand Dollars (\$5,000.00) annually over a ten-year period, to be paid no later than January 31 each year. The Board shall provide a bonus to any teacher who attains National Board certification after June 30, 2013, if the teacher was selected for the Education Leadership Oklahoma program before June 30, 2013, or the teacher has submitted an application for National Board certification to the National Board for Professional Teaching Standards before June 30, 2013.
- 2. The teachers eligible to receive the annual bonus as provided for in paragraph 1 of this subsection shall receive the

- annual bonus for the ten-year duration of their National Board

 certification and so long as they are teaching in the classroom

 full-time in an Oklahoma public school. No school or school
- 4 district shall be liable for payment of bonuses pursuant to this 5 section.
 - 3. The bonus shall not be included in the calculation of the teacher's salary for purposes of meeting the district or statutory minimum salary schedule or for purposes of compensating Oklahoma Teachers' Retirement System contributions or benefits.
 - 4. Teachers eligible to receive the annual bonus as provided for in paragraph 1 of this subsection shall not be eligible to receive the additional salary increment for National Board certification as set forth in the minimum salary schedule in Section 3 of this act 18-114.14 of this title.
 - 5. Teachers who attain National Board certification after June 30, 2013, <u>but before July 1, 2020</u>, shall be eligible to receive the additional salary increments for National Board certification as set forth in the minimum salary schedule in Section 3 of this act 18-114.14 of this title.
- 20 6. Teachers who attain or renew National Board certification on
 21 or after July 1, 2020, shall be eligible to receive the additional
 22 salary increments for National Board certification as set forth in
 23 the minimum salary schedule in Section 2 of this act.

1	7. The State Board of Education shall promulgate rules for a
2	process by which a National-Board-certified teacher will verify
3	that:
4	a. the National Board certification has not lapsed,
5	b. the teacher is still a full-time teacher, and
6	c. for teachers eligible for the bonus, the teacher has
7	not exceeded the limit of annual bonus payments as
8	provided for in paragraph 1 of this subsection.
9	J. It is the intent of the Legislature that the Oklahoma State
10	Regents for Higher Education incorporate the National Board
11	certification portfolio development into all programs in education
12	leading to a master's level degree.
13	SECTION 2. NEW LAW A new section of law to be codified
14	in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless
15	there is created a duplication in numbering, reads as follows:
16	A. Beginning with the 2020-2021 school year, teachers in the
17	public schools of Oklahoma shall receive in salary and/or fringe
18	benefits not less than the amounts specified in the following
19	schedule:

- B. 1. When determining the Minimum Salary Schedule, "fringe benefits" shall mean all or part of retirement benefits, excluding the contributions made pursuant to subsection A of Section 17-108.1 of Title 70 of the Oklahoma Statutes and the flexible benefit allowance pursuant to Section 26-105 of Title 70 of the Oklahoma Statutes from the flexible benefit allowance funds disbursed by the State Board of Education and the State Board of Career and Technology Education pursuant to Section 26-104 of Title 70 of the Oklahoma Statutes.
 - 2. If a school district intends to provide retirement benefits to a teacher such that the teacher's salary would be less than the amounts set forth in the Minimum Salary Schedule specified in subsection A of this section, the district shall be required to provide written notification to the teacher prior to his or her employment, or if already employed by the district, no later than thirty (30) days prior to the date the district elects to provide retirement benefits such that the teacher's salary would be less than the Minimum Salary Schedule.
 - C. Any of the degrees referred to in this section shall be from a college recognized by the State Board of Education. The Board shall accept teaching experience from out-of-state school districts

that are accredited by the state board of education or appropriate state accrediting agency for the districts. The Board shall accept teaching experience from out-of-country schools that are accredited or otherwise endorsed by the appropriate national or regional accrediting or endorsement authority. Out-of-country certification documentation in a language other than English shall be analyzed by an educational credential evaluation service in accordance with industry standards and guidelines and approved by the State

Department of Education. The person seeking to have credit granted for out-of-country teaching experience shall be responsible for all costs of the analysis by a credential evaluation service. The Board shall accept teaching experience from primary and secondary schools that are operated by the United States Department of Defense or are affiliated with the United States Department of State.

- D. For the purpose of state salary increments and retirement, no teacher shall be granted credit for more than five (5) years of active duty in the military service or out-of-state or out-of-country teaching experience as a certified teacher or its equivalent. Nothing in this section shall prohibit boards of education from crediting more years of experience on district salary schedules than those allowed for state purposes.
- E. The State Board of Education shall recognize, for purposes of certification and salary increments, all the years of experience of a:

- 1. Certified teacher who teaches in the educational program of the Department of Corrections, beginning with fiscal year 1981;
- 2. Vocational rehabilitation counselor under the Department of Human Services if the counselor was employed as a certified teacher by the State Department of Education when the Division of Vocational Rehabilitation was transferred from the State Board of Career and Technology Education or the State Board of Education to the Oklahoma Public Welfare Commission on July 1, 1968;
- 3. Vocational rehabilitation counselor which were completed while employed by the Department of Human Services if such counselor was certified as a teacher or was eligible for certification as a teacher in Oklahoma;
- 4. Certified teacher which were completed while employed by the Department of Human Services Child Study Center at OU Medicine, if the teacher was certified as a teacher in Oklahoma; and
- 5. Certified school psychologist or psychometrist which were completed while employed as a doctoral intern, psychological assistant or psychologist with any agency of the State of Oklahoma if the experience primarily involved work with persons of school- or preschool-age and if the person was, at the time the experience was acquired, certified as, or eligible for certification as, a school psychologist or psychometrist.

1	F. The provisions of this section shall not apply to teachers
2	who have entered into postretirement employment with a public school
3	in Oklahoma and are still receiving a monthly retirement benefit.
4	SECTION 3. This act shall become effective July 1, 2020.
