21	permanent markers bearing that name to be placed on the highway.

24 27	there is created a duplication in numbering, reads as follows:

The bridge over Coal Creek located on US Route 75 Business within the municipal limits of Henryetta shall be designated as the "Edward A. DeVore, Jr., Congressional Medal of Honor Recipient, Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.

SECTION 3. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 1698.310 of Title 69, unless
there is created a duplication in numbering, reads as follows:

The portion of State Highway 56 beginning just west of North Wood Drive and extending approximately one (1) mile west through the municipal limits of Okmulgee shall be designated as the "CPL Russell Keck, Navy Cross Recipient, Memorial Highway". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the highway.
