7	An Act relating to state property; amending Section
8	2, Chapter 209, O.S.L. 2013, as amended by Section 1, Chapter 286, O.S.L. 2014 (74 O.S. Supp. 2014, Section
9	61.8), which relates to property owned and leased by the state; exempting the Oklahoma School for the Blind and the Oklahoma School for the Deaf from
10	certain requirements; providing an effective date; and declaring an emergency.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY Section 2, Chapter 209, O.S.L.
15	2013, as amended by Section 1, Chapter 286, O.S.L. 2014 (74 O.S.
16	Supp. 2014, Section 61.8), is amended to read as follows:
17	Section 61.8. A. The Long-Range Capital Planning Commission
18	shall work to decrease the amount of property owned by Oklahoma
19	state government, return state-owned property to private sector
20	ownership, better maintain and utilize the state's needed capital
21	assets and, whenever possible, eliminate the practice of state
22	agencies leasing real property not owned by the state.
23	B. Each year, the Director of the Office of Management and
24	Enterprise Services at the direction of the Long-Range Capital

Planning Commission, shall take action to approve the privatization of state-owned real property as identified pursuant to the Oklahoma State Government Asset Reduction and Cost Savings Program. Proceeds from the liquidation of real properties shall be deposited into the Maintenance of State Buildings Revolving Fund.

- C. Prior to entering into or renewing a lease for real property, each state agency, board, commission, and public trust having the State of Oklahoma as a beneficiary shall receive approval for entering into the lease from the Office of Management and Enterprise Services.
- D. Prior to making a purchase of real property or constructing a building, each state agency, board, commission, and public trust having the State of Oklahoma as a beneficiary shall receive approval for the purchase or construction from the Director of the Office of Management and Enterprise Services; provided, if such purchase or construction is deemed by the Director of the Office of Management and Enterprise Services to be within the authority of the Long-Range Capital Planning Commission, the Director shall not approve the purchase or construction and shall refer the request to the Commission for action.
- E. Prior to approval or referral pursuant to subsection C or D of this section, the Office of Management and Enterprise Services shall determine if the applicant entity can utilize already existing

state-owned real property as an alternative to leasing non-stateowned real property or purchasing or constructing new real property.

- F. No state agency, board, commission or public trust having the state as its beneficiary shall transfer any real property owned by the agency, board, commission or trust to any other state agency, board, commission, state beneficiary trust or any public or private entity unless the transfer is first approved by the Long-Range Capital Planning Commission. Any transfer made without the prior approval of the Long-Range Capital Planning Commission as required by this subsection may be reversed by the Long-Range Capital Planning Commission and if a transfer is reversed the agency, board, commission, state beneficiary trust or other state government entity to which the real property has been impermissibly transferred shall take such actions to convey the subject property to the entity from which the asset was acquired not later than thirty (30) days from the date an order for such transfer is entered by the Long-Range Capital Planning Commission. The Commission shall not approve any transfer unless proceeds from the sale shall be deposited within the Maintenance of State Buildings Revolving Fund as established by Section 908 of Title 62 of the Oklahoma Statutes.
- G. By February 1 of each year, the Office of Management and Enterprise Services shall publish a report for the preceding calendar year listing the parcels of previously state-owned property sold, detailing the reduction in the amount of space leased by the

- 2 | Maintenance of State Buildings Revolving Fund and showing the manner
- 3 | in which deferred maintenance needs are being met. The report shall
- 4 be provided to the Governor, Speaker of the House of

- 7 H. This section shall not be applicable to the following or
- 8 | their lands, properties, buildings, funds or revenue:
 - 1. The Oklahoma Ordnance Works Authority;
 - 2. The Commissioners of the Land Office;
 - 3. The Oklahoma Department of Transportation; and
 - 4. The Oklahoma Turnpike Authority; and
- 5. The Oklahoma School for the Blind and the Oklahoma School

- 15 I. The Director of the Office of Management and Enterprise
- 16 | Services may make recommendations to the Long-Range Capital Planning
- 17 | Commission for liquidation of underutilized properties that have
- 18 | environmental issues, create a liability for the state, or create
- 19 expenses that make the continued ownership of the underutilized
- 20 property undesirable and the property has been offered through two
- 21 public auctions or sealed bids and no viable bids were received. If
- 22 | the Long-Range Capital Planning Commission approves the liquidation
- 23 of the property, the Office of Management and Enterprise Services
- 24 may accept a bid of less than ninety percent (90%) of the appraised
